

In this case, the Court finds reversal and remand necessary, as the Commissioner concedes that reconsideration and further development of the record are in order. Furthermore, Plaintiff does not oppose the Motion. Accordingly, it is:

ORDERED that the Commissioner's Unopposed Motion for Entry of Judgment Under Sentence Four of 42 U.S.C. § 405(g) with Reversal and Remand to Defendant (Doc. 21) is GRANTED. It is further:

ORDERED AND ADJUDGED that the decision of the Commissioner is REVERSED and that this case is REMANDED to the Commissioner for further proceedings. Finally, it is:

ORDERED that, in accordance with *Bergen v. Comm'r of Soc. Sec.*, 454 F.3d 1273, 1278 n.2 (11th Cir. 2006), the plaintiff shall have **90** days after she receives notice of any amount of past due benefits awarded to seek attorney's fees under 42 U.S.C. § 406(b). *See Blich v. Astrue*, 261 F. App'x 241, 241 n.1 (11th Cir. 2008).
