

## SETTLEMENT AGREEMENT AND GENERAL RELEASE

The Plaintiffs listed in "Exhibit A" ("Plaintiffs") by and through their counsel, **HONDA MANUFACTURING OF ALABAMA, LLC**, and its every agent, employee, affiliate, parent, successor, subsidiary, and assign ("HMA"), and **ELWOOD STAFFING SERVICES, INC.**, and its every agent, employee, affiliate, parent, successor, subsidiary, and assign ("Elwood") (collectively "Defendants"), by and through their respective counsel, make this Settlement Agreement and General Release ("Agreement"):

1. Plaintiffs and Defendants acknowledge and agree that (1) the individual claims in these cases have been highly disputed and Defendants have taken the position that none of the individual plaintiffs have worked unpaid overtime, and (2) each of the provisions in this Agreement and in the individual releases is supported by valid consideration, is the product of back-and-forth negotiations in mediation before United States Magistrate Judge Michael Putnam, and is factored into the ultimate settlement amount which has been apportioned between Plaintiffs.

2. The parties have reached a global settlement, proposed to the Court for approval, of all the claims of the Plaintiffs in their individual cases, under which, if approved, Plaintiffs will be bound to:

a. Withdraw and dismiss with prejudice each of the cases against Defendants (or either of them) listed in "Exhibit A" to this Agreement, each party to bear that party's own costs, attorney's fees and expenses with the exception of the fees and expenses by Defendants outlined in Paragraph 5 below;

b. Waive and release every known or unknown claim, action, lawsuit or cause of action, asserted or unasserted, that Plaintiffs may have against Defendants relating in any respect to any part of the Fair Labor Standards Act (FLSA), as amended, 29 U.S.C. §§201 *et seq.*, or other claims for unpaid wages under federal or state law (excluding any claims accruing in the future (as defined for each Plaintiff in each separate release), and claims for the enforcement of this Agreement);

c. Be responsible for the taxes and claims of any agency, attorney, spouse, former spouse, creditor or other third party to the payments made by Defendants to Plaintiffs and counsel for Plaintiffs under this Agreement; and

d. Understand that this Agreement is not Defendants' admission of liability and acknowledge and agree that Defendants continue to have the legal right to assert that they did nothing unlawful, or wrong in their dealings with Plaintiffs.

3. Plaintiffs' Counsel will withdraw the appeal in the case styled *Thsia Briggins, et al. v. Elwood TRI, Inc., et al.* Case No. 12-14833, in the United States Court of Appeal for the Eleventh Circuit.

4. Plaintiffs' counsel will return all documents and copies whether provided electronically, on disk, or in hard copy to the providing Defendant within 60 days of execution of

this Agreement, and continue to comply with all applicable protective order provisions (provided the receiving Defendant shall maintain copies for at least six years).

5. Defendants agree to pay to Plaintiffs and their counsel the gross amount of One Million Six Hundred Thousand Dollars (\$1,600,000.00), apportioned as follows:

a. Four Hundred Thousand Dollars (\$400,000) in backpay to Plaintiffs, the gross amounts divided between the individual plaintiffs as listed in "Exhibit B," from which taxes and other legally required deductions will be withheld,

- (1) \$49,999.97 to be shared among the 201 Plaintiffs originating from the *Briggins* matter based on months of employment and \$21,783.00 in enhancements:
  - (i) The minimum gross backpay payment a Plaintiff will receive is \$200;
  - (ii) The named Plaintiffs in the originally filed *Briggins* action will receive a \$750 enhancement;
  - (iii) Plaintiffs who sat for depositions will receive a \$85 enhancement;
  - (iv) Plaintiffs who provided executed written responses to Defendant's discovery requests will receive a \$30 enhancement,

and,

- (2) \$321,768.02 to be shared among the 385 Plaintiffs originating from the *Burroughs* matter based on months of employment and \$6,449.01 in enhancements:
  - (i) The minimum gross backpay payment a Plaintiff will receive is \$200;
  - (ii) The named Plaintiffs in the originally filed *Burroughs* action will receive a \$750 enhancement;
  - (iii) Plaintiffs who sat for depositions will receive a \$150 enhancement;
  - (iv) Plaintiffs who provided executed written responses to Defendant's discovery requests will receive a \$50 enhancement,

b. One Million Two Hundred Thousand Dollars (\$1,200,000), including \$247,920.94 in direct costs, in what the parties agree are reasonable attorneys' fees, costs, and expenses, for which a 1099 will be issued, which shall cover in a single sum all attorneys' fees, expenses and costs due for all work done on behalf of Plaintiffs in any of the cases against either of the Defendants; and

c. Zero ("0") of this amount shall represent liquidated damages.

6. The parties acknowledge and agree that this Agreement is subject to approval by the Court in each of the individual cases. The parties acknowledge and agree that this agreement will be submitted to Magistrate Judge Michael Putnam, who will issue a Report and Recommendation regarding the fairness of the settlement to the Court, applicable in each case. Payment under this Agreement of the individual cases for a pro rata portion of the backpay is due within thirty (30) days of the Court's approval of the Settlement Agreement and dismissal with prejudice in each of the individual cases. Payment under this Agreement of attorneys' fees, costs, expenses will be due within thirty (30) days after Court approval of the Settlement Agreement in all of the individual cases.

7. Pursuant to this Agreement, a reasonable time not to exceed thirty (30) days after court approval of the settlement in each of the individual cases, dismissal of the individual cases with prejudice, and withdrawal and dismissal of the pending appeal, each individual Plaintiff will be issued a General Release of Claims like the Release attached as "Exhibit C," Plaintiffs will accept the Release of Claims by redeeming the check for backpay which accompanies the release, including a statement that "In acceptance of the terms of the attached release and in full settlement of the claims of all claims in *Plaintiff v. Honda Manufacturing of Alabama, LLC, et al.*, Case No. \_\_\_\_\_, in the United States District Court for the Northern District of Alabama and any unasserted claims to date against Honda Manufacturing of Alabama, LLC, or Elwood Staffing Services, Inc."

8. The parties agree that if a check made to an individual plaintiff is not redeemed within 90 days of delivery of the checks to counsel for plaintiffs, Defendants will cancel payment of the check and the monies due the individual plaintiff under paragraph 5 will return to Defendants provided Defendant does not move to enforce the settlement. If Defendant moves to enforce a settlement, Defendants must tender the settlement proceeds to the individual Plaintiff in the event the settlement is successfully enforced. If within a year after the defendants provided the checks to counsel for plaintiffs, a Plaintiff who has not yet been paid requests payment, Defendants will issue Plaintiff another settlement check which must be redeemed within ninety days of it being sent to him or her; otherwise payment on the check will be cancelled. Interest will not accrue on the settlement amount after initial delivery of checks to counsel for plaintiffs, and the Defendants obligation to provide another settlement check will cease after one year from initial delivery of the checks to counsel for plaintiffs.

9. The parties agree not to disclose the amount of this Agreement or the terms of this Agreement, except that parties may disclose this information to their attorneys, accountants, or other professional advisors, to whom they must make the disclosure in order for them to render professional services, and plaintiffs may disclose to their immediate family members, as long as they instruct them to maintain the confidentiality of this information just as they must, understanding that any breach of this paragraph will constitute a material breach of this Agreement resulting in irreparable harm and entitling the other parties to temporary, preliminary and permanent injunctive relief, and the costs, expenses and attorney's fees incurred in obtaining or attempting to obtain such relief.

10. The parties agree that if enforcement of this Agreement is required, including the individual payments to individual plaintiffs under paragraph 5, defendants will file a motion to enforce the settlement and seek reasonable attorneys' fees, costs, and expenses against whom enforcement is obtained, consistent with the terms of the parties' settlement.

11. Plaintiffs and Defendants agree that the law applicable in Alabama governs this Agreement, that all negotiations and representations are merged into and superseded by this Agreement, that neither Plaintiffs nor Defendants have assigned any claim covered under this Agreement, that Plaintiffs are solely responsible to satisfy any attorney, spouse, creditor or other third party with any claim to the payments made under paragraph 6., above, and that any change to this Agreement must be made by writing signed by counsel for Plaintiffs and counsel for Defendants.

### SETTLEMENT AGREEMENT AND GENERAL RELEASE

I, **THSIA BRIGGINS**, and every attorney, agent, representative, executor, administrator, and assign (collectively "Briggins"), understand that the parties involved in the individual overtime lawsuits against Honda Manufacturing of Alabama, LLC ("HMA") and Elwood Staffing Services, Inc. ("Elwood") (collectively "Defendants") reached a global settlement, proposed to the Court for approval, of all the plaintiffs' claims in the cases, including my claims, provided me notice of the settlement and the opportunity to object at the approval hearing for the settlement, and that the Court has approved the settlement in each of the individual cases and has dismissed the individual lawsuits with prejudice, including *Thisia Briggins v. Elwood TRI, Inc. and Honda Manufacturing of Alabama, LLC*, CV NO.: 08-CV-01861-KOB.

1. I understand that by negotiating the check made payable to Thisia Briggins in the gross amount of \_\_\_\_\_ in backpay, from which applicable taxes and other legally required deductions have been withheld, I agree to the following:

a. Waive and release every known or unknown claim, action, lawsuit or cause of action, known or unknown, asserted or unasserted, that Briggins may have against Defendants relating in any respect to any part of the Fair Labor Standards Act, as amended, 29 U.S.C. §§201 *et seq.*, or other claims for unpaid wages under federal or state law (excluding any claims accruing in the future following approval of the settlement hereunder, and claims for the enforcement of this Agreement);

b. Understand that this Settlement Agreement is not Defendants' admission of liability and acknowledge and agree that Defendants continue to have the legal right to assert that they did nothing discriminatory, unlawful, or wrong in their dealings with me and the other plaintiffs;

c. Be responsible for the taxes and claims of any agency, attorney, spouse, former spouse, creditor or other third party to the payment made by Defendants to me under this Agreement;

d. Acknowledge the proposition that the payment and commitments made by Defendants under this Agreement to me have value over and above that to which I otherwise would be entitled to receive as a current or former employee of either of the Defendants;

e. Acknowledge and agree under penalty of perjury that the amount designated in paragraph 2.a. below for back compensates me for unpaid time worked from May 2005 to the present and that I have not performed unpaid overtime work for either of the Defendants since 2009;

f. Agree not to disclose the amount of payment pursuant to this Agreement, the fact of payment under the Agreement, or the terms of this Agreement, except that I may disclose this information to my attorney, accountant, or other professional advisor, to whom I must make the disclosure in order for them to render professional services, and my immediate family members, as long as I instruct them to maintain the confidentiality of this information just

as I must, understanding that any breach by me of this paragraph will constitute a material breach of this Settlement Agreement resulting in irreparable harm and entitling Defendants to temporary, preliminary and permanent injunctive relief, and the costs, expenses and attorney's fees incurred in obtaining or attempting to obtain such relief; and

g. Indemnify (for damages of every kind as well as for fees and costs of litigation), defend and hold harmless Defendants in the event I or anyone on my behalf brings, continues, or pursues any claim, action or cause of action in violation of this paragraph. or any other subpart.

2. I agree to this release and waiver through redeeming the check described in paragraph 1 knowingly and voluntarily, understand that I have the opportunity to consult with my counsel prior to accepting this release, agree that Defendants will cancel payment on the check if I have not redeemed the check within 90 days of it being sent to me, and agree to the release without coercion or duress and with the understanding that my redeeming the checks will extinguish any and all claims against Defendants as described in paragraph 1.
