5/27/98 Sentencing hearing conducted. The court finds from the evidence that the defendant has three prior felony convictions. With respect to Count II of the indictment, the defendant having had his say, the court sentences the defendant to a term of his natural life in the State Penitentiary. The defendant is ordered to pay restitution in the amount of \$6,489.77. The defendant is ordered to pay a fine in the sum of \$500.00 and to pay the sum of \$50.00 to the Alabama Crime Victim's Compensation Fund. The defendant is taxed with the cost of court which shall include an amount equal to the attorney fee Declaration, which shall be submitted to the court within fourteen days. If the defendant receives any income from the Department of Corrections, not more than 50% shall be retained and remitted to the court as payment of restitution. The Clerk is directed to apply payments first to restitution and, when paid in full, apply payments to court costs. With respect to Count III, the defendant having had his say, the court, under the provisions of the Alabama Habitual Offender Act, hereby sentences the defendant to a term of 20 years in the State Penitentiary; said sentence is to run concurrent with the sentence imposed in Count II. The defendant is ordered to pay restitution in the sum of \$1,000.00. The defendant is ordered to pay a fine in the sum of \$500.00 and to pay the sum of \$50.00 to the Alabama Crime Victim's Compensation Fund. If the defendant receives any income from the Department of Corrections, not more than 50% shall be retained and remitted to the court which is to be applied towards restitution in Count III after restitution in Count II is paid in full.
