ORDER

This matter is before the Court on the Plaintiff’s “Rule 41(a)(1)(i) Notice of Dismissal Without Prejudice as to Standard Motor Products a/k/a Standard Motor Products, Inc.” (Doc. 78). Plaintiff voluntarily dismisses all of his claims against Defendant Standard Motor Products without prejudice.

A Rule 41(a)(1)(A)(i) Notice of Dismissal is permissible if filed “before the opposing party serves either an answer or a motion for summary judgment[.]” This action was commenced on December 3, 2010. (Doc. 1). The record reveals that Defendant Standard Motor Products has not filed an answer or motion for summary judgment in this case.

Accordingly, it is **ORDERED** that all of the Plaintiff’s claims against Defendant Standard Motor Products are hereby **DISMISSED** without prejudice.

Both parties shall bear their own costs.

Nothing herein shall be construed as dismissing any of the Plaintiff's claims against the remaining defendants.
