
1 2008. The Court finds this Stipulation is in compliance with the terms of the settlement

5 1. To Bombardier Capital, Inc. a portion of the principal on deposit, in the

8 N. Frank Lloyd Wright Blvd., Ste. 1000, Scottsdale, Arizona 85260, to pick up at the
9 Clerk's office.

10 2. To Scotiabank Inverlat S.A. Institución de Banca Múltiple, Grupo
11 Financiero Scotiabank Inverlat, a portion of the principal on deposit, in the amount of
12 \$1,360,277.70, shall be paid by check to: Scotiabank Inverlat S.A.; this check is to be
13 mailed to its counsel, K. Lawson Pedigo, of Miller Keffer Bullock Pedigo, LLC, at 8401
14 N. Central Expwy., Ste. 630, Dallas, Texas, 75225.

15 3. All interest accrued on the original principal amount of \$4,057,686.63
16 deposited with the Clerk shall be paid to Alberto Abed Schekaiban, by check made
17 payable to Uptongrove, LLC.
