ORDER

Pending before the Court are two Applications to Withdraw as Counsel for Plaintiff/Counterdefendant and Counterdefendants. [Dkts. 83, 85]. Subsequent to the filing of the Applications, Monica A. Limon-Wynn and David E. Rauch of Snell & Wilmer LLP

1 filed Notices of Appearance on behalf of Plaintiff/Counterdefendant and
2 Counterdefendants. [Dkts. 92, 93]. Defendants/Counterclaimants do not object to the
3 Applications. [Dkts. 89, 90]. The Applications to Withdraw will be granted.

4 Pending before the Court is Plaintiff/Counterdefendant and Counterdefendants'
5 Motion for Extension of Time to file a Response to Defendants/Counterclaimants' Second
6 Motion to Compel and Request for Sanctions. [Dkt. 87]. The Response to the Motion to
7 Compel and Request for Sanctions was belatedly filed on March 24, 2006. [Dkt. 94].
8 Plaintiff/Counterdefendant and Counterdefendants request an extension of time due to the
9 withdrawal of their former attorneys. Defendants/Counterclaimants oppose an extension.
10 [Dkt. 88]. The Court finds good cause for an extension of time.

11 Accordingly,

12 **IT IS ORDERED** that the Applications to Withdraw [dkts. 83, 85] are **GRANTED**;
13 Bernard M. Brodsky and Jeffrey F. Reina of Lipsitz, Green, Fahringer, Roll, Salisbury &
14 Cambria, LLP and James Lawrence Blair and Roger William Hall of Renaud Cook Drury
15 Mesaros, PA are withdrawn as Counsel for Plaintiff/Counterdefendant and
16 Counterdefendants.

17 **IT IS FURTHER ORDERED** that Plaintiff/Counterdefendant and
18 Counterdefendants' Motion for Extension of Time [dkt. 87] is **GRANTED**.
