**ORDER SETTING FINAL PRETRIAL
CONFERENCE**

Pursuant to Rule 16(d) of the Federal Rules of Civil Procedure, a Final Pretrial Conference shall be held on **October 8, 2008 at 4:00 p.m.** in Courtroom 603, Sandra Day O'Connor U.S. Federal Courthouse, 401 W. Washington St., Phoenix, Arizona 85003-2151. In preparation for this Final Pretrial Conference, it is hereby Ordered:

1. The attorneys who will be responsible for the trial of the case shall attend the Final Pretrial Conference. Counsel shall bring their calendars so that trial scheduling can be discussed.
2. The parties jointly shall prepare a Proposed Final Pretrial Order and shall lodge it with the Court no later than **4:00 p.m. on September 17, 2008.** Preparation and lodging of the Proposed Final Pretrial Order in accordance with the requirements of this Order shall be deemed to satisfy the disclosure requirements of Rule 26(a)(3) of the Federal Rules of Civil Procedure. The parties shall submit a copy of the Proposed Final Pretrial Order to the Court in WordPerfect® 9.0 format either by email to Nancy_Johnson@azd.uscourts.gov or on an IBM-compatible computer disk.

1 3. The Proposed Final Pretrial Order shall include the information prescribed in
2 the Joint Proposed Final Pretrial Order form found at www.azd.uscourts.gov under Judges
3 and Courtrooms and Orders, Forms and Procedures. Information shall not be set forth in the
4 form of a question, but shall be presented in concise narrative statements.

5 4. The Court will not allow the parties to offer any exhibit, witness, or other
6 evidence that was not disclosed in accordance with the provisions of this Order and the
7 Federal Rules of Civil Procedure and listed in the Proposed Final Pretrial Order, except to
8 prevent manifest injustice.

9 5. The parties shall exchange drafts of the Proposed Final Pretrial Order no later
10 than **14 days** before the submission deadline. The Plaintiff(s) shall have the burden of
11 initiating communications concerning the Proposed Final Pretrial Order.

12 6. The parties shall (a) number and mark exhibits in accordance with the
13 instructions found in Exhibit Marking Instructions at www.azd.uscourts.gov under Judges
14 and Courtrooms and Orders, Forms and Procedures (such numbers shall correspond to
15 exhibits numbers listed in the Proposed Final Pretrial Order); (b) meet in person and
16 exchange marked copies of all exhibits to be used at trial no later than **14 days** before the
17 submission deadline for the Proposed Final Pretrial Order (any exhibit not marked and
18 exchanged at this meeting shall be precluded at trial); and (c) eliminate any duplicate exhibits
19 while meeting to exchange exhibits.

20 7. The parties shall file and serve all motions in limine no later than
21 **September 17, 2008**. Responses to motions in limine shall be filed on or before
22 **September 24, 2008**. Each motion in limine shall include proposed language for the order
23 in limine being sought from the Court, and the proposed language shall state with precision
24 the evidence that is subject to the proposed order and the limitation or exclusion placed on
25 the evidence. The motions and responses must be concise and shall not exceed three (3)
26 pages in length. No replies shall be filed. Counsel shall be prepared to argue the merits of
27 such motions at the Final Pretrial Conference.

1 8. If this case will be tried to a jury, the parties shall complete the following tasks
2 by the time of the lodging of the Proposed Final Pretrial Order:

3 (a) The parties shall file a stipulated description of the case to be read to the jury.

4 (b) The parties shall jointly file a proposed set of voir dire questions. The voir dire
5 questions shall be drafted in a neutral manner. To the extent possible, the parties shall
6 stipulate to the proposed questions. If the parties have any disagreement about a particular
7 question, they shall state the reason for their objection below the question. The parties shall
8 also provide, for the purposes of voir dire, a joint master list of the names of every witness
9 who may be called at trial.

10 (c) The parties shall file proposed jury instructions in accordance with "Guidelines
11 for Jury Instructions in Civil Cases" found at www.azd.uscourts.gov under Judges and
12 Courtrooms and Orders, Forms and Procedures.

13 (d) Each party shall file a proposed form of verdict, including any proposed special
14 verdict forms or juror interrogatories.

15 (e) The joint statement of the case, proposed voir dire questions, proposed jury
16 instructions, and forms of verdict shall be submitted in WordPerfect® 9.0 format either by
17 email to Nancy_Johnson@azd.uscourts.gov or on an IBM-PC compatible disk.

18 9. If the case will be tried to the Court, each party shall lodge proposed findings
19 of fact and conclusions of law with the Proposed Final Pretrial Order. The proposed findings
20 of fact and conclusions of law shall also be submitted in WordPerfect® 9.0 format either by
21 email to Nancy_Johnson@azd.uscourts.gov or on an IBM-compatible computer disk.

22 10. The parties shall be prepared to advise the Court at the Final Pretrial
23 Conference of the status of settlement discussions. Should settlement be reached at any time,
24 the parties promptly shall file a Notice of Settlement with the Clerk of the Court.

25 11. Counsel shall review Judge Campbell's statement of Trial Conduct and
26 Decorum before the Final Pretrial Conference. A copy can be found on the Court's website
27 at www.azd.uscourts.gov under Judges and Courtrooms and Orders, Forms and Procedures.
