26 Pursuant to the Court’s Order dated December 5, 2007, the Court has required
27 Transwestern Pipeline Company LLC (“Transwestern”) to “forthwith file a report
28 advising when it expects to be able to perfect service on each of the above cases” (Order

1 at p. 9 or p. 32). Accordingly, Transwestern files this Report on Service of Process.

2 Transwestern is expediting service of process. Service began on Monday,
3 December 3, 2007. As of December 5, 2007, Transwestern has served approximately
4 170 named defendants in all actions. Transwestern anticipates that the remaining named
5 defendants whose whereabouts are known will be served by December 7, 2007.
6 Currently, Transwestern has been unable to serve approximately 18 defendants upon
7 whom service has been attempted. Transwestern is hopeful that service on these
8 defendants can be effected by Monday, December 10, 2007. Transwestern has also
9 delivered courtesy copies of all filings on counsel of whom Transwestern is aware.
10 Counsel was identified as representing a defendant during negotiations or during the
11 Federal Energy Regulatory Commission (“FERC”) process. For unknown defendants or
12 defendants whose whereabouts are unknown, Transwestern commenced publication in
13 Yavapai, Maricopa and Pinal Counties publications on December 5 and 6, 2007. Under
14 Rule 71.1, formerly 71A, *Federal Rules of Civil Procedure*, process by publication will
15 be effective by December 20, 2007.

16 Transwestern also has several cases, which for various reasons it could not yet file.
17 Transwestern anticipates these suits will be filed no later than December 14, 2007 and
18 service made the same day or no later than December 17, 2007.

19 Because of the nature of cases and the numerous defendants, Transwestern has not
20 yet filed affidavits of service. Transwestern anticipates to begin receiving the affidavits
21 on Thursday, December 6, 2007 and to begin filing these affidavits of service
22 immediately.

23 Finally, on case, CV-07-8140-PCT-JWS, Parcel No. YA-123 has been dismissed
24 because a settlement has been reached. Transwestern anticipates that several other suits
25 will be dismissed because settlements will be reached.
