) **ORDER**

---

Plaintiff Stephen Nicewander, who is confined in the Maricopa County Durango Jail, has filed a *pro se* civil rights Complaint pursuant to 42 U.S.C. § 1983 and an Application to Proceed *In Forma Pauperis*.<sup>1</sup> The Court will dismiss the Complaint with leave to amend.

**I. Application to Proceed *In Forma Pauperis* and Filing Fee**

Plaintiff’s Application to Proceed *In Forma Pauperis* will be granted. 28 U.S.C. § 1915(a). Plaintiff must pay the statutory filing fee of \$350.00. 28 U.S.C. § 1915(b)(1). The Court will not assess an initial partial filing fee. 28 U.S.C. § 1915(b)(1). The statutory fee will be collected monthly in payments of 20% of the previous month’s income each time

<sup>1</sup>Many inmates apparently believe that they will receive an immediate payout from a fund established in Hart v. Hill, No. CV 77-0479-PHX-EHC (MS) (D. Ariz.). No such fund exists. The inmates in Hart asked for injunctive relief and not monetary damages. The Court at this time expresses no opinion on whether Plaintiff’s lawsuit may result in an award of damages.

1 the amount in the account exceeds \$10.00. 28 U.S.C. § 1915(b)(2). The Court will enter a  
2 separate Order requiring the appropriate government agency to collect and forward the fees  
3 according to the statutory formula.

## 4 **II. Statutory Screening of Prisoner Complaints**

5 The Court is required to screen complaints brought by prisoners seeking relief against  
6 a governmental entity or an officer or an employee of a governmental entity. 28 U.S.C.  
7 § 1915A(a). The Court must dismiss a complaint or portion thereof if a plaintiff has raised  
8 claims that are legally frivolous or malicious, that fail to state a claim upon which relief may  
9 be granted, or that seek monetary relief from a defendant who is immune from such relief.  
10 28 U.S.C. § 1915A(b)(1), (2). If the Court determines that a pleading could be cured by the  
11 allegation of other facts, a *pro se* litigant is entitled to an opportunity to amend a complaint  
12 before dismissal of the action. See Lopez v. Smith, 203 F.3d 1122, 1127-29 (9th Cir. 2000)  
13 (*en banc*).

14 The Court should not, however, advise the litigant how to cure the defects. This type  
15 of advice “would undermine district judges’ role as impartial decisionmakers.” Pliler v.  
16 Ford, 542 U.S. 225, 231 (2004); see also Lopez, 203 F.3d at 1131 n.13 (declining to decide  
17 whether the court was required to inform a litigant of deficiencies). Plaintiff’s Complaint  
18 will be dismissed for failure to state a claim, with leave to amend because the Complaint may  
19 possibly be saved by amendment.

## 20 **III. Complaint**

21 Plaintiff names Sheriff Joe Arpaio as Defendant. The Complaint contains eight counts  
22 concerning the conditions of confinement in the Jail. In Count I, Plaintiff alleges there is  
23 insufficient light in the pods for reading, the temperature is too cold, and he receives only one  
24 blanket, which is not enough. In Count II, Plaintiff alleges that outside recreation time is  
25 limited to 40 minutes two or three times per week. In Count III, Plaintiff alleges that the  
26 overpopulation creates noise. In Count IV, Plaintiff alleges he has no access to reading  
27 materials because there is no book cart and books and magazines are delivered only once a  
28 month. In Count V, Plaintiff alleges that blankets are changed only every other month, one

1 blanket is not enough to provide warmth, no pillows are issued, and there is no place to dry  
2 wet towels or clothes. In Count VI, Plaintiff alleges that laundry is changed only once per  
3 week. In Count VII, Plaintiff alleges that he receives only two meals per day and they are  
4 served by inmates with health risks and without food handlers' cards. In Count VIII, Plaintiff  
5 alleges that he is breathing asbestos fibers at the Jail.

6 For relief, Plaintiff seeks injunctive relief, damages, and an order holding Defendant  
7 in contempt.

#### 8 **IV. Failure to State a Claim**

##### 9 **A. Failure to Link the Harm to Defendant**

10 To state a valid claim under § 1983, plaintiffs must allege that they suffered a specific  
11 injury as a result of specific conduct of a defendant and show an affirmative link between the  
12 injury and the conduct of that defendant. Rizzo v. Goode, 423 U.S. 362, 371-72, 377 (1976).

13 To state a claim against a supervisory official, the civil rights complainant must allege that  
14 the supervisory official personally participated in the constitutional deprivation or that the  
15 supervisory official was aware of widespread abuses and, with deliberate indifference to the  
16 inmate's constitutional rights, failed to take action to prevent further misconduct. See Ortez  
17 v. Washington County, Or., 88 F.3d 804, 809 (9th Cir. 1996); Taylor v. List, 880 F.2d 1040,  
18 1045 (9th Cir. 1989); King v. Atiyeh, 814 F.2d 565, 568 (9th Cir. 1987); see also Monell v.  
19 New York City Department of Social Services, 436 U.S. 658, 691 (1978). There is no  
20 *respondeat superior* liability under § 1983, and, therefore, a defendant's position as the  
21 supervisor of persons who allegedly violated Plaintiff's constitutional rights does not impose  
22 liability. Monell, 436 U.S. at 691-92; Taylor, 880 F.2d at 1045.

23 Plaintiff does not allege that Defendant Arpaio personally participated in the  
24 constitutional deprivation or that he was aware of widespread abuses and, with deliberate  
25 indifference to Plaintiff's constitutional rights, failed to take action to prevent further  
26 misconduct, or that he formed policies that resulted in Plaintiff's injuries. Plaintiff has failed  
27 to state a claim against Defendant Arpaio.

1           **B.     Failure to Allege a Constitutional Violation**

2           Section 1983 provides a cause of action against persons acting under color of state  
3 law who have violated rights guaranteed by the United States Constitution and federal law.  
4 42 U.S.C. § 1983; see also Buckley v. City of Redding, 66 F.3d 188, 190 (9th Cir. 1995).  
5 A pretrial detainee’s claim for unconstitutional conditions of confinement arises from the  
6 Due Process Clause rather than from the Eighth Amendment prohibition against cruel and  
7 unusual punishment. Bell v. Wolfish, 441 U.S. 520 (1979). Nevertheless, the Eighth  
8 Amendment provides a minimum standard of care for determining a plaintiff’s rights as a  
9 pretrial detainee. Anderson v. Kern, 45 F.3d 1310, 1312-13 (9th Cir. 1995) (citing Redman  
10 v. County of San Diego, 942 F.2d 1435, 1442 (9th Cir. 1991)). To prevail on an  
11 unconstitutional conditions claim under an Eighth Amendment standard of care, a plaintiff,  
12 whether a pretrial detainee or a convict, must show that defendants were “deliberately  
13 indifferent” to the alleged constitutional violations. Redman, 942 F.2d at 1443; Wilson v.  
14 Seiter, 501 U.S. 294, 302-03 (1991).

15           The specific inquiry with respect to pretrial detainees is whether the prison conditions  
16 amount to “punishment” without due process in violation of the Fourteenth Amendment.  
17 Bell, 441 U.S. at 535. With regard to providing pretrial detainees with such basic necessities  
18 as food, living space, and medical care, the minimum standard allowed by the Due Process  
19 Clause is the same as that allowed by the Eighth Amendment for convicted persons. Hamm  
20 v. Dekalb County, 774 F.2d 1567, 1574 (11th Cir. 1985). To comply with the Eighth  
21 Amendment’s prohibition against cruel and unusual punishment, a prison must provide  
22 prisoners with “adequate food, clothing, shelter, sanitation, medical care, and personal  
23 safety.” Hoptowit v. Ray, 682 F.2d 1237, 1246 (9th Cir. 1982). However, this does not  
24 mean that federal courts can or should interfere whenever prisoners are inconvenienced or  
25 suffer *de minimis* injuries. See Bell, 441 U.S. at 539 n.21 (noting that a *de minimis* level of  
26 imposition does not rise to a constitutional violation).

27           Here, Plaintiff has not alleged a constitutional violation in any of the counts.  
28

1 **V. Leave to Amend**

2 For the foregoing reasons, Plaintiff’s Complaint will be dismissed for failure to state  
3 a claim upon which relief may be granted. Within 30 days, Plaintiff may submit a first  
4 amended complaint to cure the deficiencies outlined above. The Clerk of Court will mail  
5 Plaintiff a court-approved form to use for filing a first amended complaint. If Plaintiff fails  
6 to use the court-approved form, the Court may strike the amended complaint and dismiss this  
7 action without further notice to Plaintiff.

8 Plaintiff must clearly designate on the face of the document that it is the “First  
9 Amended Complaint.” The first amended complaint must be retyped or rewritten in its  
10 entirety on the court-approved form and may not incorporate any part of the original  
11 Complaint by reference. Plaintiff may include only one claim per count.

12 A first amended complaint supersedes the original complaint. Ferdik v. Bonzelet, 963  
13 F.2d 1258, 1262 (9th Cir. 1992); Hal Roach Studios v. Richard Feiner & Co., 896 F.2d 1542,  
14 1546 (9th Cir. 1990). After amendment, the Court will treat an original complaint as  
15 nonexistent. Ferdik, 963 F.2d at 1262. Any cause of action that was raised in the original  
16 complaint is waived if it is not raised in a first amended complaint. King, 814 F.2d at 567.

17 **VI. Warnings**

18 **A. Release**

19 Plaintiff must pay the unpaid balance of the filing fee within 120 days of his release.  
20 Also, within 30 days of his release, he must either (1) notify the Court that he intends to pay  
21 the balance or (2) show good cause, in writing, why he cannot. Failure to comply may result  
22 in dismissal of this action.

23 **B. Address Changes**

24 Plaintiff must file and serve a notice of a change of address in accordance with Rule  
25 83.3(d) of the Local Rules of Civil Procedure. Plaintiff must not include a motion for other  
26 relief with a notice of change of address. Failure to comply may result in dismissal of this  
27 action.

1           **C. Copies**

2           Plaintiff must submit an additional copy of every filing for use by the Court. See  
3 LRCiv 5.4. Failure to comply may result in the filing being stricken without further notice  
4 to Plaintiff.

5           **D. Possible “Strike”**

6           Because the Complaint has been dismissed for failure to state a claim, if Plaintiff fails  
7 to file an amended complaint correcting the deficiencies identified in this Order, the  
8 dismissal will count as a “strike” under the “3-strikes” provision of 28 U.S.C. § 1915(g).  
9 Under the 3-strikes provision, a prisoner may not bring a civil action or appeal a civil  
10 judgment *in forma pauperis* under 28 U.S.C. § 1915 “if the prisoner has, on 3 or more prior  
11 occasions, while incarcerated or detained in any facility, brought an action or appeal in a  
12 court of the United States that was dismissed on the grounds that it is frivolous, malicious,  
13 or fails to state a claim upon which relief may be granted, unless the prisoner is under  
14 imminent danger of serious physical injury.” 28 U.S.C. § 1915(g).

15           **E. Possible Dismissal**

16           If Plaintiff fails to timely comply with every provision of this Order, including these  
17 warnings, the Court may dismiss this action without further notice. See Ferdik, 963 F.2d at  
18 1260-61 (a district court may dismiss an action for failure to comply with any order of the  
19 Court).

20 **IT IS ORDERED:**

21           (1) Plaintiff’s Application to Proceed *In Forma Pauperis*, filed with the Complaint,  
22 is **granted**.


23           (2) As required by the accompanying Order to the appropriate government agency,  
24 Plaintiff must pay the \$350.00 filing fee and is not assessed an initial partial filing fee.

25           (3) The Complaint (Doc. #1) is **dismissed** for failure to state a claim. Plaintiff has  
26 **30 days** from the date this Order is filed to file a first amended complaint in compliance with  
27 this Order.

1 (4) If Plaintiff fails to file an amended complaint within 30 days, the Clerk of  
2 Court must, without further notice, enter a judgment of dismissal of this action with prejudice  
3 that states that the dismissal counts as a “strike” under 28 U.S.C. § 1915(g).

4 (5) The Clerk of Court must mail Plaintiff a court-approved form for filing a civil  
5 rights complaint by a prisoner.

**INFORMATION AND INSTRUCTIONS FOR A  
PRISONER FILING CIVIL RIGHTS COMPLAINT  
IN THE UNITED STATES DISTRICT COURT  
FOR THE DISTRICT OF ARIZONA**

**I. General Information About the Civil Rights Complaint Form:**

A. The Form. The civil rights complaint form is designed to help prisoners prepare a complaint seeking relief for a violation of their federal civil rights. Local Rule of Civil Procedure 3.4(a) requires that prisoner civil rights complaints be filed on the court-approved form. Your complaint must be typewritten or legibly handwritten. All information must be clearly and concisely written, **only in the space provided on the form**. If needed, you may attach no more than fifteen additional pages of standard letter size paper to continue any part of the complaint. You must identify which part of the complaint is being continued and number all pages.

B. Your Signature. You must sign the complaint. Your signature constitutes a certificate that: 1) you have read the complaint; 2) to the best of your knowledge, information and belief formed after reasonable inquiry it is well grounded in fact and law; and 3) it is not being filed for any improper purpose. Please review Rule 11 of the Federal Rules of Civil Procedure. Rule 11 provides for the imposition of sanctions if the complaint is signed in violation of the Rule.

C. The Filing Fee. You must pay the \$350.00 filing fee. If you are unable to pay the filing fee when the complaint is filed, you may request leave to proceed *in forma pauperis*. Please review the "Information for Prisoners Seeking Leave to Proceed with a (Non-Habeas) Civil Action in Federal Court *In Forma Pauperis* Pursuant to 28 U.S.C. § 1915" for more information.

D. Court Divisions. If you resided in Maricopa, Pinal, Yuma, La Paz, or Gila county when your rights were allegedly violated, you should file your complaint in the Phoenix Division of the court. If you resided in Apache, Navajo, Coconino, Mohave, or Yavapai county when your rights were allegedly violated, you should file your complaint in the Prescott Division of the court. If you resided in Pima, Cochise, Santa Cruz, Graham, or Greenlee county when your rights were allegedly violated, you should file your complaint in the Tucson Division of the court. See LRCiv 5.1(a) and 77.1(a).

You should mail THE ORIGINAL AND ONE COPY of your complaint with the \$350.00 filing fee or the application to proceed *in forma pauperis* to:

E. Certificate of Service on Defendants. You must furnish the opposing party or their attorney with a copy of any document you submit to the court (except the initial complaint and application to proceed *in forma pauperis*). Pursuant to Rules 5(a) and (d) of the Federal Rules of Civil Procedure, each original document (except the initial complaint and application for leave to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the opposing party or their attorney and the address to which it was mailed. Any document received by the court which does not include a certificate of service may be stricken. A certificate of service should be in the following form:

F. Original and Judge's Copy. You must furnish an original and one copy of any document submitted to the court. You must furnish one additional copy to the clerk if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original.

G. Exhibits. You should not submit exhibits with the complaint. Instead, the relevant information should be paraphrased in the complaint. You should keep the exhibits to use to support or oppose a motion for summary judgment or at trial.

H. Change of Address. You must immediately notify the clerk and the opposing party or their attorney in writing of any change in your mailing address. Failure to notify the court of any change in your mailing address may result in the dismissal of your case.

I. Amended Complaint. If you need to change any of the information in the initial complaint, you must file an amended complaint. The amended complaint must be written on the court-approved civil rights complaint form. Rule 15(a) of the Federal Rules of Civil Procedure allows you to file one amended complaint prior to any defendant filing an answer. After any defendant has filed an answer, you must file a motion for leave to amend and lodge a proposed amended complaint. Local Rule of Civil Procedure 15.1(a)(2) prohibits any amended pleading from referencing any prior pleading. Further, any allegations or defendants not included in the amended complaint are considered dismissed.

J. Letters and Motions. It is generally inappropriate to write a letter to any of the District Judges, Magistrates Judges, or the staff of any of the judicial officers. The appropriate way to communicate with these persons is by filing a written pleading or motion.

## **II. Completing the Civil Rights Complaint Form:**

### **HEADING:**

1. Your Name. Print your name, prison or jail inmate number, and mailing address on the lines provided.
2. Defendants. Print the names of each of your defendants. If you name more than **four** defendants, you should print the name of one defendant and "see additional page for defendants" in the space provided. On the additional page you must list the names of **all** of the defendants. This additional page should be inserted after page 1 and numbered as page "1-A" at the bottom of the page. The initial complaint must contain the names of **all** of the parties (plaintiffs as well as defendants) in the heading (or on the additional page if more than four defendants). See Rule 10(a) of the Federal Rules of Civil Procedure.
3. Jury Demand. If you want a jury trial, you must write "JURY TRIAL DEMANDED" on the line below "CIVIL RIGHTS COMPLAINT BY A PRISONER." Failure to do so will result in the loss of the right to a jury trial. A jury trial is not available if you are seeking only injunctive relief.

### **Part A. JURISDICTION:**

1. Nature of Suit. Mark whether you are filing the complaint pursuant to 42 U.S.C. § 1983 for state, county, or city defendants; "Bivens v. Six Unknown Federal Narcotics Agents" for federal defendants; or "other." If you mark "other," identify the source of that authority.
2. Plaintiff. Print all of the requested information on the spaces provided. Identify the institution and city where the alleged violation of your rights occurred.
3. Defendants. Print all of the requested information about each of the defendants in the spaces provided. If you are naming more than four defendants, you must provide the necessary information about each additional defendant on a separate page. Label the page(s) as "2-A," "2-B," etc., at the bottom of the page and insert the additional page(s) immediately behind page 2.

### **Part B. PREVIOUS LAWSUITS:**

You must identify any other lawsuit you have filed in either state or federal court while you were a prisoner. Print all of the requested information about each lawsuit in the spaces provided. If you have filed more than three lawsuits, you must provide the necessary information about each additional lawsuit on a separate page. Label the page(s) as "2-A," "2-B," etc., at the bottom of the page and insert the additional page(s) immediately behind page 2.

### **Part C. CAUSE OF ACTION:**

You must identify what rights the defendant(s) violated. The form provides space to allege three separate counts (one violation per count). If you are alleging more than three

counts, you must provide the necessary information about each additional count on a separate page. Number the additional pages "5-A", "5-B", etc., and insert them immediately behind page 5. Remember that you are limited to a total of fifteen additional pages.

1. Counts. You must identify which civil right was violated. **YOU MAY ALLEGE THE VIOLATION OF ONLY ONE CIVIL RIGHTS CLAIM PER COUNT.**

2. Issue Involved. Check the box that most closely identifies the issue involved in your claim. **YOU MAY CHECK ONLY ONE BOX PER COUNT.** If you check the box marked "Other," you must identify the specific issue involved in the space provided.

3. Supporting Facts. After you have identified which civil right was violated, you need to state the supporting facts. Be as specific as possible. You must state what each individual defendant did to violate your rights. If there is more than one defendant, you need to identify which defendant did what act. You also need to state the date(s) on which the act(s) occurred if possible.

4. Injury. State precisely how you were injured by the alleged violation of your rights.

5. Administrative Remedies. Exhaustion of administrative remedies is a prerequisite to filing a civil rights complaint. 42 U.S.C. § 1997e requires prisoners to exhaust the available administrative remedies before being allowed to file a civil rights action. Consequently, you must disclose whether you have exhausted the inmate grievance procedures or administrative appeals for each count in your complaint. If one of your counts is exempt from the grievance procedures or administrative appeals, fully explain the exemption on the lines provided.

**Part D. REQUEST FOR RELIEF:**

Print the relief you are seeking in the space provided.

**SIGNATURE:**

You must sign your name and print the date you signed the complaint. Your signature must be an original signature, not a photocopy.

**FINAL NOTE**

You should follow these instructions carefully. Failure to do so may result in your complaint being stricken or dismissed by the court. All questions must be answered concisely in the proper space on the form. If needed, you may attach no more than fifteen additional pages. The form, however, must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the complaint is being continued and number the pages.
