**DEFENDANT’S MOTION TO
 EXTEND TIME TO INDICT**
 (Reentry After Deportation)
 (First Request)

 17 The above-named defendant, Rigoberto Mejía, who is accused of Reentry
 18 After Deportation in violation of 8 U.S.C. § 1326, being advised of the nature of the
 19 charges and of his rights in this matter, hereby moves this Court, pursuant to 18 U.S.C.
 20 § 3161(h)(8)(A), for an extension of an additional thirty (30) days within which the
 21 Government must indict this matter as required by the Speedy Trial Act. 18 U.S.C. §
 22 3161. The basis for this request is to permit the defendant time within which to review
 23 the facts in this matter, to review discovery and to investigate defenses prior to waiving
 24 rights to a number of hearings. Additionally, the defendant is housed at CCA which is
 25 located between Phoenix and Tucson. This distance, coupled with the need for
 26 interpretation, requires additional time for counsel to review discovery material with the
 27 defendant.
