RULE 11(c)(1)(C), F.R. Crim. P., Stipulated Sentence: The defendant shall be: 1) sentenced to thirty (30) days incarceration; 2) no supervised release; and 3) fined at the Court's discretion.

DISPOSITION OF ADDITIONAL CHARGES: n/a

I, Federico Camacho-Valdez, understand that the above sentencing provision is binding upon the Court if the Court accepts my guilty plea under this plea agreement.

By pleading guilty, I will be giving up my rights to plead not guilty; to confront, cross-examine and compel the attendance of witnesses; to present evidence in my defense; to remain silent and refuse to be a witness against myself by asserting my privilege against self-incrimination – all with the assistance of counsel – and to be presumed innocent until proven guilty beyond a reasonable doubt. I waive my right to trial, agree to enter my plea before and to be sentenced by a U.S. Magistrate Judge, and waive any right to appeal or otherwise challenge my conviction. The nature of the charge(s) and the possible penalties have been explained to me, and there is a factual basis for each charge to which I am pleading guilty. I understand that the Court may later modify the terms and conditions of any probation or supervised release ordered as part of my sentence. My guilty plea is not the result of force, threats, or promises other than

as part of my sentence. My guilty plea is not the result of force, threats, or promises other than any promises contained in this written agreement. I am not currently under the influence of alcohol or any other intoxicants and I am fully capable of understanding this agreement and enter it voluntarily.
