I am Betty J. Brown, former significant other of Randy Sammy Roberts, plaintiff/petitioner in case number CV '06 2625 PHX SMM. I am writing this letter to express my experiences with Randy during our years as a couple, and my interactions with him as my daughter's father.

In the beginning of our relationship, I really enjoyed Randy's companionship. We had many common interests and life ambitions. However, as the years rolled on, our relationship drastically deteriorated. Although he went to great lengths to hide the strong foundation of falsehood on which he built his life, I began to see Randy for who he truly was. Randy's character was manipulative, deceitful, repulsive, disappointing, and extremely exasperating.

I invested years of my life doing what I could to make our relationship work, listening to his empty promises, and upset by his unfulfilled commitments. I can not fully convey the frustration my relationship with Randy caused me.
