18 COMES NOW the Defendant, Christopher T. Williams, by and through
 19 undersigned counsel, and submits the following *Memorandum* regarding the *Supervised*
 20 *Release Disposition Report* for the Court’s consideration.

21 **Memorandum**

22 On or about June 7, 2007, undersigned counsel received a copy of the *Supervised*
 23 *Release Disposition Report* (herein after “report”) via fax. The report states on page
 24 three, under the *Unsatisfied Special Conditions* section, that “the Court imposed a 180
 25 day period of placement at a community corrections center” and that the Defendant “has
 a balance of 180 days to satisfy this obligation.”

1 A review of the record reflects that the Court, on February 2, 2007, issued an order
2 that stated, "Christopher Williams shall reside at and participate in a residential re-entry
3 center, under the community corrections component, and shall follow the rules of the
4 program, as approved by the Probation Officer, for a period *not to exceed 180 days* or
5 until discharged by the program director, pursuant to 18 U.S.C. 3563(b)(11)." See Waiver
6 and Order (Document Number 25) (Emphasis Added). Counsel submits that the report is
7 incorrect when it states that "the Court imposed a *180 day period* of placement at a
8 community corrections center."
