CONDITIONS SET FORTH ARE AS FOLLOWS:

- DEFENDANT SHALL NOT TRAVEL OUTSIDE the state of Arizona unless Court permission is granted to travel elsewhere
- DEFENDANT SHALL SEEK VERIFIABLE EMPLOYMENT
- DEFENDANT SHALL HAVE NO CONTACT WITH ANY VICTIMS, WITNESSES, OR POTENTIAL WITNESSES
- DEFENDANT SHALL NOT USE ANY ALCOHOL AND SHALL NOT USE OR POSSESS ANY NARCOTIC OR OTHER CONTROLLED SUBSTANCES WITHOUT A LEGAL PRESCRIPTION.
- DEFENDANT SHALL PARTICIPATE IN DRUG ALCOHOL PSYCHIATRIC COUNSELING, AND SUBMIT TO DRUG TESTING AS DIRECTED BY PRETRIAL SERVICES.
- DEFENDANT SHALL MAKE A CO-PAYMENT TO THE AGENCY CONTRACTED AND NOT EXCEED TOTAL COST UNTIL SERVICES ARE TERMINATED, AS DIRECTED BY PRETRIAL SERVICES/OFFICER.
- DEFENDANT SHALL REPORT TO PRETRIAL SERVICES AS DIRECTED.
- DEFENDANT SHALL COMPLY WITH CURFEW OF _____
- DEFENDANT SHALL RESIDE AT BEHAVIORAL SYSTEMS SOUTHWEST NEW BEGINNINGS TREATMENT CENTER VIDA SERENA TREATMENT CENTER AND ABIDE BY ALL CONDITIONS AS DIRECTED BY STAFF. THE DEFENDANT SHALL BE REQUIRED TO MAKE A COPAYMENT IN AN AMOUNT TO BE DETERMINED BY THE PRETRIAL SERVICES OFFICER, BUT IN NO EVENT TO BE MORE THAN 50% OF NET INCOME, TO A FACILITY TO BE DETERMINED BY PRETRIAL SERVICES EACH PAY PERIOD UNTIL PLACEMENT IS TERMINATED.
- DEFENDANT SHALL COMPLY WITH ELECTRONIC MONITORING AND ABIDE BY ALL REQUIREMENTS.
- DEFENDANT SHALL PAY FOR THE MONITORING ONE MONTH IN ADVANCE AT THE RATE OF \$3.47 PER DAY AND THEREAFTER REGULAR MONTHLY PAYMENTS UNTIL MONITORING IS TERMINATED.
- DEFENDANT IS PLACED IN THE THIRD PARTY CUSTODY OF ESTHER IDA DELORES ANDREW AND SHALL RESIDE WITH HER UPON HIS RELEASE FROM VIDA SERENA.
- DEFENDANT SHALL NOT POSSESS ANY FIREARM OR ANY OTHER DANGEROUS OR DESTRUCTIVE DEVICES

ALL OTHER STANDARD CONDITIONS OF RELEASE ARE ADOPTED BY THE COURT.

- DEFENDANT ADVISED OF CONDITIONS OF RELEASE ON THE RECORD ADVISED PREVIOUSLY
- CUSTODIAN ADVISED OF CONDITIONS OF RELEASE ON THE RECORD ADVISED PREVIOUSLY
- DEFENDANT RELEASED ON JUDGE'S SIGNATURE
- OTHER: THE DEFENDANT SHALL RESOLVE ALL LOWER COURT MATTERS AND PROVIDE PROOF OF SUCH TO PRETRIAL SERVICES.
