COMPLAINANT'S STATEMENT OF FACTS CONSTITUTING THE OFFENSE OR VIOLATION:

On or about November 08, 2007, at or near Nogales, Arizona, in the District of Arizona, Victor Manuel ARREDONDO-Bojorquez, an alien, entered, and was found in the United States of America after having been denied admission, excluded, deported, and removed from the United States through San Ysidro, CA on February 06, 2007, and not having obtained the express consent of the Attorney General or the Secretary of DHS to reapply for admission thereto; in violation of Title 8, United States Code, Section 1326, enhanced by Title 8, United States Code, Section 1326 (b) (2).

BASIS OF COMPLAINANTS CHARGE AGAINST THE ACCUSED:

Victor Manuel ARREDONDO-Bojorquez is a citizen of Mexico. On February 06, 2007, Victor Manuel ARREDONDO-Bojorquez was lawfully denied admission, excluded, deported, and removed from the United States through San Ysidro, CA. On November 08, 2007, agents found ARREDONDO-Bojorquez in the United States at or near Nogales, Arizona. ARREDONDO-Bojorquez did not obtain the express consent of the Attorney General or the Secretary of DHS to re-apply for admission to the United States. ARREDONDO-Bojorquez admitted that he was a Mexican citizen with no legal documents that would allow him to be or remain in the United States legally.
