COMPLAINANT'S STATEMENT OF FACTS CONSTITUTING THE OFFENSE OR VIOLATION:

On or about November 13, 2007, at Tucson, in the District of Arizona, the above named defendant, Peter Gregorio CASTRO, did knowingly escape from custody at Dismas Charities half-way house; an institutional facility in which he was lawfully confined at the direction of the Attorney General by virtue of a judgment and commitment of the United States District Court for the District of Arizona upon conviction for the commission of Conspiracy to Distribute Cocaine, a class A Felony Offense, and Use of a Firearm, as charged in the Indictment, and in violation of Title 21, United States Code, Section 841(a)(1), in violation of Title 18, United States Code, Sections 924(c) and 751(a).

BASIS OF COMPLAINANT'S CHARGE AGAINST THE ACCUSED:

On or about March 8, 2000, Peter Gregorio CASTRO was sentenced to the custody of the Attorney General for a term of NINETY EIGHT (98) MONTHS pursuant to his conviction for Conspiracy to Distribute Cocaine and Use of a Firearm, in case number CR 98-0524-TUC-FRZ. According to the Bureau of Prisons (BOP)Peter Gregorio CASTRO was to be released from custody on December 17, 2007, via good conduct release. Pursuant to his 98 month commitment to the Bureau of Prisons, and by the authority of the Attorney General of the United States, Peter Gregorio CASTRO was designated to serve a portion of his sentence at Dismas Charities, a community corrections facility located in Tucson, in the District of Arizona. The defendant left on November 13, 2007 and was discovered missing by facility officials after a facility count was conducted. A subsequent search of the grounds for the defendant was negative. The defendant did not have permission to be away from the facility. The defendant was placed on escape status by the Bureau of Prisons. As of November 16, 2007 the defendant has not been located.
