Petitioner Keith R. Stokes, who is confined in the Arizona State Prison Complex-Safford (ASPC-Safford), has filed a *pro se* Petition for Writ of Habeas Corpus pursuant to 28 U.S.C. § 2254 (Doc. #1) and an Application to Proceed *In Forma Pauperis* (Doc. #3). The Court will grant the Application to Proceed *In Forma Pauperis*, dismiss the Petition without prejudice, with leave to amend, and give Petitioner 30 days from the filing date of this order to file his amended petition with the Clerk of Court on the court-approved form included with this order.

I. Application to Proceed *In Forma Pauperis*

Petitioner’s Application to Proceed *In Forma Pauperis* indicates that his inmate trust account balance is less than \$25.00. Accordingly, the Application to Proceed *In Forma Pauperis* (Doc. #3) will be granted. See LRCiv 3.5(b).

1 **II. Petition**

2 Named as Respondents in the Petition are: (1) Dora B. Schriro, former Director of the
3 Arizona Department of Corrections (ADOC); and (2) Jackson, Warden of ASPC-Safford.
4 Terry Goddard, Attorney General of the State of Arizona, is named as an Additional
5 Respondent. The Court takes judicial notice that Dora B. Schriro is no longer Director of the
6 ADOC. Accordingly, the new Interim Director of the ADOC, Charles L. Ryan, will be
7 substituted as Respondent pursuant to Rule 25(d) of the Federal Rules of Civil Procedure.

8 Petitioner challenges his judgment of conviction on April 25, 2003, for one count of
9 Second-Degree Murder, two counts of First-Degree Attempted Murder, and one count of
10 Aggravated Assault, entered in the Maricopa County Superior Court in matter CR 2000-
11 013991. Petitioner alleges he was sentenced to a 54-year prison term. Petitioner presents
12 five grounds for habeas corpus relief in which he alleges that the following constitutional
13 provisions were violated:

- 14 (1) “U.S.C.A. 5th Amend. Violation under the 14th”;
- 15 (2) “U.S.C.A. 14th Amend.”;
- 16 (3) “U.S.C.A. 8th Amend.”;
- 17 (4) “U.S.C.A. 3rd Separation of Powers where Sentence and Conviction violated
18 Arizona Revised Statutes A.R.S. §§§ 13-110; 111; 115A; and 116”;
- 19 (5) “U.S.C.A. 6th ineffective counsel through this entire process as required under
20 A.R.C.P. 6.8 ‘Standards for Appointment of Counsel in Capital Cases.’”

21 **III. Exhaustion of State Remedies**

22 A prisoner attacking his state conviction must exhaust state remedies before a federal
23 court will entertain a petition for writ of habeas corpus. Rose v. Lundy, 455 U.S. 509, 102
24 (1982); Szeto v. Rushen, 709 F.2d 1340 (9th Cir. 1983). The federal court will not entertain
25 a petition for writ of habeas corpus unless each and every issue has been exhausted. Rose,
26 455 U.S. at 521-22. “[E]xcept in habeas petitions in life-sentence or capital cases, claims of
27 Arizona state prisoners are exhausted for purposes of federal habeas once the Arizona Court
28 of Appeals has ruled on them.” Swoopes v. Sublett, 196 F.3d 1008, 1010 (9th Cir. 1999).

1 The failure to exhaust subjects the Petitioner to dismissal. Gutierrez v. Griggs, 695 F.2d
2 1195 (9th Cir. 1983).

3 Petitioner alleges that he has presented the issues in Grounds I, III, and V to the
4 Arizona Supreme Court. Petitioner does not indicate if the issue in Ground II was presented
5 to any state court and indicates that the issue in Ground IV was not presented to the Arizona
6 Supreme Court. Thus, it is unclear from the Petition if all grounds have been exhausted in
7 the state courts as required.

8 **IV. Dismissal of Petition With Leave to Amend**

9 Because exhaustion is unclear, the Court will dismiss the Petition without prejudice,
10 with leave to amend, to show how **each and every ground** has been exhausted in the state
11 courts. Petitioner will be given 30 days from the filing date of this order to file his amended
12 petition with the Clerk of Court on the court-approved form included with this order.

13 With regard to any amended petition that he may file, Petitioner should note that
14 pursuant to 28 U.S.C. § 2254, federal courts “shall entertain an application for a writ of
15 habeas corpus in behalf of a person in custody pursuant to the judgment of a State court only
16 on the ground that he is in custody in violation of the Constitution or laws or treaties of the
17 United States.” 28 U.S.C. § 2254(a). Accordingly, for each ground Petitioner alleges in an
18 amended petition, he must allege how he is in custody in violation of the Constitution or laws
19 or treaties of the United States, and should also provide information as to how he has first
20 exhausted his administrative remedies as to each and every claim.

21 Petitioner must limit each ground to the allegation of the violation of a single
22 constitutional right, must describe the right and its source in the Constitution, and must
23 clearly state supporting facts showing how that constitutional right was violated. The
24 grounds and facts must be clearly set out as fully as possible on the court-approved petition
25 form itself. If Petitioner cannot fit all of his supporting facts or arguments in favor of a
26 particular ground on the court-approved form, then he may continue on an attachment, but
27 each matter on any attachment must be clearly referenced to a particular ground on the court-
28 approved form, and be numbered appropriately. To the extent that Petitioner desires to allege

1 more than four grounds in an amended petition, he should photocopy an extra page of page 9
2 of the court-approved form for each additional ground, and after renumbering the ground and
3 page as appropriate, use the extra page or pages to present his other claim or claims.

4 Petitioner should take notice that by amending his Petition, he will be presumed to
5 have deliberately waived his right to raise any constitutional errors or deprivations other than
6 those set forth in his amended habeas petition, and the Court may dismiss any subsequent
7 petitions. 28 U.S.C. § 2244.¹

8 Petitioner should further take notice that all grounds alleged in his original Petition
9 which are not alleged in any amended petition will be waived. Hal Roach Studios v. Richard
10 Feiner & Co., 896 F.2d 1542, 1546 (9th Cir. 1990) (“an amended pleading supersedes the
11 original”); King v. Atiyeh, 814 F.2d 565 (9th Cir. 1987).

12 **V. Warnings**

13 **A. Address Changes**

14 Petitioner must file and serve a notice of a change of address in accordance with Rule
15 83.3(d) of the Local Rules of Civil Procedure. Petitioner must not include a motion for other
16 relief with a notice of change of address. Failure to comply may result in dismissal of this
17 action.

18 **B. Copies**

19 Petitioner must submit an additional copy of every filing for use by the Court. LRCiv
20 5.4. The Court may strike any filing that fails to comply with these requirements.

21 **C. Possible Dismissal**

22 Petitioner is warned that failure to timely comply with every provision of this Order,
23 including these warnings, may result in dismissal of this action without further notice. See
24

25 ¹Title 28 U.S.C. § 2244(b) states that a district court shall dismiss a claim presented in a
26 second or successive habeas corpus application under § 2254 that was not presented in a
27 prior application, except under certain circumstances. Furthermore, under 28 U.S.C.
28 § 2244(b)(3)(A), before a second or successive application is filed in the district court, the
applicant shall move in the court of appeals for an order authorizing the district court to
consider the application.

1 Ferdik v. Bonzelet, 963 F.2d 1258, 1260-61 (9th Cir. 1992) (a district court may dismiss an
2 action for failure to comply with any order of the Court).

3 **IT IS ORDERED:**

4 (1) Petitioner's Application to Proceed *In Forma Pauperis* (Doc. #3) is **granted**.


5 (2) Charles L. Ryan, Interim Director of the ADOC, is **substituted as Respondent**
6 for Dora B. Schriro pursuant to Rule 25(d) of the Federal Rules of Civil Procedure.
7 Henceforth, proceedings in this action **must be** in the name of Charles L. Ryan as
8 Respondent.

9 (3) The Petition (Doc. #1) is **dismissed without prejudice, with leave to amend**.
10 Petitioner has **30 days** from the date this Order is filed **to file** an amended petition in
11 compliance with this Order.

12 (4) **If** Petitioner fails to file an amended petition within 30 days from the filing date
13 of this Order, the Clerk of Court **must enter**, without further notice to Petitioner, a judgment
14 of dismissal of this action without prejudice.

15 (5) The Clerk of Court **must provide** Petitioner with a current, court-approved
16 form for filing a petition for writ of habeas corpus pursuant to 28 U.S.C. § 2254.

**Instructions for Filing a Petition Under 28 U.S.C. § 2254
for a Writ of Habeas Corpus by a Person in State Custody
in the United States District Court for the District of Arizona**

1. Who May Use This Form. To use this form, you must be a person who is currently serving a sentence under a judgment against you in a state court. You are asking for relief from the conviction or the sentence on the grounds that your conviction or sentence violates the United States Constitution or other federal law. You also may use this form to challenge a state judgment that imposed a sentence to be served in the future, but you must fill in the name of the state where the judgment was entered. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment. **This form should not be used in death penalty cases.** If you were sentenced to death, you are entitled to the assistance of counsel and you should request the appointment of counsel.
2. The Form. **Local Rule of Civil Procedure (LRCiv) 3.5(a) provides that habeas corpus petitions must be filed on the court-approved form.** The form must be typed or neatly handwritten. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages. The form, however, must be completely filled in to the extent applicable. You do not need to cite law. If you want to file a brief or arguments, you must attach a separate memorandum.
3. Your Signature. You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.
4. The Filing Fee. The filing fee for this action is \$5.00. If you are unable to pay the filing fee, you may request permission to proceed *in forma pauperis* by completing and signing the Application to Proceed *In Forma Pauperis* provided with the petition form. You must have an official at the prison or jail complete the certificate at the bottom of the application form. If the amount of money in your account exceeds \$25.00, you must pay the \$5.00 filing fee. LRCiv 3.5(b).
5. Original and Judge's Copy. You must send an **original plus one copy** of your petition and of any other document submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten.
6. Where to File. You should **file your petition in the division where you were convicted.** See LRCiv 5.1(b). If you are challenging a judgment of conviction entered in Maricopa, Pinal, Yuma, La Paz, or Gila County, file your petition in the Phoenix Division. If you are challenging a judgment of conviction entered in Apache, Navajo, Coconino, Mohave, or Yavapai County, file your petition in the Prescott Division. If you are challenging a judgment of conviction entered in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file your petition in the Tucson Division. See LRCiv 5.1(b) and 77.1(a).

7. Change of Address. You must immediately notify the Court and respondents in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.**

8. Certificate of Service. You must provide the respondents with a copy of any document you submit to the Court (except the initial petition and application to proceed *in forma pauperis*). Each original document (except the initial petition and application to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the respondents and the address to which it was mailed. Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. A certificate of service should be in the following form:

9. Amended Petition. If you need to change any of the information in the initial petition, you must file an amended petition. The amended petition must be written on the court-approved form. You may file one amended petition without leave (permission) of Court before any respondent has answered your original petition. See Fed. R. Civ. P. 15(a). After any respondent has filed an answer, you must file a motion for leave to amend and lodge (submit) a proposed amended petition. LRCiv 15.1. An amended petition may not incorporate by reference any part of your prior petition. LRCiv 15.1(a)(2). **Any grounds not included in the amended petition are considered dismissed.**

10. Exhibits. If available, you should attach a copy of all state and federal court written decisions regarding the conviction you are challenging. Do **not** submit any other exhibits with the petition. Instead, you should paraphrase the relevant information in the petition.

11. Letters and Motions. It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

12. Warnings.

- a. Judgment Entered by a Single Court. You may challenge the judgment entered by only one court. Multiple counts which resulted in a judgment by the same court may be challenged in the same petition. If you wish to challenge judgments entered by more than one court, however, you must file separate petitions for each judgment.
- b. Grounds for Relief. You must raise all grounds for relief that relate to this conviction or sentence. Any grounds not raised in this petition will likely be barred from being raised in any subsequent federal action.
- c. Exhaustion. In order to proceed in federal court, you ordinarily must exhaust the remedies available to you in the state courts as to each claim on which you request action by the federal court. If you did not fairly present each of your grounds to the Arizona Court of Appeals, your petition may be dismissed. If you did not present one or more of your grounds to the Arizona Court of Appeals, explain why you did not.

FINAL NOTE

You should follow these instructions carefully. Failure to do so may result in your petition being stricken or dismissed by the Court. All questions must be answered concisely in the proper space on the form. If you need more space, you may attach additional pages. But the form must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the petition is being continued and number all pages.

(C) the date on which the constitutional right asserted was initially recognized by the Supreme Court, if the right has been newly recognized by the Supreme Court and made retroactively applicable to cases on collateral review; or

(D) the date on which the factual predicate of the claim or claims presented could have been discovered through the exercise of due diligence.

(2) The time during which a properly filed application for State post-conviction or other collateral review with respect to the pertinent judgment or claim is pending shall not be counted toward any period of limitation under this subsection.
