COMPLAINANT'S STATEMENT OF FACTS CONSTITUTING THE OFFENSE OR VIOLATION:

COUNT 1: On or about May 17, 2007, at or near Douglas, Arizona, in the District of Arizona, Gustavo SEGURA-Nava, an alien, entered, and was found in the United States of America after having been denied admission, excluded, deported, and removed from the United States through San Ysidro, California on October 08, 2003, and not having obtained the express consent of the Attorney General or the Secretary of the Department of Homeland Security to reapply for admission thereto; in violation of Title 8, United States Code, Section 1326(a) and 1326 (b)(1).

COUNT 2: On or about May 16, 2007, at or near Douglas, Arizona, in the District of Arizona, Gustavo SEGURA-Nava, an alien, did unlawfully enter the United States of America from the Republic of Mexico, at a time and place other than as designated by Immigration Officers of the United States of America, in violation of Title 8, United States Code, Section 1325.

BASIS OF COMPLAINANTS CHARGE AGAINST THE ACCUSED:

Gustavo SEGURA-Nava is a citizen of Mexico. On October 08, 2003, Gustavo SEGURA-Nava was lawfully denied admission, excluded, deported, and removed from the United States through San Ysidro, California. On May 17, 2007, agents found SEGURA-Nava in the United States at or near Douglas, Arizona. SEGURA-Nava did not obtain the express consent of the Attorney General or the Secretary of DHS to re-apply for admission to the United States. Furthermore, as evidenced from his illegal presence in the United States, Gustavo SEGURA-Nava entered the United States from the Republic of Mexico, at a time and place other than as designated by Immigration Officers of the United States.
