**TO: THE DIRECTOR OF THE ARIZONA DEPARTMENT OF CORRECTIONS**

Plaintiff Arron Eugene Mowry, inmate #159208, who is confined in the Arizona State

18

Prison Complex-Eyman, must pay the statutory filing fee of \$350.00. Plaintiff must first pay

19

an initial partial filing fee of \$1.66. Thereafter, Plaintiff must pay the balance of the fee in

20

monthly payments of 20% of the preceding month's income credited to Plaintiff's trust

21

account. The Director of the Arizona Department of Corrections or his designee must collect

22

and forward these payments to the Clerk of Court each time the amount in the account

23

exceeds \$10.00.

24

**IT IS ORDERED:**

25

(1) The Director of the Arizona Department of Corrections or his designee **must**

26

**forward** to the Clerk of Court the initial partial filing fee of \$1.66. The balance of the

27

\$350.00 filing fee must be collected from Plaintiff's trust account in monthly payments of

28

20% of the preceding month's income credited to the account. Payments must be forwarded


1 to the Clerk of the Court each time the amount in the account exceeds \$10.00. The payments  
2 must be clearly identified by the name and number assigned to this action.

3 (2) The Director of the Arizona Department of Corrections or his designee **must**  
4 **notify** the Clerk of Court in writing when Plaintiff is released or transferred to a correctional  
5 institution other than the Arizona Department of Corrections, so new billing arrangements  
6 may be made to collect any outstanding balance.

7 (3) The Clerk of Court **must serve by mail** a copy of this Order on the Director  
8 of the Arizona Department of Corrections, 1601 West Jefferson, Phoenix, Arizona, 85007.

9 (4) The Clerk of Court **must forward** a copy of this Order to Financial  
10 Administration for the Phoenix Division of the United States District Court for the District  
11 of Arizona. Financial Administration must set up an account to receive payments on the  
12 filing fee for this action and must notify the Court when the filing fee is paid in full.
