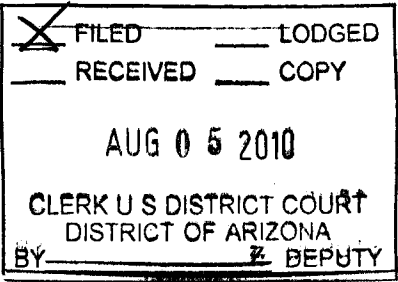

**I. PURPOSES:**

1. The purpose of this Motion is to appeal to the Court Order, issued on July 28, 2010 that did not include the areas badly effected the Joinder party, Mariette Do-Nguyen and the American public, specified on the Joinder's Motion to Join the Parties that was filed in this Court on July 19, 2010.

2. I, Mariette Do-Nguyen, as Joinder of the Parties' Motion filed in this Court specified that I and the majority of American taxpayers were victimized by a majority of the United States Federal leaders, high-ranking officials, and employees who abused their positions and authority, badly violating the United States Constitution and many Federal laws.

1                   **II. FACTS SHOWED EVIDENCE THAT THE FIRST AMENDMENT OF**  
2 **THE UNITED STATES CONSTITUTION AND CERTAIN FEDERAL LAWS**  
3 **WERE NOT ENFORCED, OR WERE INCORRECTLY ENFORCED, OR WERE**  
4 **VIOLATED, RESULTING IN A LARGE AMOUNT OF DEATHS, WOUNDS,**  
5 **EMOTIONAL SUFFERING, AND BADLY HARMING THE AMERICA**  
6 **ECONOMY.**

7                   3. Evidence shows that the United States Federal government leaders,  
8 high-ranking officials, and federal employees violated The following United  
9 States Federal laws, either by not enforcing them or by enforcing them  
10 incorrectly, or violated which caused the State of Arizona Legislative branch to  
11 pass its SB1070 Immigration Law, and is also responsible for the existence of  
12 this case and other cases in this Court.

13                   a. Title 8, Chapter 12, Subchapter I, Section 1101, Immigration and  
14 Naturalization Act.

15                   b. Title 8, Chapter 12, Subchapter II, Part VIII, Section 1324,  
16 Bringing in and harboring certain aliens.

17                   c. Title 12, Chapter 35,

18                         (1) Section 3403 (a) Confidence of financial records

19                         (2) Section 3405 Administration subpoena and summons in Right to  
20 Financial Privacy.

21                   d. Title 18, Part I, Chapter 103, Section 2113 (a) (b) (c) (f) Bank  
22 robbery and incidental crimes.

23                   e. First Amendment of the United States Constitution, protection of  
24 freedom of religion.

25                   **III. THE SECTIONS THAT BADLY INJURED THE JOINDER AND**  
26 **THE MAJORITY OF AMERICAN VOTERS/TAXPAYERS WERE NOT**  
27 **INCLUDED ON THE COURT ORDER ISSUED ON JULY 28, 2010.**

28                   4. Certain areas in the "Order" issued by this Court on July 28, 2010,  
regarding Motion for Preliminary Injunction filed by Plaintiff of the United  
States ("Pl.'s Mot.") (Dock. 27)

**A. Federal Immigration laws were not enforced, or were incorrectly  
enforced, or were violated which resulted in many serious problems for  
American taxpayers.**

5. United States Federal government leaders, high-ranking officials, and  
certain federal government employees either did not enforce or incorrectly

1 enforced laws and badly violated their authority.

2 a. Certain Federal government leaders only talk without action about  
3 securing International borders between the United States and foreign  
4 countries.

5 b. Title 8, Chapter 12, Subchapter II, Part VIII, Section 1324, Bringing  
6 in and harboring certain aliens, was not enforced or was incorrectly enforced.

7 c. Title 8, Chapter 12, Subchapter I, Section 1101, Immigration and  
8 Naturalization Act was incorrectly enforced.

9 6. The lack of and incorrect enforcement resulted in burdens on  
10 American citizens and legal immigrants, who are taxpayers who are being  
11 forced by United States presidents and legislators to pay for illegal  
12 immigrants' (who do not pay income taxes) healthcare, school expenses, law  
13 enforcement protection, and other benefits.

14 7. Several states in the Union, such as the State of California are in  
15 debt over fourteen billion dollars, and have laid off state employees, which  
16 effected California citizens high-rate unemployment, because of very high  
17 numbers of illegal immigrants who heavily contribute to the states' debts.

18 8. Citizens of both the states of California and Arizona are badly  
19 effected by high population and felony drug crimes and smuggling of illegal  
20 immigrants.

21 9. It is costly to pass the SB1070 Immigration Law, and to process this  
22 case and other cases filed in Federal courts.

23 10. People who obey Federal Immigration laws by standing in line to  
24 immigrate into the United States are punished, and illegal immigrants who  
25 violate our Federal Immigration laws are rewarded.

26 11. Federal government leaders created sanctuaries for illegal  
27 immigrants throughout the United States government leaders and high-  
28 ranking official, by intentionally failing to or incorrectly enforcing Title 8,  
Chapter 12, Subchapter II, Part VIII, Section 1324 and Title 8, Chapter 12  
Subchapter I, Section 1101, which resulted in American taxpayers being  
forced to pay for the illegal immigrants' benefits, as well as allowing illegal  
immigrants to smuggle illegal drugs and more illegal immigrants into the  
United States where many have committed other felony crimes on American  
soil.

**B. Illegal immigrants' amnesty was a violation of Federal  
Immigration laws, which led to Federal government officials wrongly  
punishing the Joinder party, Mariette Do-Nguyen, her sister, sister's  
family, and other people who stood online seek for immigrate in USA.**

2 12. The former President Ronald Regan's illegal immigrants' amnesty  
3 **put him and other leaders on this amnesty above two Federal**  
4 **Immigration laws!** It was very loud and clear that white-collar felony crimes  
5 were committed, violating Title 8, Chapter 12, Subchapter II, Part VIII, Section  
6 1324 and Title 8, Chapter 12 Subchapter I, Section 1101.

7 a. Regan's amnesty was a serious violation of the Immigration and  
8 Naturalization Act. Harboring certain aliens and creating sanctuaries for  
9 illegal immigrants have rewarded illegal immigrants for violating Federal  
10 Immigration laws.

11 b. Regan's amnesty has rewarded foreigners who violated Federal  
12 Immigration laws and entered through United States borders illegally,  
13 resulting in over thirteen million illegal immigrants living in the United States!

14 c. Regan's amnesty has punished people who stood in line to  
15 immigrate to the United States, by delaying their visas or never issuing visas  
16 for them to come to the United States. **My dearly beloved sister and her**  
17 **family are the victims of Regan's amnesty and of Federal Immigration**  
18 **workers failing to enforce or incorrectly enforcing Federal Immigration**  
19 **laws.**

20 13. My sister worked for me for years during the time I held  
21 ownership of the Linh Trang Laundry and Tailor Concessionaire, serving the  
22 Department of the Army, at Headquarter, 2D Squadron, 11<sup>th</sup> Armored Cavalry  
23 Regiment in Quang Loi, and she later worked for USARV/MACV SUPCOM in  
24 Long Binh. However, the United States Federal Immigration punished her by  
25 incorrectly handling her application for her immigration to the United States  
26 to join my children and me. Exhibit A

27 14. After the U.S. military left Vietnam, I worked as a local employee  
28 for the United States Defense Attaché Office for years before the evacuation in  
April 1975. Before my immediate supervisor, the United States Civil Services  
GS-15, Ralph Yates told me he had to leave Vietnam. He told me that I must  
take my family and leave the country right away. I asked him why I had to  
leave my country. I still remember exactly what he said to me, "If you do not  
leave early, at last you must go to the beach, and whatever you can grasp,  
wood log or anything to keep you floating, hang on to it, and wait for a United  
States ship to pick you up!" It was very frightening and I thought, "If this is  
the case, then all my four children from the age of three to twelve will surely  
die in the ocean!"

a. I decided to find out more about the location where we would be  
evacuated to. I talked to more of my co-workers who were American Civil  
Service Workers, and they told me the same thing my immediate supervisor  
told me.

1 b. I decided of find out from the top of the USAF Colonel Julian C.  
2 Johnson, Jr., Chief Logistics Branch. I used the format evacuation letter given  
3 to us, and I prepared a letter for my family, and I walked into his office for his  
4 signature. Again, I asked him for information regarding the location where  
5 they would take us. His response was exactly the same as what my immediate  
6 supervisor had given me previously.

7 c. After the most fearful three months journey of my adult life since  
8 my birth, we arrived in San Diego. Throughout this time and until these days,  
9 I dearly missed my beloved mother, my only living sister, and her children!  
10 About a year later, after I settled in San Diego, California, I received a letter  
11 from a family relative, informing me that my mother had died one day after I  
12 left Vietnam, on April 29, 1975. Then in 1981, I learned of the United States  
13 federal law allowing me to sponsor my only living sister and her family.

14 15. On March 12, 1981, I went to the office of the United States  
15 Catholic Conference, Immigration and Refugee Services, where I filled out an  
16 application (Vietnamese version) to sponsor my sister, her husband, and their  
17 children. After I became a U.S. citizen in June 1982, I informed Federal  
18 Immigration that I became a U.S. citizen, and **I received a Notice of Approval  
19 of Relative Immigrant Visa Petition, dated December 17, 1985.** Exhibit C  
20

21 a. Throughout the following years, I wrote to many Federal legislators  
22 representing the State of California and resulting in absolutely no fruit. About  
23 a year after I became disabled and left work on April 7, 1994, my sister and  
24 her husband called me from Vietnam, informing me that they received notice  
25 for an interview. I had not received anything from the Immigration  
26 Department. I think it is very logical that since I am sponsoring her and her  
27 family, it is the duty of the Immigration Department to send notice to me.  
28 Since I recently had become disabled, my income did not qualify to bring my  
sister and her family to the USA. I believed I would find a way, and after  
another year, I returned to work, planning to bring them to the USA. (At that  
time, I did not know that there could be more than one sponsor to assist with  
qualifying for financial support.)

b. Then during the year of 1998, I contacted the Orderly Departure  
Program in Bangkok, Thailand, and I received a response letter, dated  
December 16, 1998. The letter informed me that my sister's file was canceled.  
I contacted the Immigration and Naturalization Services. In its response to  
me, I was told to contact the Department of State, Visa Office in Washington. I  
spoke to Pam Lewis, who was Congressional Officer, and she told me to work  
with the people in Bangkok, Thailand.

From the day I filed my sponsoring application via the United States  
Catholic Conference, Immigration and Refugee Services for my sister to  
immigrate to the United States to the date Federal Immigration contacted her  
for the interview was 15 long years, and when the immigration office  
contacted my sister for an interview, I, the sponsor, was not notified. This

1 demonstrates that Federal Immigration officers incorrectly do their duties and  
2 mishandle their responsibilities, and the former President Ronald Reagan  
3 violated Federal Immigration laws, result of my sister, her family and I  
4 seriously injured!

4 **C. Freedom of Religion is protected in the First Amendment of the  
5 United States Constitution:**

6 "Congress shall make no law representing an establishment of  
7 religion, or prohibiting the free exercise thereof; or abridging  
8 the freedom of speech or of the press; or the right of the people  
9 peaceably to assemble, and to petition the government for a  
10 redress of grievances."

11 16. The First Amendment clearly prohibits Congress from using  
12 American taxpayer dollars for all programs that include wars that violate  
13 religious beliefs and teachings. All religions that use or are based on the Old  
14 and New Testaments of the Holy Bible know the Almighty Eternal Creator  
15 ordered humans on earth, "You shall not kill!" (Exodus 20:13). He seriously  
16 meant there is no one on earth who has the authority to kill another human  
17 being, because no one on earth has the capacity and authorization of creation  
18 of the human soul. (Without a human soul, there is absolutely no human  
19 physical body.)

20 a. Killing another human for any reason is prohibited by the Almighty  
21 Eternal Creator. This means that the states in the union are prohibited from  
22 passing laws that utilize taxpayer dollars for programs that result in death,  
23 such as war, abortion, and assisted suicide.

24 b. The result of Congress, Presidents, and the Pentagon using taxpayer  
25 dollars to fund war after war, killing millions of humans will come back upon  
26 American taxpayers and descendants from generation to generation until the  
27 full price is paid to victims. People must understand the Almighty Eternal  
28 Creator's justice for all must prevail in the end. As always, there are rewards  
and punishments for all actions—as individuals, communities, cities, groups,  
and nations of the world.

22 **D. Federal and International felony crimes have been committed  
23 of violating financial privacy, committing grand robbery, initiating  
24 scams, and providing financial support of terrorist attacks, and by former  
25 President George Walker Bush and his administration through the CIA's  
26 monitoring of overseas banking.**

27 17. The former President George Walker Bush and his administration's  
28 pro-war agenda scared my natural services will achieve peace, justice and  
prosperity; Washington's Federal government leaders would have lost their  
control over American taxpayers and global government leaders. Shortly after  
September 11, 2001, the former President George Walker Bush and his

1 Administration periodically issue "Secret Administration Subpoenas to SWIFT  
2 Corporation, authorized CIA monitors overseas robbed my four funds in  
3 foreign countries. Exhibit E.

4 18. The following were my four **genuine** funds in foreign countries'  
5 banks, and they were abducted by former President George Walker Bush and  
6 his administration's periodical "Secret" Administration Subpoenas to SWIFT  
7 Corporation, by the CIA's operatives monitoring of overseas banking.

8 a. US\$13,000,000.00 was intercepted from transfer in transit from  
9 Benin to the USA on August 30, 2004 by telex transfer. It was intercepted in  
10 Canada, demanded for anti-terrorist, drug clearance, money laundering  
11 certificate, and VAT charges. After all required documents were provided and  
12 VAT charges were paid, CIA operatives illegally handed the fund and its  
13 interest, totaling US\$26,000,000.00 official bank draft to Canada's border  
14 customs inspection department. Canada's Border Customs and Revenue  
15 department illegally withheld the original bank draft sent to me and a copy of  
16 the bank notice of the Canada non-resident taxes due \$34,575.00. Then, as a  
17 result, CIA overseas banking operatives illegally handed this fund over to  
18 ECOWAS in Ghana. The US\$13,000,000.00 and its interest is part of the  
19 US\$455,000,000.00 indicated in the Bond Certificate, issued by Benin Inland  
20 Revenue. Exhibit F

21 b. US\$200,000,000.00 was a balance of my account with Financial  
22 Bank Benin in Benin, with assistance of International Finance Corporation,  
23 its employee Gillis Galuduc, and their lawyer, Jessica S. Parise of Fulbright &  
24 Jaworski L.L.P, New York office, and New York government authorities. CIA  
25 overseas banking operatives illegally halted the fund to ECOWAS Ghana. The  
26 US\$200,000,00.00 and its interest is part of the US\$455,000,000.00 in the  
27 Bond Certificate, issued by Benin Inland Revenue. Exhibit G

28 c. US\$10,600,000.00 was a donation from a sinner before his death in  
Ghana. The donor of the fund requested the fund for the benefit of ending  
wars, help orphans children and poverty. In March 2003, the fund was sent  
by telex transfer from Ghana to the USA via Barclays Bank Plc in London. I  
was notified by Barclays Bank Plc London that the fund was (illegally)  
intercepted and has been withheld since. I have attempted to get it transferred  
to the USA and credited to my bank account for years, and all my efforts have  
been rejected because the CIA monitors overseas banking and has refused to  
return my money to me. Exhibits H

d. The 25,000,000.00 British Pound was in custody of Barclays Bank  
Plc London. The transaction was handled by Home Mortgage Loan Banking, a  
division of Barclays Bank Plc. It was illegally halted by CIA operatives that  
monitor oversea banking. Exhibit I

e. June 2008, I received notice from ECOWAS Benin's Debt Recovery  
Committee that informed me of my two funds (US\$26,000,000.00 &

1 US\$200,000,000.00) from International Monetary Fund (IMF). As a result, in  
2 November 2008, ECOWAS Ghana informed me of my US\$455,000,000.00  
withheld in ECOWAS Ghana custody. Exhibit K

3 f. After I complied with ECOWAS Ghana requirement of a Bond  
4 Certificate from Benin Inland Revenue was fulfilled, CIA monitors overseas  
5 banking, together with ECOWAS attempted to issue fraudulent documents, so  
6 that I who am innocent would be arrested by the FBI, so that no one can  
7 claim my US\$455,000,000.00, and for them to use my money to fund waves of  
attacks on American soil. Base on evidences I received, the  
8 US\$455,000,000.00 currently is illegally withheld by World Link Security  
9 Ghana. Exhibits L, M.

10 g. Illegal interception, hiding four funds, and handing it over to  
International felony criminals were violations of financial privacy and grand  
11 robbery, indicated in the Ninth Amendment of the United States Constitution  
and the following Federal laws:

12 (1). Title 12, Chapter 35,

13 (a) Section 3403 (a) Confidentiality of financial records

14 (b) Section 3405 Administration subpoena and summons in Right to  
Financial Privacy.

15 (2). Title 18, Part I, Chapter 103, Section 2113 (a) (b) (c) (f) Bank  
16 Robbery and incidental crimes.

17 (3). Ninth Amendment of the United States Constitution: "The  
18 enumeration in the Constitution of certain rights shall not be construed to  
deny or disparage others retained by the people."

19 19. Besides illegally moving my four funds around in foreign  
20 countries, the last evidence shows that they handed my two funds in Benin  
21 over to terrorists, robbers, and scammers. Evidence shows that CIA monitors  
22 of overseas banking attempted to scam US\$19,310.00 by issuing fake  
documents for the FBI to arrest me and put me in prison, in order for  
terrorists to use my funds to pay for an attack on America soil. Exhibits N

23 20. I went to the FBI building in San Diego, met with an Intake Agent,  
24 and filed a federal crime complaint. There were two FBI agents who contacted  
25 me; the first FBI agent was the result of my complaint with the U.S. Embassy.  
26 He called me twice, once from an FBI office phone number and another time  
27 from his cell phone. He left a message, and I called him back, but he was  
28 afraid to give me his full name. The second FBI Agent came to my residence  
twice as a result of my emails to the FBI, reporting of terrorists' plans of  
attack on America soil. The first time this agent came, I was not at home. The  
second time was an appointment. After I gave him federal and international

1 felony crime evidence, as well as shared with him verbally, he said to me two  
2 or three times, "We will investigate." Since this meeting of February 24, 2010  
3 and as of today, I have not received a written response or case number from  
4 him. The last time I spoke to him was on June 22, 2010. I asked him to  
5 transfer to me my funds originating from Benin, that the CIA agents that  
6 monitor overseas banking illegally handed over to ECOWAS Ghana. The FBI  
7 agent said to me, "**It involves many agencies, and they do not pay for me**  
8 **to do that work!**" My understanding of his words is that he does not have the  
9 authority to perform that kind of work, because I already hear from the  
10 following sources: In response to my complaint and request for Federal  
11 congressional assistance, Senator Dianne Feinstein's worker in her San  
12 Francisco office yelled at me on the telephone, saying to me, "The Federal  
13 government cannot help you!" Senator Barbara Boxer did not respond to me.  
14 Congressman Brian Bilbray's office told me that Congressman Bilbray could  
15 not help me.

16 These are evidence showing that a felony crime has been committed by  
17 the United States former Commander-In-Chief to the CIA agency and bankers,  
18 while Federal legislatives, the U.S. office of Ethics, and the FBI are protecting  
19 the Commander-In-Chief and the CIA, and federal and International felony  
20 crimes of grand robbery and handed my money to terrorists, for purposes of  
21 fund attacks on America soil.

#### 22 **IV. IT IS THIS COURT'S DUTY AND RESPONSIBILITY TO** 23 **ENFORCE THE UNITED STATES CONSTITUTION'S FIRST AMENDMENT** 24 **AND FEDERAL LAWS.**

25 21. The United States of America has hundreds of thousands or  
26 millions of legislative laws on the books! While based on the facts, the First  
27 Amendment of the United States Constitution and many Federal laws have  
28 been badly violated by Federal government leaders and high-ranking officials.  
In addition, Federal government leaders and high-ranking officials illegally  
forced Federal employees, American citizens, and legal immigrants to violate  
these laws along with them. Therefore, **it is the duties of this United States**  
**District Court to enforce freedom of religion protect in the First**  
**Amendment of the United States Constitution, and Federal laws badly**  
**violated that complaint in this complaint.**

#### 29 **V. CONCLUSION:**

30 22. The actions of making laws that contradict the United States  
31 Constitution and Federal Laws that are on the books are prohibited!  
32 Legislatives, presidents, and governors who passed laws, including executive  
33 orders that work against the Constitution and laws on the books have violated  
34 the laws!

1 23. Former President Ronald Regan's amnesty was a serious violation  
2 of the Federal Immigration laws.

3 24. Former president George Walker Bush's periodical secret  
4 subpoenas to SWIFT Corporation violated Title 12, Chapter 35, (1) Section  
5 3403 (a) Confidentiality of financial records, and (2) Section 3405  
6 Administration subpoena and summons in the Right to Financial Privacy.

7 25. The CIA operatives that monitor overseas banking illegally halted  
8 the Joinder Party's four funds, and they have hidden them from me and  
9 handled them over to ECOWAS Ghana, which violated d. Title 18, Part I,  
10 Chapter 103, Section 2113 (a) (b) (c) (f) Bank Robbery and incidental crimes.

11 26. Taxpayers' dollars have funded war, and the result is the killing of  
12 human lives, wounding of human bodies, and destroying of structures and  
13 these are violations of freedom of religion of taxpayers whose religion is based  
14 on the Bible, both Old and New testaments.

15 27. It is the duty and responsibility of law enforcement officials and  
16 various levels of Federal courts to enforce ALL the existing laws on the books!

17 28. It is also the duty and responsibility of various Federal courts to  
18 issue correct ORDERS and to repair and pay in full damages to Federal crime  
19 victims, due to crimes committed by various levels of the Federal  
20 government's employees.

## 21 **VI. REQUEST THIS COURT FOR ITS ORDER**

22 A. As joinder of parties of this case 10 cv 1413 SRB, the Almighty  
23 Eternal Creator's Messenger of the Covenant, U.S. citizen, and federal crime  
24 victim, I sincerely and urgently request this Court to exercise its full  
25 AUTHORITY, and IMMEDIATELY issue a clear ORDER to enforce the following  
26 United States Federal laws and Constitution:

27 a. Title 8, Chapter 12, Subchapter I, Section 1101, Immigration and  
28 Naturalization Act, and
