**STIPULATION REGARDING TIME
FOR DEFENDANTS TO RESPOND
TO COMPLAINT**

(First Request)

23 Pursuant to LRCiv 7.3, defendants State of Arizona and Janice K. Brewer and
24 plaintiff United States of America jointly stipulate and request that the Court extend the
25 time for defendants to respond to the operative complaint in this action.

26 On December 10, 2010, the Court issued an order (doc. 133) granting in part and
27 denying in part defendants’ motion to dismiss. In the order, the Court granted plaintiff 30
28 days from the date of the order “to file any amended Complaint.” Accordingly, the

1 deadline for plaintiff to file any amended complaint is January 10, 2011.

2 The parties agree that defendants should have a similar amount of time following
3 January 10, 2011 to file a response to the operative complaint. Accordingly, the parties
4 stipulate and request that the deadline for defendants to respond to the complaint should
5 be extended to February 11, 2011. A proposed order is submitted herewith.
