

I. THE SPETH - MAGEDSON - CONNECTION

On March 24th 2004, William O. Boyd and Brenda S. Boyd executed a warranty deed to the entity **UNKLE ASSETS INVESTMENT LIMITED PARTNERSHIP**, an Arizona Limited Partnership.

On November 27th 2004, an entity known as **UNKLE ASSETS INVESTMENT LIMITED PARTNERSHIP**, an Arizona Limited Partnership, with an address of P.O. Box 31288, Mesa Arizona 85213 executed a note and deed of trust to the benefit of **INTERACTIVE REASONING INC. 401(k) PLAN** in the principal amount of \$105,000.00.

This instrument was executed by Maria Crimi Speth and John F. Goodson on Behalf of **UNKLE ASSETS INVESTMENT LIMITED PARTNERSHIP**.

On May 7th 2009, **POND INVESTMENTS LIMITED PARTNERSHIP** executed a special warranty deed and transferred title to LOT 15, THE LINKS AT ALTA MESA, ACCORDING TO BOOK 276 OF MAPS, PAGE 35, RECORDS OF MARICOPA COUNTY, ARIZONA to non party - James Kessler.

The aforesaid special warranty deed was executed by Ed Magedson acting as an Attorney in Fact for David J. Bedore the listed President of **CREATIVE BUSINESS INVESTMENT CONCEPTS, INC.**

POND INVESTMENTS LIMITED PARTNERSHIP according to the aforementioned Special Warranty Deed; acquired title as **UNKLE ASSETS INVESTMENT LIMITED PARTNERSHIP.**

DESERT PROPERTIES LLC holds title to 15821 East Jericho in Fountain Hills Arizona 85268. This is the covert address that the criminal enterprise of RipoffReport.com and Ed Magedson is physically located.

All of the aforementioned facts are supported by public documents and are incorporated herein by reference for all intents and purposes.

A former insider and Counter Plaintiff Witness had worked for Ed Magedson for (10) years, was recently fired and now states that Magedson told him to write up fake ripoff reports, create fake Yahoo email accounts and perform multiple clicks on the ROR complaints that he authored from a wireless Kinko's account in Phoenix Arizona.

Multiple recorded telephone conversations between Richeson and Rogers are incorporated herein by reference for all intents and purposes.

Upon information and belief, Maria Crimi Speth and Ed Magedson are in fact the controlling partners of the criminal enterprise known as RipoffReport.com.

Upon information and belief, Ed Magedson is the lightning rod, straw man and judgment proof partner in the criminal enterprise known as RipoffReport.com.

II. CAUSE OF ACTION
RICO 18 U.S.C.A § 1961 ET SEQ.

Maria Speth, Ed Magedson and the Firm of jaburg and Wilk P.C. have conspired and engaged in a racketeering, and extortion scheme in violation of the *federal Racketeer Influenced and Corruption Organizations Act (RICO), (18 U.S.C.A. § 1961 et seq. [1970])*.

The damages caused by the Cross Defendants Racketeering scheme exceed \$75,000 and are within the jurisdictional limits of this Court.

Congress enacted the Racketeer Influenced and Corrupt Organizations Act, 18 U.S.C. §§ 1961-1968 ("RICO") in 1970 to eradicate organized crime in the United States. To that end, RICO imposes severe criminal penalties on any individual or entity that engages in "racketeering activity," which is broadly defined to include an extensive list of actionable predicate acts, including mail and wire fraud. 18 U.S.C. § 1961(1).

RICO also provides a private right of action for treble damages in favor of any person "injured in his business or property by reason of" a RICO violation. 18 U.S.C. § 1964(c).

The Cross Defendants use an internet web site to post false or inflated consumer complaints posing as a legitimate consumer hiding among real consumers. This is a RICO predicate act.

The Cross Defendants then enlist the power of the search engines to quickly propagate the damage they create to a world wide level. This is also RICO predicate act.

The Cross Defendants then utilize surrogates to enter responses to the complaints that the Cross Defendants create to entice Google, Yahoo, and Bing to heighten the relevance of the search results. This is also RICO predicate act.

The Counter Plaintiff Richeson has amassed a significant sum of prima facie evidence to support the undisputable fact that Maria Speth and Ed Magedson in conspiracy with the law firm of Jaburg and Wilk P.C. have used a web site as an extortion device and are guilty of the criminal offence of the Racketeer Influenced and Corrupt Organizations Act, 18 U.S.C. §§ 1961-1968 ("RICO") in 1970 beyond any reasonable doubt.

The Plaintiff is only burdened with proof by preponderance of the evidence and can easily establish his cause of action under 18 U.S.C. § 1964(c)

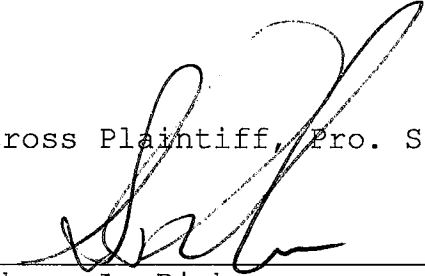
Wherefore, premises considered, the Cross Plaintiff respectfully prays that upon final trial the Cross Plaintiff have:

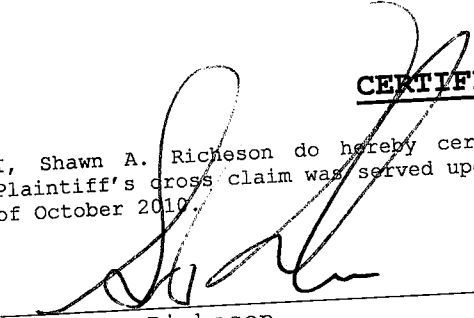
