

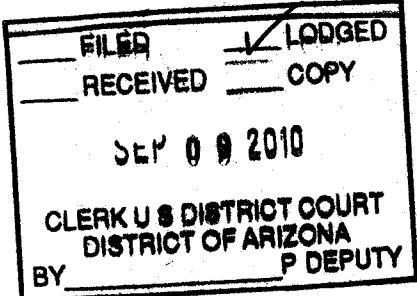

**DECLARATION OF MARIA CRIMI
SPETH**

I, Maria Crimi Speth, declare as follows:

1. My name is Maria Crimi Speth. I am a resident of the State of Arizona, am over the age of 18 years, and if called to testify in court or other proceeding I could and would give the following testimony which is based upon my own personal knowledge.

2. I am an attorney at Jaburg & Wilk, P.C.

3. Jaburg & Wilk has represented Xcentric Ventures, LLC in various matters for the past seven years. Xcentric Ventures operates www.ripoffreport.com (Ripoff Report).

4. Approximately a week ago Shawn Richeson called me at my office. He said that he knew Ripoff Report removed a report for someone else and that Ripoff Report needed to do

1 the same for him. I told him that he was mistaken and that Ripoff Report does not remove
2 reports. When he told me the name of the person who the report was about, I explained that the
3 report had not been removed but the person's name was redacted from the posting by Ripoff
4 Report. I explained that the reason for the redaction was that the posting accused that person of
5 molesting a child. I explained that Ripoff Report has a policy to remove the name of someone
6 accused of a violent crime or child molestation unless there was a police report or criminal record
7 to support the accusation.

8 5. Between Friday, September 3, 2010, and Monday, September 6, 2010, I received
9 32 emails from Shawn Richeson demanding changes be made to postings about him on Ripoff
10 Report.

11 6. Mr. Richeson first demanded that his last name, "Richeson," and his company
12 name, "clickanerd.com" be removed from two identified URLs on Ripoff Report.

13 7. Mr. Richeson urged me to "think this through and evaluate whats [sic] at risk very
14 carefully." He stated that he had pulled the criminal records of David Gingras, in-house counsel
15 for Xcentric Ventures and former attorney for Jaburg & Wilk (the "firm"), and posted about Mr.
16 Gingras and Jaburg & Wilk on his website. (See Ex. 1 - email of September 3, 2010 1:08 PM).

17 8. Mr. Richeson then launched a person attack on Mr. Gingras by posting statements
18 to several internet site in which he falsely labeled Mr. Gingras as a "child molester." (See Ex. 2 -
19 email of September 3, 2010 2:13 PM regarding a posting to jaburg-and-
20 wilk.pissedconsumer.com; Ex. 3 - email of September 3, 2010 2:24 PM regarding similar posting
21 to www.seomoz.org and in which he states "This info is going virul [sic]...Damn dirt sells"; Ex.
22 4 - email of September 3, 2010 2:35 PM regarding similar posting to www.clickanerd.com).

23 9. I requested that Mr. Richeson stop making such postings and discuss the matter
24 with me instead. (See Ex. 5 - email of September 3, 2010 2:35 PM).

25 10. Mr. Richeson then called my office but did not speak with me because I was on the
26 telephone with a client. (See Ex. 6 - emails of September 3, 2010 2:48 PM and 4:53 PM).

27 11. Mr. Richeson then sent an email detailing his extortion. He said he would remove
28 the postings he had made about Mr. Gingras and Jaburg & Wilk if his demands were met,

1 claiming he would otherwise file a “lay down slam dunk mother fucker” law suit in Maricopa
2 County and send his “internet gurus back the grind digging into all of [the firm’s] employees,
3 clients[,] etc.” to ensure the firm “couldn’t get a client if they [sic] stood on the corner with a sign
4 saying ‘we sue for food’.” (See Ex. 6 - email of September 3, 2010 4:17 PM).

5 12. I informed Mr. Richeson that despite the assertions made in his various postings,
6 Mr. Gingras was not a child molester and never had been; rather, when he was in his early
7 twenties he had a girlfriend who was seventeen years old and her parents pressed charges against
8 Mr. Gingras that were ultimately dismissed. (See Ex. 7 - emails of September 3, 2010 8:33 PM
9 and 7:41 PM).

10 13. Mr. Richeson responded that it did not matter to him that the charges were
11 dismissed against Mr. Gingras and challenged the firm to “deal with the political fallout” then sue
12 him, but that in any case the report will have gone viral by the coming Monday. (See Ex. 7 -
13 email of September 3, 2010 7:41 PM).

14 14. Later that same evening, Mr. Richeson forwarded yet another link to an internet
15 site wherein he again falsely labeled Mr. Gingras a child molester. (See Ex. 8 - email of
16 September 3, 2010 9:24 PM and posting on cmtracker.wordpress.com/2010/09/04/david-gingras).

17 15. The following morning, which was this past Saturday, he continued his barrage of
18 emails by sending me links to a number of websites with similar postings about Mr. Gingras; (See
19 Ex. 9 - email of September 4, 2010 9:19 AM; Ex. 10 - email of September 4, 2010 9:24 AM; Ex.
20 11 - email of September 4, 2010 10:47 AM; Ex. 12 - email of September 4, 2010 10:57 AM; Ex.
21 13 - email of September 4, 2010 11:29 AM).

22 16. Just thirty minutes later, he claimed he would “have all of [our] clients criminal
23 records soon”; he augmented his claim with statements such as “no turning back now,” “you may
24 want to run over to federal court and snag an emergency TRO,” and “cant [sic] wait to see you in
25 court dear.” (See Ex. 13 - email of September 4, 2010 11:29 AM).

26 17. His attacks then turned on me personally when he stated his “Indian friends just
27 got to work a few minutes ago and they do work cheap. They found something about you being
28

1 cited by the city of Phoenix for some sort of property violation. I imagine it's trivial, but sounds
2 important to us." (See Ex. 14 - email of September 4, 2010 1:35 PM).

3 18. He also reiterated his intent to search records relating to the firm's employees,
4 family members and clients and listed four of the firm's major clients by name, threatening to
5 make statements about each that were "unflattering, humiliating and very public" and further
6 claiming that his "desire to settle [was] fading as [his] excitement in this project increases." (See
7 *Id.*).

8 19. Mr. Richeson continued his tirade claiming that "before the weeks [sic] out,
9 operation 'ass slam jaburg and wilk' will be a huge success." (See Ex. 15 - email of September 4,
10 2010 2:23 PM).

11 20. At this point I informed Mr. Richeson that Mr. Magedson (the Manager of
12 Xcentric Ventures) was considering his demands but needed time to confer with counsel. (See *Id.*
13 at 3:31PM.).

14 21. Mr. Richeson responded stating, "in the spirit of fair competition, [he] would give
15 [me] 20 minutes to fix" the two postings. (See *Id.* At 2:23PM).

16 22. After conferring with Mr. Magedson, the Killeen Texas police department, the
17 Phoenix City Police department, and separate counsel for Xcentric Ventures, I informed Mr.
18 Richeson that Ripoff Report was in the process of removing both "Richeson" and
19 "clickanerd.com" from the identified URLs. (See Ex. 16 - email of September 4, 2010 5:13 PM).

20 23. Mr. Richeson then stated that "when it's down, your stuff is down." (See *Id.* at
21 3:21 PM).

22 24. He soon thereafter removed the all of his postings. (See Ex. 17 - email of
23 September 4, 2010 3:37 PM; Ex. 18 - email of September 4, 2010 4:16 PM; Ex 19 - email of
24 September 4, 2010 5:00 PM).

25 25. I believed the matter was temporarily resolved and logged off email for the
26 remainder of the holiday weekend.

1 26. Despite understanding that this would conclude the matter, Mr. Richeson then
2 requested an additional posting be amended to remove “Richeson” and “clickanerd.com.” (See
3 Ex. 19 - email of September 4, 2010 5:00 PM).

4 27. Less than one hour later, Mr. Richeson requested two posts be amended to remove
5 “Richeson” and “clickanerd.com” and claimed “I will quit bothering you this weekend.” (See
6 Ex. 20 - email of September 4, 2010 5:56 PM).

7 28. On Sunday morning, Mr. Richeson again emailed demanding that his name be
8 removed from additional postings. (See Ex. 21 - email of September 5, 2010 9:57 AM).

9 29. Again, less than one hour later, he emailed me stating: “WTF: Are you going to fix
10 this or not?” (See Ex. 22 - email of September 5, 2010 10:34 AM).

11 30. When I did not respond by mid-day Sunday, he emailed me stating, “Avoiding my
12 calls is not smart....Pissing me off is not smart. If you are jerking me off to get through the
13 weekend, I can promise you, you will lose in ways you never dreamed of. Keep your word and
14 fix these posts, or Find out just how far I am willing to take this matter.” (See Ex. 23 - email of
15 September 5, 2010 12:21 PM).

16 31. By Sunday evening, when he was unable to reach me, he emailed me to say he was
17 “unable to evaluate where we were at if [I] ignore [him].” (See Ex. 24 - email of September 5,
18 2010 7:30 PM).

19 32. When I had not responded by Sunday night, he reactivated
20 www.jaburgandwilksucks.com. (See Ex. 25 - email of September 5, 2010 10:56 PM).

21 33. Monday afternoon, he suggested we “let the games begin” and warned not to
22 “attempt an Ex Parte TRO Or I am moving for sanctions.” (See Ex. 26 - email of September 6,
23 2010 3:29 PM).

24 34. He also updated information about Mr. Gingras on the
25 www.jaburgandwilksucks.com website. (See Ex. 27 - email of September 6, 2010 4:08 PM).

26 35. Shortly thereafter, he emailed all the partners in the firm stating:

27 I promise and swear to god as my judge, I will not let you get away
28 with this and the only non paying, time consuming and emotionally

1 draining case you and your firm will be in for the next 3 years is
2 jaburg v richeson v Speth v Magedson.

3 Every lawyer, paralegal and client you have will see all of their
4 criminal records and any other unflattering piece of dirt that exists
5 out there on the web right in the center of the Google and Yahoo
6 search results.

7 You have fucked with the wrong hombre folks.

8 (See Ex. 28 - email of September 6, 2010 4:31 PM).

9 36. This was followed by an invitation to comment on a case filed in Phoenix
10 Municipal Court involving another attorney employed by Jaburg & Wilk (a speeding
11 ticket) (See Ex. 29 - email of September 6, 2010 4:57 PM).

12 37. Late Monday night, Labor Day, I checked my email in preparation for the
13 next day's business to find all of Mr. Richeson's communications.

14 38. I informed him that I had believed the matter to be concluded on Saturday
15 and had not been online after that time due to the holiday weekend in order to spend time
16 with my family. (See Ex. 30 and 31 - emails of September 6, 2010 11:12 PM and 9:40 PM).

17 39. Nonetheless, I agreed to contact Mr. Magedson and inform him that Mr.
18 Richeson had made additional demands. (See *Id.*)

19 40. In response, Mr. Richeson agreed he would get "out of [my] hair" and
20 disable the www.jaburgandwilksucks.com website in return for the additional
21 amendments. (See Ex. 30 - email of September 6, 2010 9:30 PM; Ex. 32 - email of September 6,
22 2010 10:16 PM).

23 41. In addition to all of the emails, Mr. Richeson called my home three times
24 over the holiday weekend. He left the following message on my family answering
25 machine: "Hi, this is Rich with Click A Nerd. I was calling you back [inaudible] your
26 computer problem. You can give us a call us back at 254-247-3241 if you still have any
27 computer problems. Thank you and have a great day." He also called and spoke to my
28 husband. He told my husband he was calling back from Click A Nerd because someone

1 called him about a computer problem. The last telephone call at my home was at 10:45
2 PM on labor day. I answered the telephone call, Mr. Richeson identified himself, and I
3 told him to never call my home again and hung up on him.

4 42. He claimed to be trying to reach me by phone to “prevent a lag in
5 communications...[and] settle this matter.” (See Ex. 33 - email of September 6, 2010 11:12
6 PM).

7 43. I responded by email with a requested that he never call my home again and
8 informed him that Xcentric was having the final amendments made. (See Ex. 34 - email of
9 September 7, 2010 12:30 AM).

10 44. Xcentric has informed me that it made the decision to remove Richeson’s
11 name from Ripoff Report only long enough to get through the holiday weekend and allow
12 itself and Jaburg & Wilk the opportunity to get to Court.

13 45. Xcentric is strongly opposed to the removal of truthful content from Ripoff
14 Report.

15 46. Xcentric’s position is that negotiation with someone who is threatening and
16 harming Xcentric will lead to threats and harm by others.

17 47. Xcentric made the difficult decision to remove the content demanded by
18 Defendant Richeson only until a temporary restraining order could be obtained and only
19 to avoid the serious irreparable harm that was occurring over the holiday weekend.

20 48. Xcentric feels compelled to restore the posting to its original version and
21 indicated that it would do so by September 7, 2010. Xcentric then agreed to extend that
22 deadline because it was not possible to file all of the necessary paperwork by September
23 7, 2010.

24 49. Once Xcentric restores the posting to its original version, it is virtually
25 certain that, absent an injunction, Richeson will resume his harassment, defamation, and
26 other wrongful acts.

27 50. Absent the issuance of the requested injunctive relief, irreparable harm is
28 likely to occur at the hands of Defendant Richeson.

1 51. Pursuant to Rule 65(b)(1), notice has not has been given to Defendant
2 Richeson of the pendency of this Application because Plaintiffs will suffer immediate and
3 irreparable injury if injunctive relief is not granted prior to Defendant Richeson's
4 appearance before this Court.

5 52. Notice should not be required because Defendant Richeson has specifically
6 threatened, "By the time you get an emergency TRO filed on Tuesday, this baby will have
7 hit the 10K IP pull range."


8 53. If notice is given before a restraining order is issued, Richeson will make
9 every possible effort to inflict the maximum amount of damage on Plaintiffs before he is
10 restrained from doing so.

11 54. Thus, pursuant to Rule 65(b)(1), notice should not be required to Defendant
12 Richeson prior to the entry of the injunctive relief requested herein.

13 I declare under penalty of perjury that the foregoing is true and correct.
