I. Background

On November 16, 2010, Plaintiff Steven James Budge, who is confined in the Maricopa County Lower Buckeye Jail, filed a *pro se* civil rights Complaint pursuant to 42 U.S.C. § 1983 and an Application to Proceed *In Forma Pauperis*. In a November 24, 2010 Order, the Court granted the Application to Proceed and dismissed the Complaint, with leave to amend, because Plaintiff had failed to state a claim. The Court gave Plaintiff 30 days to file an amended complaint that cured the deficiencies identified in the Order.

On December 10, 2010, Plaintiff filed a “Motion for 30 Day Continuance of Possible Dismissal Date.” In a December 14, 2010 Order, the Court granted Plaintiff’s Motion and gave Plaintiff an additional 30 days within which to file an amended complaint. The Court informed Plaintiff that the Clerk of Court would enter a judgment of dismissal of the action if Plaintiff failed to file an amended complaint within 30 days.

On December 14, 2010, Plaintiff filed a Notification of Change of Address, indicating that he was no longer confined. Plaintiff, however, did not file an amended complaint within

1 30 days of the Court's December 14, 2010 Order. Therefore, the Clerk of Court entered
2 Judgment on January 27, 2011. That same day, Plaintiff filed a "Motion to Extend Amended
3 Complaint."

4 In a February 8, 2011 Order, the Court vacated the Judgment, granted the "Motion to
5 Extend Amended Complaint," and gave Plaintiff an additional 30 days within which to file
6 an amended complaint. The Court noted that no further extensions of that deadline would
7 be granted. In addition, because Plaintiff was no longer confined, the Court ordered Plaintiff
8 to either pay the balance of the filing fee or file a Response that stated the date of Plaintiff's
9 release and that either promised to pay the unpaid balance of the filing fee within 120 days
10 from the date of his release **or** showed good cause why he could not pay the outstanding
11 balance of the filing fee.

12 On February 23, 2011, Plaintiff filed a Motion to Extend Filing Fee, requesting an
13 extension of time to pay the filing fee because he had "been placed back into jail." In a
14 March 7, 2011 Order, the Court granted Plaintiff's Motion to Extend Filing Fee and issued
15 a separate Order requiring the appropriate government agency to collect and forward the fee
16 payments according to the statutory formula.

17 On March 8, 2011, Plaintiff filed his First Amended Complaint (Doc. 18).

18 **II. First Amended Complaint not on Court-Approved Form**

19 Local Rule of Civil Procedure 3.4(a) requires in part that "[a]ll complaints and
20 applications to proceed in forma pauperis by incarcerated persons shall be signed and legibly
21 written or typewritten on forms approved by the Court and in accordance with the
22 instructions provided with the forms." Plaintiff's First Amended Complaint is not on a court-
23 approved form as required by Local Rule of Civil Procedure 3.4(a). Plaintiff's First
24 Amended Complaint will therefore be dismissed without prejudice, with leave to amend, in
25 order for Plaintiff to file a second amended complaint on a court-approved form.

26 Within 30 days, Plaintiff may submit a second amended complaint on a court-
27 approved form. The Clerk of Court will mail Plaintiff a court-approved form to use for filing
28 a second amended complaint. If Plaintiff fails to use the court-approved form, the Court may

1 strike the second amended complaint and dismiss this action without further notice to
2 Plaintiff.

3 Plaintiff must clearly designate on the face of the document that it is the “Second
4 Amended Complaint.” The second amended complaint must be retyped or rewritten in its
5 entirety on the court-approved form and may not incorporate any part of the original
6 Complaint or First Amended Complaint reference. Plaintiff may include only one claim per
7 count.

8 A second amended complaint supersedes the original Complaint and First Amended
9 Complaint. Ferdik v. Bonzelet, 963 F.2d 1258, 1262 (9th Cir. 1992); Hal Roach Studios v.
10 Richard Feiner & Co., 896 F.2d 1542, 1546 (9th Cir. 1990). After amendment, the Court will
11 treat the original Complaint and First Amended Complaint as nonexistent. Ferdik, 963 F.2d
12 at 1262. Any cause of action that was raised in the original Complaint or First Amended
13 Complaint is waived if it is not raised in a second amended complaint. King v. Atiyeh, 814
14 F.2d 565, 567 (9th Cir. 1987).

15 **III. Warnings**

16 **A. Release**

17 Plaintiff must pay the unpaid balance of the filing fee within 120 days of his release.
18 Also, within 30 days of his release, he must either (1) notify the Court that he intends to pay
19 the balance or (2) show good cause, in writing, why he cannot. Failure to comply may result
20 in dismissal of this action.

21 **B. Address Changes**

22 Plaintiff must file and serve a notice of a change of address in accordance with Rule
23 83.3(d) of the Local Rules of Civil Procedure. Plaintiff must not include a motion for other
24 relief with a notice of change of address. Failure to comply may result in dismissal of this
25 action.

1 **C. Copies**

2 Plaintiff must submit an additional copy of every filing for use by the Court. See
3 LRCiv 5.4. Failure to comply may result in the filing being stricken without further notice
4 to Plaintiff.

5 **D. Possible “Strike”**

6 Because the original Complaint was dismissed for failure to state a claim, if Plaintiff
7 fails to file a second amended complaint correcting the deficiencies identified in the
8 November 24, 2010 Order and this Order, the dismissal may count as a “strike” under the “3-
9 strikes” provision of 28 U.S.C. § 1915(g). Under the 3-strikes provision, a prisoner may not
10 bring a civil action or appeal a civil judgment *in forma pauperis* under 28 U.S.C. § 1915 “if
11 the prisoner has, on 3 or more prior occasions, while incarcerated or detained in any facility,
12 brought an action or appeal in a court of the United States that was dismissed on the grounds
13 that it is frivolous, malicious, or fails to state a claim upon which relief may be granted,
14 unless the prisoner is under imminent danger of serious physical injury.” 28 U.S.C.
15 § 1915(g).

16 **E. Possible Dismissal**

17 If Plaintiff fails to timely comply with every provision of this Order, including these
18 warnings, the Court may dismiss this action without further notice. See Ferdik, 963 F.2d at
19 1260-61 (a district court may dismiss an action for failure to comply with any order of the
20 Court).

21 **IT IS ORDERED:**


22 (1) The First Amended Complaint (Doc. 18) is **dismissed** for failure to file on a
23 court-approved form. Plaintiff has **30 days** from the date this Order is filed to file a second
24 amended complaint in compliance with this Order and the November 24, 2010 Order.

25 (2) If Plaintiff fails to file a second amended complaint within 30 days, the Clerk
26 of Court must, without further notice, enter a judgment of dismissal of this action with
27 prejudice that states that the dismissal may count as a “strike” under 28 U.S.C. § 1915(g).

1 (3) The Clerk of Court must mail Plaintiff a court-approved form for filing a civil
2 rights complaint by a prisoner.

Instructions for a Prisoner Filing a Civil Rights Complaint in the United States District Court for the District of Arizona

1. **Who May Use This Form.** The civil rights complaint form is designed to help incarcerated persons prepare a complaint seeking relief for a violation of their federal civil rights. These complaints typically concern, but are not limited to, conditions of confinement. **This form should not be used to challenge your conviction or sentence.** If you want to challenge a state conviction or sentence, you should file a petition under 28 U.S.C. § 2254 for a writ of habeas corpus by a person in state custody. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment.
2. **The Form.** **Local Rule of Civil Procedure (LRCiv) 3.4(a) provides that complaints by incarcerated persons must be filed on the court-approved form.** The form must be typed or neatly handwritten. The form must be completely filled in to the extent applicable. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages, **but no more than fifteen additional pages**, of standard letter-sized paper. You must identify which part of the complaint is being continued and number all pages. If you do not fill out the form properly, you will be asked to submit additional or corrected information, which may delay the processing of your action. You do not need to cite law.
3. **Your Signature.** You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.
4. **The Filing Fee.** The filing fee for this action is \$350.00. If you are unable to immediately pay the filing fee, you may request leave to proceed *in forma pauperis*. Please review the “Information for Prisoners Seeking Leave to Proceed with a (Non-Habeas) Civil Action in Federal Court *In Forma Pauperis* Pursuant to 28 U.S.C. § 1915” for additional instructions.
5. **Original and Judge’s Copy.** You must send an **original plus one copy** of your complaint and of any other documents submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten.
6. **Where to File.** You should file your complaint in the division **where you were confined when your rights were allegedly violated.** See LRCiv 5.1(a) and 77.1(a). If you were confined in Maricopa, Pinal, Yuma, La Paz, or Gila County, file in the Phoenix Division. If you were confined in Apache, Navajo, Coconino, Mohave, or Yavapai County, file in the Prescott Division. If you were confined in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file in the Tucson Division. **Mail the original and one copy of the complaint with the \$350 filing fee or the application to proceed *in forma pauperis* to:**

7. **Change of Address.** You must immediately notify the Court and the defendants in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.**

8. **Certificate of Service.** You must furnish the defendants with a copy of any document you submit to the Court (except the initial complaint and application to proceed *in forma pauperis*). Each original document (except the initial complaint and application to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the defendants and the address to which it was mailed. See Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. A certificate of service should be in the following form:

9. **Amended Complaint.** If you need to change any of the information in the initial complaint, you must file an amended complaint. The amended complaint must be written on the court-approved civil rights complaint form. You may file one amended complaint without leave (permission) of Court before any defendant has answered your original complaint. See Fed. R. Civ. P. 15(a). After any defendant has filed an answer, you must file a motion for leave to amend and lodge (submit) a proposed amended complaint. LRCiv 15.1. In addition, an amended complaint may not incorporate by reference any part of your prior complaint. LRCiv 15.1(a)(2). **Any allegations or defendants not included in the amended complaint are considered dismissed.** All amended complaints are subject to screening under the Prison Litigation Reform Act; screening your amendment will take additional processing time.

10. **Exhibits.** You should not submit exhibits with the complaint or amended complaint. Instead, the relevant information should be paraphrased. You should keep the exhibits to use to support or oppose a motion to dismiss, a motion for summary judgment, or at trial.

11. **Letters and Motions.** It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

12. Completing the Civil Rights Complaint Form.

HEADING:

1. Your Name. Print your name, prison or inmate number, and institutional mailing address on the lines provided.
2. Defendants. If there are **four or fewer** defendants, print the name of each. If you name **more than four** defendants, print the name of the first defendant on the first line, write the words “and others” on the second line, and attach an additional page listing the names of **all** of the defendants. Insert the additional page after page 1 and number it “1-A” at the bottom.
3. Jury Demand. If you want a jury trial, you must write “JURY TRIAL DEMANDED” in the space below “CIVIL RIGHTS COMPLAINT BY A PRISONER.” Failure to do so may result in the loss of the right to a jury trial. A jury trial is not available if you are seeking only injunctive relief.

Part A. JURISDICTION:

1. Nature of Suit. Mark whether you are filing the complaint pursuant to 42 U.S.C. § 1983 for state, county, or city defendants; “Bivens v. Six Unknown Federal Narcotics Agents” for federal defendants; or “other.” If you mark “other,” identify the source of that authority.
2. Location. Identify the institution and city where the alleged violation of your rights occurred.
3. Defendants. Print all of the requested information about each of the defendants in the spaces provided. If you are naming more than four defendants, you must provide the necessary information about each additional defendant on separate pages labeled “2-A,” “2-B,” etc., at the bottom. Insert the additional page(s) immediately behind page 2.

Part B. PREVIOUS LAWSUITS:

You must identify any other lawsuit you have filed in either state or federal court while you were a prisoner. Print all of the requested information about each lawsuit in the spaces provided. If you have filed more than three lawsuits, you must provide the necessary information about each additional lawsuit on a separate page. Label the page(s) as “2-A,” “2-B,” etc., at the bottom of the page and insert the additional page(s) immediately behind page 2.

Part C. CAUSE OF ACTION:

You must identify what rights each defendant violated. The form provides space to allege three separate counts (**one violation per count**). If you are alleging more than three counts, you must provide the necessary information about each additional count on a separate page. Number the additional pages “5-A,” “5-B,” etc., and insert them immediately behind page 5. Remember that you are limited to a total of fifteen additional pages.

1. **Counts**. You must identify which civil right was violated. **You may allege the violation of only one civil right per count.**
2. **Issue Involved**. Check the box that most closely identifies the issue involved in your claim. **You may check only one box per count.** If you check the box marked "Other," you must identify the specific issue involved.
3. **Supporting Facts**. After you have identified which civil right was violated, you must state the supporting facts. Be as specific as possible. You must state what each individual defendant did to violate your rights. If there is more than one defendant, you must identify which defendant did what act. You also should state the date(s) on which the act(s) occurred, if possible.
4. **Injury**. State precisely how you were injured by the alleged violation of your rights.
5. **Administrative Remedies**. You must exhaust any available administrative remedies before you file a civil rights complaint. See 42 U.S.C. § 1997e. Consequently, you should disclose whether you have exhausted the inmate grievance procedures or administrative appeals for each count in your complaint. If the grievance procedures were not available for any of your counts, fully explain why on the lines provided.

Part D. REQUEST FOR RELIEF:

Print the relief you are seeking in the space provided.

SIGNATURE:

You must sign your name and print the date you signed the complaint. Failure to sign the complaint will delay the processing of your action. Unless you are an attorney, you may not bring an action on behalf of anyone but yourself.

FINAL NOTE

You should follow these instructions carefully. Failure to do so may result in your complaint being stricken or dismissed. All questions must be answered concisely in the proper space on the form. If you need more space, you may attach no more than fifteen additional pages. But the form must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the complaint is being continued and number the pages.
