24 Pursuant to Rule 42.1 of the Local Rules of Civil Procedure, the Tohono O'odham
25 Nation has filed a motion to transfer to the undersigned Judge a related case, *Arizona v.*
26 *Tohono O'odham Nation*, CV-11-296-PHX-NVW (D. Ariz. Feb. 14, 2011). Doc. 132,
27 CV-10-1993. Plaintiffs in the related case, the State of Arizona and the Gila River

1 Indian Community, consent to the requested transfer. Doc. 134, CV-10-1993. In the
2 interest of judicial economy, the motion to transfer will be granted.

3 **IT IS ORDERED:**

4 1. The motion to transfer related case (Doc. 132, CV-10-1993) is **granted**.

5 2. The Clerk is directed to transfer Case No. CV-11-296-PHX-NVW to the
6 undersigned Judge.

7 3. A case management conference will be held by telephone on **April 1, 2011,**
8 **at 11:00 a.m.** At least two days prior to the conference, the parties jointly shall file a
9 memorandum setting forth a proposed litigation schedule for this case.
