ORDER

Plaintiff James Ray Jones, who is confined in the Arizona State Prison Complex, North Unit in Florence, Arizona, has filed a *pro se* civil rights Complaint pursuant to 42 U.S.C. § 1983 and an Application to Proceed *In Forma Pauperis*. The Court will dismiss the Complaint with leave to amend.

I. Application to Proceed *In Forma Pauperis* and Filing Fee

Plaintiff’s Application to Proceed *In Forma Pauperis* will be granted. 28 U.S.C. § 1915(a). Plaintiff must pay the statutory filing fee of \$350.00. 28 U.S.C. § 1915(b)(1). The Court will assess an initial partial filing fee of \$10.11. The remainder of the fee will be collected monthly in payments of 20% of the previous month’s income each time the amount in the account exceeds \$10.00. 28 U.S.C. § 1915(b)(2). The Court will enter a separate Order requiring the appropriate government agency to collect and forward the fees according to the statutory formula.

II. Statutory Screening of Prisoner Complaints

The Court is required to screen complaints brought by prisoners seeking relief against

1 a governmental entity or an officer or an employee of a governmental entity. 28 U.S.C.
2 § 1915A(a). The Court must dismiss a complaint or portion thereof if a plaintiff has raised
3 claims that are legally frivolous or malicious, that fail to state a claim upon which relief may
4 be granted, or that seek monetary relief from a defendant who is immune from such relief.
5 28 U.S.C. § 1915A(b)(1), (2).

6 A pleading must contain a “short and plain statement of the claim *showing* that the
7 pleader is entitled to relief.” Fed. R. Civ. P. 8(a)(2) (emphasis added). While Rule 8 does not
8 demand detailed factual allegations, “it demands more than an unadorned, the-defendant-
9 unlawfully-harmed-me accusation.” Ashcroft v. Iqbal, 129 S. Ct. 1937, 1949 (2009).
10 “Threadbare recitals of the elements of a cause of action, supported by mere conclusory
11 statements, do not suffice.” Id.

12 “[A] complaint must contain sufficient factual matter, accepted as true, to ‘state a
13 claim to relief that is plausible on its face.’” Id. (quoting Bell Atlantic Corp. v. Twombly,
14 550 U.S. 544, 570 (2007)). A claim is plausible “when the plaintiff pleads factual content
15 that allows the court to draw the reasonable inference that the defendant is liable for the
16 misconduct alleged.” Id. “Determining whether a complaint states a plausible claim for
17 relief [is] . . . a context-specific task that requires the reviewing court to draw on its judicial
18 experience and common sense.” Id. at 1950. Thus, although a plaintiff’s specific factual
19 allegations may be consistent with a constitutional claim, a court must assess whether there
20 are other “more likely explanations” for a defendant’s conduct. Id. at 1951.

21 But as the United States Court of Appeals for the Ninth Circuit has instructed, courts
22 must “continue to construe *pro se* filings liberally.” Hebbe v. Pliler, 627 F.3d 338, 342 (9th
23 Cir. 2010). A “complaint [filed by a *pro se* prisoner] ‘must be held to less stringent standards
24 than formal pleadings drafted by lawyers.’” Id. (quoting Erickson v. Pardus, 551 U.S. 89,
25 94 (2007) (*per curiam*)).

26 If the Court determines that a pleading could be cured by the allegation of other facts,
27 a *pro se* litigant is entitled to an opportunity to amend a complaint before dismissal of the
28 action. See Lopez v. Smith, 203 F.3d 1122, 1127-29 (9th Cir. 2000) (*en banc*). The Court

1 should not, however, advise the litigant how to cure the defects. This type of advice “would
2 undermine district judges’ role as impartial decisionmakers.” Pliler v. Ford, 542 U.S. 225,
3 231 (2004); see also Lopez, 203 F.3d at 1131 n.13 (declining to decide whether the court was
4 required to inform a litigant of deficiencies). The Court will dismiss Plaintiff’s Complaint
5 for failure to state a claim, but because the Complaint may possibly be saved by amendment,
6 will dismiss the Complaint with leave to amend.

7 **III. Complaint**

8 Plaintiff alleges one count for the use of excessive force. He sues the following
9 Defendants: the City of Yuma Police Department; the Chief of the Yuma Police Department;
10 and Yuma Police Officers Mike Ewald and John Doe Holzworth. Plaintiff seeks declaratory,
11 compensatory, and punitive relief.

12 Plaintiff alleges the following facts in his Complaint: At some point, Plaintiff was
13 walking with his hands in his pocket in a “highly intoxicated” state when Officer Ewald
14 slammed Plaintiff to the ground and began hitting him in the head until Plaintiff was knocked
15 unconscious. (Doc. 1 at 3.) Officer Holzworth witnessed Ewald’s actions. Plaintiff suffered
16 cuts, swelling, bruises, and a concussion.

17 **IV. Failure to State a Claim**

18 Section 1983 provides a cause of action against persons acting under color of state law
19 who have violated rights guaranteed by the United States Constitution and federal law. 42
20 U.S.C. § 1983; see also Buckley v. City of Redding, 66 F.3d 188, 190 (9th Cir. 1995). To
21 state a claim under § 1983, a plaintiff must allege facts supporting that (1) the conduct about
22 which he complains was committed by a person acting under the color of state law and (2)
23 the conduct deprived him of a federal constitutional or statutory right. Wood v. Ostrander,
24 879 F.2d 583, 587 (9th Cir. 1989). A “plaintiff generally must assert his own legal rights
25 and interests, and cannot assert the legal rights or interests of third parties.” Mothershed v.
26 Justices of the Supreme Court, 410 F.3d 602, 610 (9th Cir. 2005) (quoting Warth v. Seldin,
27 422 U.S. 490, 499 (1975)). A plaintiff must also allege that he suffered a specific injury as
28 a result of the conduct of a particular defendant and he must allege an affirmative link

1 between the injury and the conduct of that defendant. Rizzo v. Goode, 423 U.S. 362, 371-72,
2 377 (1976).

3 **A. City of Yuma Police Department**

4 Plaintiff sues the City of Yuma Police Department. A municipal police department
5 is not a “person” within the meaning of § 1983. See e.g., Petaway v. City of New Haven
6 Police Dep’t, 541 F. Supp.2d 504 (D. Conn. 2008); Pahle v. Colebrookdale Tp., 227 F.
7 Supp.2d 361 (E.D. Pa. 2002). However, a municipality is a “person” for purposes of § 1983,
8 i.e., a municipality such as a city or county, may be sued. See Leatherman v. Tarrant County
9 Narcotics Intelligence and Coordination Unit, 507 U.S. 163, 166 (1993); Monell v. Dep’t of
10 Soc. Servs., 436 U.S. 658, 694 (1978). To state a claim against a municipality under § 1983,
11 a plaintiff must allege facts to support that his constitutional rights were violated pursuant
12 to a policy or custom of the municipality. Cortez v. County of Los Angeles, 294 F.3d 1186,
13 1188 (9th Cir. 2001) (citing Monell, 436 U.S. at 690-91); Thompson v. City of Los Angeles,
14 885 F.2d 1439, 1443 (9th Cir. 1989)). Thus, a municipality may not be sued solely because
15 an injury was inflicted by one of its employees or agents. Long v. County of Los Angeles,
16 442 F.3d 1178, 1185 (9th Cir. 2006). Therefore, a § 1983 claim against a municipal
17 defendant “cannot succeed as a matter of law” unless a plaintiff: (1) contends that the
18 municipal defendant maintains a policy or custom pertinent to the plaintiff’s alleged injury;
19 and (2) explains how such policy or custom caused the plaintiff’s injury. Sadoski v. Mosley,
20 435 F.3d 1076, 1080 (9th Cir. 2006) (affirming dismissal of a municipal defendant pursuant
21 to Fed. R. Civ. P. 12(b)(6)).

22 The City of Yuma Police Department is not a proper Defendant and it will be
23 dismissed. To the extent that Plaintiff sues the City of Yuma, he fails to allege facts to
24 support that the City of Yuma maintained a policy or custom that resulted in the violation of
25 Plaintiff’s federal constitutional rights or to explain how his injuries were caused by any
26 municipal policy or custom. Accordingly, Plaintiff also fails to state a claim against the City
27 of Yuma.

1 **B. Yuma Chief of Police**

2 Plaintiff also sues the Yuma Chief of Police. Plaintiff fails to allege any facts against
3 the Chief. Instead, he appears to assert that the Chief is liable pursuant to *respondeat*
4 *superior*. (Doc. 1 at 2.) To state a claim against a defendant, a “plaintiff must allege facts,
5 not simply conclusions, that show that an individual was personally involved in the
6 deprivation of his civil rights.” Barren v. Harrington, 152 F.3d 1193, 1194 (9th Cir. 1998).
7 For an individual to be liable in his official capacity, a plaintiff must allege that the official
8 acted as a result of a policy, practice, or custom or that the official promulgated a policy,
9 practice or custom resulting in the violation. See Cortez, 294 F.3d at 1188. In addition, there
10 is no *respondeat superior* liability under § 1983, so a defendant’s position as the supervisor
11 of someone who allegedly violated a plaintiff’s constitutional rights does not make him
12 liable. Monell, 436 U.S. at 691; Taylor v. List, 880 F.2d 1040, 1045 (9th Cir. 1989). A
13 supervisor in his individual capacity, “is only liable for constitutional violations of his
14 subordinates if the supervisor participated in or directed the violations, or knew of the
15 violations and failed to act to prevent them.” Taylor, 880 F.2d at 1045.

16 Plaintiff fails to allege any facts to support the Yuma Police Chief’s involvement in
17 any alleged constitutional violation. Therefore, Plaintiff fails to state a claim against the
18 Yuma Police Chief and he will be dismissed.

19 **C. Holzworth**

20 Plaintiff also sues Officer Holzworth. The only facts alleged against him is that he
21 saw Officer Ewald use excessive force against Plaintiff. That, absent more, is not sufficient
22 to support that Holzworth in any way violated Plaintiff’s constitutional rights. Accordingly,
23 Holzworth will be dismissed.

24 **D. Excessive Force**

25 Plaintiff alleges a claim for the use of excessive force during an arrest. The Fourth
26 Amendment applies to excessive force claims by pretrial detainees. See Lolli v. County of
27 Orange, 351 F.3d 410, 415 (9th Cir. 2003). Officials acting under color of state law may not
28 maliciously and sadistically use force for the purpose of causing harm. Hudson v.

1 McMillian, 503 U.S. 1, 7 (1992); Watts v. McKinney, 394 F.3d 710, 711 (9th Cir. 2005).
2 To state a claim for excessive force, a plaintiff must allege facts to support that an official
3 used or caused to be used objectively unreasonable force against him. See Brosseau v.
4 Haugen, 543 U.S. 194, 197 (2004). Analysis of an excessive force claim requires “balancing
5 the ‘nature and quality of the intrusion’ on a person’s liberty with the ‘countervailing
6 governmental interest at stake’ to determine whether the use of force was objectively
7 reasonable under the circumstances.” Drummond v. City of Anaheim, 343 F.3d 1052, 1056
8 (9th Cir. 2003) (citations omitted); see also Graham v. Connor, 490 U.S. 386, 395 (1989).

9 Plaintiff fails to allege when and where the incident at issue occurred. Plaintiff also
10 fails to sufficiently allege the surrounding circumstances, such as those leading to his arrest
11 and whether he was resisting or failing to comply with instructions from police at the time.
12 Accordingly, Plaintiff fails to state a claim for excessive force.

13 **V. Leave to Amend**

14 For the foregoing reasons, Plaintiff’s Complaint will be dismissed for failure to state
15 a claim upon which relief may be granted. Within 30 days, Plaintiff may submit a first
16 amended complaint to cure the deficiencies outlined above. The Clerk of Court will mail
17 Plaintiff a court-approved form to use for filing a first amended complaint. If Plaintiff fails
18 to use the court-approved form, the Court may strike the amended complaint and dismiss this
19 action without further notice to Plaintiff.

20 Plaintiff must clearly designate on the face of the document that it is the “First
21 Amended Complaint.” The first amended complaint must be retyped or rewritten in its
22 entirety on the court-approved form and may not incorporate any part of the original
23 Complaint by reference. Plaintiff may include only one claim per count.

24 A first amended complaint supersedes the original complaint. Ferdik v. Bonzelet, 963
25 F.2d 1258, 1262 (9th Cir. 1992); Hal Roach Studios v. Richard Feiner & Co., 896 F.2d 1542,
26 1546 (9th Cir. 1990). After amendment, the Court will treat an original complaint as
27 nonexistent. Ferdik, 963 F.2d at 1262. Any cause of action that was raised in the original
28 complaint is waived if it is not raised in a first amended complaint. King v. Atiyeh, 814 F.2d

1 565, 567 (9th Cir. 1987).

2 **VI. Warnings**

3 **A. Release**

4 Plaintiff must pay the unpaid balance of the filing fee within 120 days of his release.
5 Also, within 30 days of his release, he must either (1) notify the Court that he intends to pay
6 the balance or (2) show good cause, in writing, why he cannot. Failure to comply may result
7 in dismissal of this action.

8 **B. Address Changes**

9 Plaintiff must file and serve a notice of a change of address in accordance with Rule
10 83.3(d) of the Local Rules of Civil Procedure. Plaintiff must not include a motion for other
11 relief with a notice of change of address. Failure to comply may result in dismissal of this
12 action.

13 **C. Copies**

14 Plaintiff must submit an additional copy of every filing for use by the Court. See
15 LRCiv 5.4. Failure to comply may result in the filing being stricken without further notice
16 to Plaintiff.

17 **D. Possible “Strike”**

18 Because the Complaint has been dismissed for failure to state a claim, if Plaintiff fails
19 to file an amended complaint correcting the deficiencies identified in this Order, the
20 dismissal may count as a “strike” under the “3-strikes” provision of 28 U.S.C. § 1915(g).
21 Under the 3-strikes provision, a prisoner may not bring a civil action or appeal a civil
22 judgment *in forma pauperis* under 28 U.S.C. § 1915 “if the prisoner has, on 3 or more prior
23 occasions, while incarcerated or detained in any facility, brought an action or appeal in a
24 court of the United States that was dismissed on the grounds that it is frivolous, malicious,
25 or fails to state a claim upon which relief may be granted, unless the prisoner is under
26 imminent danger of serious physical injury.” 28 U.S.C. § 1915(g).

27 **E. Possible Dismissal**

28 If Plaintiff fails to timely comply with every provision of this Order, including these

1 warnings, the Court may dismiss this action without further notice. See Ferdik, 963 F.2d at
2 1260-61 (a district court may dismiss an action for failure to comply with any order of the
3 Court).

4 **IT IS ORDERED:**

5 (1) Plaintiff's Application to Proceed *In Forma Pauperis* is **granted**. (Doc. 5.)

6 (2) As required by the accompanying Order to the appropriate government agency,
7 Plaintiff must pay the \$350.00 filing fee and is assessed an initial partial filing fee of 10.11.

8 (3) The Complaint (Doc. 1) is **dismissed** for failure to state a claim. Plaintiff has
9 **30 days** from the date this Order is filed to file a first amended complaint in compliance with
10 this Order.

11 (4) If Plaintiff fails to file an amended complaint within 30 days, the Clerk of
12 Court must, without further notice, enter a judgment of dismissal of this action with prejudice
13 that states that the dismissal may count as a "strike" under 28 U.S.C. § 1915(g).

14 (5) The Clerk of Court must mail Plaintiff a court-approved form for filing a civil
15 rights complaint by a prisoner.

**Instructions for a Prisoner Filing a Civil Rights Complaint
in the United States District Court for the District of Arizona**

1. Who May Use This Form. The civil rights complaint form is designed to help incarcerated persons prepare a complaint seeking relief for a violation of their federal civil rights. These complaints typically concern, but are not limited to, conditions of confinement. **This form should not be used to challenge your conviction or sentence.** If you want to challenge a state conviction or sentence, you should file a petition under 28 U.S.C. § 2254 for a writ of habeas corpus by a person in state custody. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment.

2. The Form. **Local Rule of Civil Procedure (LRCiv) 3.4(a) provides that complaints by incarcerated persons must be filed on the court-approved form.** The form must be typed or neatly handwritten. The form must be completely filled in to the extent applicable. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages, **but no more than fifteen additional pages**, of standard letter-sized paper. You must identify which part of the complaint is being continued and number all pages. If you do not fill out the form properly, you will be asked to submit additional or corrected information, which may delay the processing of your action. You do not need to cite law.

3. Your Signature. You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.

4. The Filing Fee. The filing fee for this action is \$350.00. If you are unable to immediately pay the filing fee, you may request leave to proceed *in forma pauperis*. Please review the “Information for Prisoners Seeking Leave to Proceed with a (Non-Habeas) Civil Action in Federal Court *In Forma Pauperis* Pursuant to 28 U.S.C. § 1915” for additional instructions.

5. Original and Judge’s Copy. You must send an **original plus one copy** of your complaint and of any other documents submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten.

6. Where to File. You should file your complaint in the division **where you were confined when your rights were allegedly violated.** See LRCiv 5.1(a) and 77.1(a). If you were confined in Maricopa, Pinal, Yuma, La Paz, or Gila County, file in the Phoenix Division. If you were confined in Apache, Navajo, Coconino, Mohave, or Yavapai County, file in the Prescott Division. If you were confined in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file in the Tucson Division. **Mail the original and one copy of the complaint with the \$350 filing fee or the application to proceed *in forma pauperis* to:**

7. Change of Address. You must immediately notify the Court and the defendants in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.**

8. Certificate of Service. You must furnish the defendants with a copy of any document you submit to the Court (except the initial complaint and application to proceed *in forma pauperis*). Each original document (except the initial complaint and application to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the defendants and the address to which it was mailed. See Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. A certificate of service should be in the following form:

9. Amended Complaint. If you need to change any of the information in the initial complaint, you must file an amended complaint. The amended complaint must be written on the court-approved civil rights complaint form. You may file one amended complaint without leave (permission) of Court before any defendant has answered your original complaint. See Fed. R. Civ. P. 15(a). After any defendant has filed an answer, you must file a motion for leave to amend and lodge (submit) a proposed amended complaint. LRCiv 15.1. In addition, an amended complaint may not incorporate by reference any part of your prior complaint. LRCiv 15.1(a)(2). **Any allegations or defendants not included in the amended complaint are considered dismissed.** All amended complaints are subject to screening under the Prison Litigation Reform Act; screening your amendment will take additional processing time.

10. Exhibits. You should not submit exhibits with the complaint or amended complaint. Instead, the relevant information should be paraphrased. You should keep the exhibits to use to support or oppose a motion to dismiss, a motion for summary judgment, or at trial.

11. Letters and Motions. It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

12. Completing the Civil Rights Complaint Form.

HEADING:

1. Your Name. Print your name, prison or inmate number, and institutional mailing address on the lines provided.
2. Defendants. If there are **four or fewer** defendants, print the name of each. If you name **more than four** defendants, print the name of the first defendant on the first line, write the words “and others” on the second line, and attach an additional page listing the names of **all** of the defendants. Insert the additional page after page 1 and number it “1-A” at the bottom.
3. Jury Demand. If you want a jury trial, you must write “JURY TRIAL DEMANDED” in the space below “CIVIL RIGHTS COMPLAINT BY A PRISONER.” Failure to do so may result in the loss of the right to a jury trial. A jury trial is not available if you are seeking only injunctive relief.

Part A. JURISDICTION:

1. Nature of Suit. Mark whether you are filing the complaint pursuant to 42 U.S.C. § 1983 for state, county, or city defendants; “Bivens v. Six Unknown Federal Narcotics Agents” for federal defendants; or “other.” If you mark “other,” identify the source of that authority.
2. Location. Identify the institution and city where the alleged violation of your rights occurred.
3. Defendants. Print all of the requested information about each of the defendants in the spaces provided. If you are naming more than four defendants, you must provide the necessary information about each additional defendant on separate pages labeled “2-A,” “2-B,” etc., at the bottom. Insert the additional page(s) immediately behind page 2.

Part B. PREVIOUS LAWSUITS:

You must identify any other lawsuit you have filed in either state or federal court while you were a prisoner. Print all of the requested information about each lawsuit in the spaces provided. If you have filed more than three lawsuits, you must provide the necessary information about each additional lawsuit on a separate page. Label the page(s) as “2-A,” “2-B,” etc., at the bottom of the page and insert the additional page(s) immediately behind page 2.

Part C. CAUSE OF ACTION:

You must identify what rights each defendant violated. The form provides space to allege three separate counts (**one violation per count**). If you are alleging more than three counts, you must provide the necessary information about each additional count on a separate page. Number the additional pages “5-A,” “5-B,” etc., and insert them immediately behind page 5. Remember that you are limited to a total of fifteen additional pages.

1. Counts. You must identify which civil right was violated. **You may allege the violation of only one civil right per count.**

2. Issue Involved. Check the box that most closely identifies the issue involved in your claim. **You may check only one box per count.** If you check the box marked “Other,” you must identify the specific issue involved.

3. Supporting Facts. After you have identified which civil right was violated, you must state the supporting facts. Be as specific as possible. You must state what each individual defendant did to violate your rights. If there is more than one defendant, you must identify which defendant did what act. You also should state the date(s) on which the act(s) occurred, if possible.

4. Injury. State precisely how you were injured by the alleged violation of your rights.

5. Administrative Remedies. You must exhaust any available administrative remedies before you file a civil rights complaint. See 42 U.S.C. § 1997e. Consequently, you should disclose whether you have exhausted the inmate grievance procedures or administrative appeals for each count in your complaint. If the grievance procedures were not available for any of your counts, fully explain why on the lines provided.

Part D. REQUEST FOR RELIEF:

Print the relief you are seeking in the space provided.

SIGNATURE:

You must sign your name and print the date you signed the complaint. Failure to sign the complaint will delay the processing of your action. Unless you are an attorney, you may not bring an action on behalf of anyone but yourself.

FINAL NOTE

You should follow these instructions carefully. Failure to do so may result in your complaint being stricken or dismissed. All questions must be answered concisely in the proper space on the form. If you need more space, you may attach no more than fifteen additional pages. But the form must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the complaint is being continued and number the pages.
