**ORDER**

15 Plaintiff Bryan Mornyngstarr Bernard, who is confined in the Yuma County  
16 Detention Center, filed a *pro se* civil rights Complaint pursuant to 42 U.S.C. § 1983 and  
17 an Application to Proceed *In Forma Pauperis*.

18 In an October 9, 2012 Order, the Court granted Plaintiff 30 days to: (1) pay the  
19 filing fee or file a complete Application to Proceed *In Forma Pauperis*; **and** (2) file an  
20 amended complaint on the court-approved form. On October 25, 2012, Plaintiff filed a  
21 First Amended Complaint (Doc. 11). In a November 30, 2012 Order, the Court granted  
22 Plaintiff an additional 30 days to file an Application to Proceed *In Forma Pauperis*. On  
23 December 17, 2012, Plaintiff filed an incomplete Application to Proceed *In Forma*  
24 *Pauperis* (Doc. 13).

25 The Court will deny the new Application to Proceed *In Forma Pauperis* and give  
26 Plaintiff one final opportunity to file a **complete** Application to Proceed *In Forma*  
27 *Pauperis*. If Plaintiff fails to file a complete Application to Proceed *In Forma Pauperis*  
28 within 30 days, the Court will dismiss this action.

1     **I.     Payment of Filing Fee**

2             When bringing an action, a prisoner must either pay the \$350.00 filing fee in a  
3 lump sum or, if granted the privilege of proceeding *in forma pauperis*, pay the fee  
4 incrementally as set forth in 28 U.S.C. § 1915(b)(1). An application to proceed *in forma*  
5 *pauperis* requires an affidavit of indigence and a *certified* copy of the inmate’s trust  
6 account statement for the six months preceding the filing of the Complaint. 28 U.S.C.  
7 § 1915(a)(2). An inmate must submit statements from each institution where the inmate  
8 was confined during the six-month period. *Id.* To assist prisoners in meeting these  
9 requirements, the Court requires use of a form application. LRCiv 3.4.

10            If a prisoner is granted leave to proceed *in forma pauperis*, the Court will assess an  
11 initial partial filing fee of 20% of either the average monthly deposits or the average  
12 monthly balance in Plaintiff’s account, whichever is greater. 28 U.S.C. § 1915(b)(1). An  
13 initial partial filing fee will only be collected when funds exist. 28 U.S.C. § 1915(b)(4).  
14 The balance of the fee will be collected in monthly payments of 20% of the preceding  
15 month’s income credited to an inmate’s account, each time the amount in the account  
16 exceeds \$10.00. 28 U.S.C. § 1915(b)(2).

17     **II.    Application Fails to Comply With Statute**

18            Plaintiff has used the court-approved form, but has left blank the “Consent to  
19 Collection of Fees from Trust Account” section. This part of the *in forma pauperis*  
20 application must be filled out, signed, and dated. The “Certificate of Correctional  
21 Official as to Status of Applicant’s Trust Account” section is also not completed, and  
22 Plaintiff has not submitted a certified six-month trust account statement. In light of these  
23 deficiencies, the Court will deny the Application to Proceed and will give Plaintiff 30  
24 days to either pay the \$350.00 filing fee or file a complete Application to Proceed *In*  
25 *Forma Pauperis*, including a certified six-month trust account statement.

1 **III. Warnings**

2 **A. Address Changes**

3 Plaintiff must file and serve a notice of a change of address in accordance with  
4 Rule 83.3(d) of the Local Rules of Civil Procedure. Plaintiff must not include a motion  
5 for other relief with a notice of change of address. Failure to comply may result in  
6 dismissal of this action.

7 **B. Copies**

8 Plaintiff must submit an additional copy of every filing for use by the Court. *See*  
9 LRCiv 5.4. Failure to comply may result in the filing being stricken without further  
10 notice to Plaintiff.

11 **C. Possible Dismissal**

12 If Plaintiff fails to timely comply with every provision of this Order, including  
13 these warnings, the Court may dismiss this action without further notice. *See Ferdik v.*  
14 *Bonzelet*, 963 F.2d 1258, 1260-61 (9th Cir. 1992) (a district court may dismiss an action  
15 for failure to comply with any order of the Court).

16 **IT IS ORDERED:**

17 (1) Plaintiff's December 17, 2012 Application to Proceed *In Forma Pauperis*  
18 (Doc. 13) is **denied without prejudice**.

19 (2) Within 30 days of the date this Order is filed, Plaintiff must either pay the  
20 \$350.00 filing fee **or** file a complete Application to Proceed *In Forma Pauperis* and a  
21 certified six-month trust account statement.

22 (3) If Plaintiff fails to either pay the \$350.00 filing fee or file a complete  
23 Application to Proceed *In Forma Pauperis* within 30 days, the Clerk of Court must enter  
24 a judgment of dismissal of this action without prejudice and without further notice to  
25 Plaintiff.



**Instructions for Prisoners Applying for Leave to Proceed *in Forma Pauperis*  
Pursuant to 28 U.S.C. § 1915 in a Civil Action (Non-habeas) in Federal Court**

You must pay the full filing fee of \$350.00 for a civil action. If you later file an appeal, you will be obligated to pay the \$455.00 filing fee for the appeal.

If you have enough money to pay the full filing fee, you should send a cashier's check or money order payable to the Clerk of the Court with your complaint, petition, or notice of appeal.

If you do not have enough money to pay the full filing fee, you can file the action without prepaying the filing fee. However, the court will assess an initial partial filing fee. The initial partial filing fee will be the greater of 20% of the average monthly deposits or 20% of the average monthly balance in your prison or jail account for the six months immediately preceding the filing of the lawsuit. The court will order the agency that has custody of you to withdraw the initial partial filing fee from your prison or jail account as soon as funds are available and to forward the money to the court.

After the initial partial filing fee has been paid, you will owe the balance of the filing fee. Until the filing fee is paid in full, each month you will owe 20% of your preceding month's income. The agency that holds you in custody will collect that money and forward it to the court any time the amount in your account exceeds \$10.00. The balance of the filing fee may be collected even if the action is later dismissed, summary judgment is granted against you, or you fail to prevail at trial.

To file an action without prepaying the filing fee, and to proceed with an action *in forma pauperis*, you must complete the attached form and return it to the court with your complaint. You must have a prison or jail official complete the certificate on the bottom of the form and attach a certified copy of your prison or jail account statement for the last six months. If you were incarcerated in a different institution during any part of the past six months, you must attach a certificate and a certified copy of your account statement from each institution at which you were confined. If you submit an incomplete form or do not submit a prison or jail account statement with the form, your request to proceed *in forma pauperis* will be denied.

Even if some or all of the filing fee has been paid, the court is required to dismiss your action if: (1) your allegation of poverty is untrue; (2) the action is frivolous or malicious; (3) your complaint does not state a claim upon which relief can be granted; or (4) your complaint makes a claim against a defendant for money damages and that defendant is immune from liability for money damages.

If you file more than three actions or appeals which are dismissed as frivolous or malicious or for failure to state a claim on which relief can be granted, you will be prohibited from filing any other action *in forma pauperis* unless you are in imminent danger of serious physical injury.

### CONSENT TO COLLECTION OF FEES FROM TRUST ACCOUNT

I, \_\_\_\_\_, hereby consent to having the designated correctional officials at this institution release to the Court my trust account information. I further consent to having the designated correctional officials at this institution withdraw from my trust account the funds required to comply with the order of this Court for the payment of filing fees in accordance with 28 U.S.C. § 1915(b).

My consent includes withdrawal from my account by correctional officials of partial initial payments to this Court equal to 20% of the greater of:

- (A) the average monthly deposits to my account for the six-month period preceding my filing of this action, or
- (B) the average monthly balance in my account for the six-month period preceding my filing of this action.

My consent also includes monthly withdrawals from my account by correctional officials of an amount equal to 20% of each month's income. Whenever the amount in my account reaches \$10.00, correctional officials will withdraw that amount and forward it to the Court until the required filing fee is paid in full. I understand that I am liable for paying the entire fee, even if my case is dismissed by the Court before the fee is fully paid.
