ORDER

Plaintiff Laura L. Medley, who is confined in the Arizona State Prison Complex-Perryville in Goodyear, Arizona, has filed a *pro se* civil rights Complaint pursuant to 42 U.S.C. § 1983 (Doc. 1) and an Application to Proceed *In Forma Pauperis* (Doc. 2). The Court will dismiss the Complaint with leave to amend.

I. “Three Strikes Provision” of 28 U.S.C. § 1915(g)

A prisoner may not bring a civil action or appeal a civil judgment *in forma pauperis* if:

the prisoner has, on 3 or more prior occasions, while incarcerated or detained in any facility, brought an action or appeal in a court of the United States that was dismissed on the grounds that it is frivolous, malicious, or fails to state a claim upon which relief may be granted, unless the prisoner is under imminent danger of serious physical injury.

28 U.S.C. § 1915(g).

.....

1 Plaintiff has filed at least three actions in this Court that were dismissed as
2 frivolous, malicious, or as failing to state a claim. See *Medley v. Maricopa County*
3 *Superior Court*, 01-CV-2130-PHX-MHM (DKD); *Medley v. Arpaio*, 08-CV-101-PHX-
4 MHM (DKD); and *Medley v. Overton*, 08-CV-590-PHX-MHM (DKD).¹

5 Therefore, Plaintiff may not bring a civil action without complete prepayment of
6 the \$350.00 filing fee unless she is in imminent danger of serious physical injury. 28
7 U.S.C. § 1915(g).

8 **II. Imminent Danger**

9 A plaintiff who has three or more strikes may not bring a civil action without
10 complete prepayment of the \$350.00 filing fee unless she is in imminent danger of
11 serious physical injury. 28 U.S.C. § 1915(g). The Court must consider “the facts alleged
12 in the complaint in deciding whether a prisoner faced the requisite harm.” *Andrews v.*
13 *Cervantes*, 493 F.3d 1047, 1053 (9th Cir. 2007). To meet the “imminent danger”
14 requirement, the “threat or prison condition [must be] real and proximate,” *Ciarpaglini v.*
15 *Saini*, 352 F.3d 328, 330 (7th Cir. 2003) (quoting *Lewis v. Sullivan*, 279 F.3d 526, 531
16 (7th Cir. 2002)), and the allegations must be “specific or credible.” *Kinnell v. Graves*,
17 265 F.3d 1125, 1128 (10th Cir. 2001).

18 In her Complaint, Plaintiff alleges that her Eighth Amendment rights have been
19 violated. She claims, among other things, that more than two-and-a-half years after she
20 received a magnetic resonance imaging (MRI) of her left knee that revealed that she had
21 a ¾ chondral loss at the patella apex, she has not seen an orthopedic surgeon, despite
22 numerous orders for her to see one. Plaintiff asserts that she has severe swelling,
23 numbness, and excruciating pain; that she is forced to walk with a cane or use a

26 ¹The Court identified these strikes in a November 5, 2010 Order to Show Cause in
27 *Medley v. Arizona*, 10-CV-1971-PHX-MHM (DKD). In the Order to Show Cause, the
28 Court gave Plaintiff 30 days to show cause why the dismissals of her prior lawsuits
should not prevent her from proceeding *in forma pauperis*. Plaintiff did not respond to
the Order to Show Cause.

1 wheelchair; and that she is losing her ability to walk. These allegations are sufficient to
2 satisfy the § 1915(g) imminent danger requirement.

3 **III. Application to Proceed *In Forma Pauperis* and Filing Fee**

4 Plaintiff's Application to Proceed *In Forma Pauperis* will be granted. 28 U.S.C.
5 § 1915(a). Plaintiff must pay the statutory filing fee of \$350.00. 28 U.S.C. § 1915(b)(1).
6 The Court will not assess an initial partial filing fee. 28 U.S.C. § 1915(b)(1). The
7 statutory fee will be collected monthly in payments of 20% of the previous month's
8 income each time the amount in the account exceeds \$10.00. 28 U.S.C. § 1915(b)(2).
9 The Court will enter a separate Order requiring the appropriate government agency to
10 collect and forward the fees according to the statutory formula.

11 **IV. Statutory Screening of Prisoner Complaints**

12 The Court is required to screen complaints brought by prisoners seeking relief
13 against a governmental entity or an officer or an employee of a governmental entity. 28
14 U.S.C. § 1915A(a). The Court must dismiss a complaint or portion thereof if a plaintiff
15 has raised claims that are legally frivolous or malicious, that fail to state a claim upon
16 which relief may be granted, or that seek monetary relief from a defendant who is
17 immune from such relief. 28 U.S.C. § 1915A(b)(1), (2).

18 A pleading must contain a "short and plain statement of the claim *showing* that the
19 pleader is entitled to relief." Fed. R. Civ. P. 8(a)(2) (emphasis added). While Rule 8
20 does not demand detailed factual allegations, "it demands more than an unadorned, the-
21 defendant-unlawfully-harmed-me accusation." *Ashcroft v. Iqbal*, 556 U.S. 662, 678
22 (2009). "Threadbare recitals of the elements of a cause of action, supported by mere
23 conclusory statements, do not suffice." *Id.*

24 "[A] complaint must contain sufficient factual matter, accepted as true, to 'state a
25 claim to relief that is plausible on its face.'" *Id.* (quoting *Bell Atlantic Corp. v. Twombly*,
26 550 U.S. 544, 570 (2007)). A claim is plausible "when the plaintiff pleads factual
27 content that allows the court to draw the reasonable inference that the defendant is liable
28 for the misconduct alleged." *Id.* "Determining whether a complaint states a plausible

1 claim for relief [is] . . . a context-specific task that requires the reviewing court to draw
2 on its judicial experience and common sense.” *Id.* at 679. Thus, although a plaintiff’s
3 specific factual allegations may be consistent with a constitutional claim, a court must
4 assess whether there are other “more likely explanations” for a defendant’s conduct. *Id.*
5 at 681.

6 But as the United States Court of Appeals for the Ninth Circuit has instructed,
7 courts must “continue to construe *pro se* filings liberally.” *Hebbe v. Pliler*, 627 F.3d 338,
8 342 (9th Cir. 2010). A “complaint [filed by a *pro se* prisoner] ‘must be held to less
9 stringent standards than formal pleadings drafted by lawyers.’” *Id.* (quoting *Erickson v.*
10 *Pardus*, 551 U.S. 89, 94 (2007) (*per curiam*)).

11 If the Court determines that a pleading could be cured by the allegation of other
12 facts, a *pro se* litigant is entitled to an opportunity to amend a complaint before dismissal
13 of the action. *See Lopez v. Smith*, 203 F.3d 1122, 1127-29 (9th Cir. 2000) (*en banc*). The
14 Court should not, however, advise the litigant how to cure the defects. This type of
15 advice “would undermine district judges’ role as impartial decisionmakers.” *Pliler v.*
16 *Ford*, 542 U.S. 225, 231 (2004); *see also Lopez*, 203 F.3d at 1131 n.13 (declining to
17 decide whether the court was required to inform a litigant of deficiencies). The Court
18 will dismiss Plaintiff’s Complaint for failure to state a claim, but because the Complaint
19 may possibly be saved by amendment, will dismiss the Complaint with leave to amend.

20 **V. Complaint**

21 In her one-count Complaint, Plaintiff sues Defendant Arizona Department of
22 Corrections (ADOC) Director Charles L. Ryan. Plaintiff alleges that her Eighth
23 Amendment rights have been violated. She claims that after waiting more than a year,
24 she obtained an MRI of her left knee in May 2010 and was told that she had a ¾ chondral
25 loss at the patella apex. She claims that it took more than eighteen months to obtain an
26 appropriate knee brace. In addition, she alleges that more that two-and-a-half years after
27 the MRI and despite numerous orders for her to see an orthopedic surgeon, she has not
28 seen an orthopedic surgeon. Plaintiff asserts that Defendant Ryan has refused to provide

1 her with appropriate medical care. She also contends that after the privatization of prison
2 medical care at ADOC, she has experienced “delays of up to several months after
3 submitting health needs requests”; appointments have been cancelled, rescheduled, and
4 cancelled again due to a lack of providers; and medications and medical orders expire and
5 she has had to wait several months to see a provider for a renewal. Plaintiff asserts that
6 she has severe swelling, numbness, and excruciating pain; that she is forced to walk with
7 a cane or use a wheelchair; and that she is losing her ability to walk.

8 In her Request for Relief, Plaintiff seeks monetary damages.

9 **VI. Failure to State a Claim**

10 Although *pro se* pleadings are liberally construed, *Haines v. Kerner*, 404 U.S. 519,
11 520-21 (1972), conclusory and vague allegations will not support a cause of action. *Ivey*
12 *v. Board of Regents of the University of Alaska*, 673 F.2d 266, 268 (9th Cir. 1982).
13 Further, a liberal interpretation of a civil rights complaint may not supply essential
14 elements of the claim that were not initially pled. *Id.*

15 To state a valid claim under § 1983, plaintiffs must allege that they suffered a
16 specific injury as a result of specific conduct of a defendant and show an affirmative link
17 between the injury and the conduct of that defendant. *See Rizzo v. Goode*, 423 U.S. 362,
18 371-72, 377 (1976). “Because vicarious liability is inapplicable to *Bivens* and § 1983
19 suits, a plaintiff must plead that each Government-official defendant, through the
20 official’s own individual actions, has violated the Constitution.” *Iqbal*, 556 U.S. at 676.

21 Not every claim by a prisoner relating to inadequate medical treatment states a
22 violation of the Eighth or Fourteenth Amendment. To state a § 1983 medical claim, a
23 plaintiff must show that the defendants acted with “deliberate indifference to serious
24 medical needs.” *Jett v. Penner*, 439 F.3d 1091, 1096 (9th Cir. 2006) (quoting *Estelle v.*
25 *Gamble*, 429 U.S. 97, 104 (1976)). A plaintiff must show (1) a “serious medical need”
26 by demonstrating that failure to treat the condition could result in further significant
27 injury or the unnecessary and wanton infliction of pain and (2) the defendant’s response
28 was deliberately indifferent. *Jett*, 439 F.3d at 1096 (quotations omitted).

1 “Deliberate indifference is a high legal standard.” *Toguchi v. Chung*, 391 F.3d
2 1051, 1060 (9th Cir. 2004). To act with deliberate indifference, a prison official must
3 both know of and disregard an excessive risk to inmate health; “the official must both be
4 aware of facts from which the inference could be drawn that a substantial risk of serious
5 harm exists, and she must also draw the inference.” *Farmer v. Brennan*, 511 U.S. 825,
6 837 (1994). Deliberate indifference in the medical context may be shown by a
7 purposeful act or failure to respond to a prisoner’s pain or possible medical need and
8 harm caused by the indifference. *Jett*, 439 F.3d at 1096. Deliberate indifference may
9 also be shown when a prison official intentionally denies, delays, or interferes with
10 medical treatment or by the way prison doctors respond to the prisoner’s medical needs.
11 *Estelle*, 429 U.S. at 104-05; *Jett*, 439 F.3d at 1096.

12 Deliberate indifference is a higher standard than negligence or lack of ordinary
13 due care for the prisoner’s safety. *Farmer*, 511 U.S. at 835. “Neither negligence nor
14 gross negligence will constitute deliberate indifference.” *Clement v. California Dep’t of*
15 *Corrections*, 220 F. Supp. 2d 1098, 1105 (N.D. Cal. 2002); *see also Broughton v. Cutter*
16 *Labs.*, 622 F.2d 458, 460 (9th Cir. 1980) (mere claims of “indifference,” “negligence,” or
17 “medical malpractice” do not support a claim under § 1983). “A difference of opinion
18 does not amount to deliberate indifference to [a plaintiff’s] serious medical needs.”
19 *Sanchez v. Vild*, 891 F.2d 240, 242 (9th Cir. 1989). A mere delay in medical care,
20 without more, is insufficient to state a claim against prison officials for deliberate
21 indifference. *See Shapley v. Nevada Bd. of State Prison Comm’rs*, 766 F.2d 404, 407
22 (9th Cir. 1985). The indifference must be substantial. The action must rise to a level of
23 “unnecessary and wanton infliction of pain.” *Estelle*, 429 U.S. at 105.

24 Plaintiff’s allegations are too vague and conclusory to state an Eighth Amendment
25 deliberate indifference claim against Defendant Ryan. Thus, the Court will dismiss
26 without prejudice Plaintiff’s Complaint.

1 **VII. Leave to Amend**

2 For the foregoing reasons, Plaintiff's Complaint will be dismissed for failure to
3 state a claim upon which relief may be granted. Within 30 days, Plaintiff may submit a
4 first amended complaint to cure the deficiencies outlined above. The Clerk of Court will
5 mail Plaintiff a court-approved form to use for filing a first amended complaint. If
6 Plaintiff fails to use the court-approved form, the Court may strike the amended
7 complaint and dismiss this action without further notice to Plaintiff.

8 Plaintiff must clearly designate on the face of the document that it is the "First
9 Amended Complaint." The first amended complaint must be retyped or rewritten in its
10 entirety on the court-approved form and may not incorporate any part of the original
11 Complaint by reference. Plaintiff may include only one claim per count.

12 If Plaintiff files an amended complaint, Plaintiff must write short, plain statements
13 telling the Court: (1) the constitutional right Plaintiff believes was violated; (2) the name
14 of the Defendant who violated the right; (3) exactly what that Defendant did or failed to
15 do; (4) how the action or inaction of that Defendant is connected to the violation of
16 Plaintiff's constitutional right; and (5) what specific injury Plaintiff suffered because of
17 that Defendant's conduct. *See Rizzo*, 423 U.S. at 371-72, 377.

18 Plaintiff must repeat this process for each person she names as a Defendant. If
19 Plaintiff fails to affirmatively link the conduct of each named Defendant with the specific
20 injury suffered by Plaintiff, the allegations against that Defendant will be dismissed for
21 failure to state a claim. **Conclusory allegations that a Defendant or group of**
22 **Defendants have violated a constitutional right are not acceptable and will be**
23 **dismissed.**

24 A first amended complaint supersedes the original complaint. *Ferdik v. Bonzelet*,
25 963 F.2d 1258, 1262 (9th Cir. 1992); *Hal Roach Studios v. Richard Feiner & Co.*, 896
26 F.2d 1542, 1546 (9th Cir. 1990). After amendment, the Court will treat an original
27 complaint as nonexistent. *Ferdik*, 963 F.2d at 1262. Any cause of action that was raised
28

1 in the original complaint is waived if it is not raised in a first amended complaint. *King v.*
2 *Atiyeh*, 814 F.2d 565, 567 (9th Cir. 1987).

3 **VIII. Warnings**

4 **A. Release**

5 Plaintiff must pay the unpaid balance of the filing fee within 120 days of her
6 release. Also, within 30 days of her release, she must either (1) notify the Court that she
7 intends to pay the balance or (2) show good cause, in writing, why she cannot. Failure to
8 comply may result in dismissal of this action.

9 **B. Address Changes**

10 Plaintiff must file and serve a notice of a change of address in accordance with
11 Rule 83.3(d) of the Local Rules of Civil Procedure. Plaintiff must not include a motion
12 for other relief with a notice of change of address. Failure to comply may result in
13 dismissal of this action.

14 **C. Copies**

15 Plaintiff must submit an additional copy of every filing for use by the Court. *See*
16 LRCiv 5.4. Failure to comply may result in the filing being stricken without further
17 notice to Plaintiff.

18 **D. Possible “Strike”**

19 Because the Complaint has been dismissed for failure to state a claim, if Plaintiff
20 fails to file an amended complaint correcting the deficiencies identified in this Order, the
21 dismissal may count as a “strike” under the “3-strikes” provision of 28 U.S.C. § 1915(g).
22 Under the 3-strikes provision, a prisoner may not bring a civil action or appeal a civil
23 judgment *in forma pauperis* under 28 U.S.C. § 1915 “if the prisoner has, on 3 or more
24 prior occasions, while incarcerated or detained in any facility, brought an action or appeal
25 in a court of the United States that was dismissed on the grounds that it is frivolous,
26 malicious, or fails to state a claim upon which relief may be granted, unless the prisoner
27 is under imminent danger of serious physical injury.” 28 U.S.C. § 1915(g).

E. Possible Dismissal

If Plaintiff fails to timely comply with every provision of this Order, including these warnings, the Court may dismiss this action without further notice. *See Ferdik*, 963 F.2d at 1260-61 (a district court may dismiss an action for failure to comply with any order of the Court).

IT IS ORDERED:

(1) Plaintiff’s Application to Proceed *In Forma Pauperis* (Doc. 2) is **granted**.


(2) As required by the accompanying Order to the appropriate government agency, Plaintiff must pay the \$350.00 filing fee and is not assessed an initial partial filing fee.

(3) The Complaint (Doc. 1) is **dismissed** for failure to state a claim. Plaintiff has **30 days** from the date this Order is filed to file a first amended complaint in compliance with this Order.

(4) If Plaintiff fails to file an amended complaint within 30 days, the Clerk of Court must, without further notice, enter a judgment of dismissal of this action with prejudice that states that the dismissal may count as a “strike” under 28 U.S.C. § 1915(g).

(5) The Clerk of Court must mail Plaintiff a court-approved form for filing a civil rights complaint by a prisoner.

**Instructions for a Prisoner Filing a Civil Rights Complaint
in the United States District Court for the District of Arizona**

1. Who May Use This Form. The civil rights complaint form is designed to help incarcerated persons prepare a complaint seeking relief for a violation of their federal civil rights. These complaints typically concern, but are not limited to, conditions of confinement. **This form should not be used to challenge your conviction or sentence.** If you want to challenge a state conviction or sentence, you should file a petition under 28 U.S.C. § 2254 for a writ of habeas corpus by a person in state custody. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment.

2. The Form. **Local Rule of Civil Procedure (LRCiv) 3.4(a) provides that complaints by incarcerated persons must be filed on the court-approved form.** The form must be typed or neatly handwritten. The form must be completely filled in to the extent applicable. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages, **but no more than fifteen additional pages**, of standard letter-sized paper. You must identify which part of the complaint is being continued and number all pages. If you do not fill out the form properly, you will be asked to submit additional or corrected information, which may delay the processing of your action. You do not need to cite law.

3. Your Signature. You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.

4. The Filing Fee. The filing fee for this action is \$350.00. If you are unable to immediately pay the filing fee, you may request leave to proceed *in forma pauperis*. Please review the “Information for Prisoners Seeking Leave to Proceed with a (Non-Habeas) Civil Action in Federal Court *In Forma Pauperis* Pursuant to 28 U.S.C. § 1915” for additional instructions.

5. Original and Judge’s Copy. You must send an **original plus one copy** of your complaint and of any other documents submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten.

6. Where to File. You should file your complaint in the division **where you were confined when your rights were allegedly violated.** See LRCiv 5.1(a) and 77.1(a). If you were confined in Maricopa, Pinal, Yuma, La Paz, or Gila County, file in the Phoenix Division. If you were confined in Apache, Navajo, Coconino, Mohave, or Yavapai County, file in the Prescott Division. If you were confined in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file in the Tucson Division. **Mail the original and one copy of the complaint with the \$350 filing fee or the application to proceed *in forma pauperis* to:**

7. Change of Address. You must immediately notify the Court and the defendants in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.**

8. Certificate of Service. You must furnish the defendants with a copy of any document you submit to the Court (except the initial complaint and application to proceed *in forma pauperis*). Each original document (except the initial complaint and application to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the defendants and the address to which it was mailed. See Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. A certificate of service should be in the following form:

9. Amended Complaint. If you need to change any of the information in the initial complaint, you must file an amended complaint. The amended complaint must be written on the court-approved civil rights complaint form. You may file one amended complaint without leave (permission) of Court before any defendant has answered your original complaint. See Fed. R. Civ. P. 15(a). After any defendant has filed an answer, you must file a motion for leave to amend and lodge (submit) a proposed amended complaint. LRCiv 15.1. In addition, an amended complaint may not incorporate by reference any part of your prior complaint. LRCiv 15.1(a)(2). **Any allegations or defendants not included in the amended complaint are considered dismissed.** All amended complaints are subject to screening under the Prison Litigation Reform Act; screening your amendment will take additional processing time.

10. Exhibits. You should not submit exhibits with the complaint or amended complaint. Instead, the relevant information should be paraphrased. You should keep the exhibits to use to support or oppose a motion to dismiss, a motion for summary judgment, or at trial.

11. Letters and Motions. It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

12. Completing the Civil Rights Complaint Form.

HEADING:

1. Your Name. Print your name, prison or inmate number, and institutional mailing address on the lines provided.
2. Defendants. If there are **four or fewer** defendants, print the name of each. If you name **more than four** defendants, print the name of the first defendant on the first line, write the words “and others” on the second line, and attach an additional page listing the names of **all** of the defendants. Insert the additional page after page 1 and number it “1-A” at the bottom.
3. Jury Demand. If you want a jury trial, you must write “JURY TRIAL DEMANDED” in the space below “CIVIL RIGHTS COMPLAINT BY A PRISONER.” Failure to do so may result in the loss of the right to a jury trial. A jury trial is not available if you are seeking only injunctive relief.

Part A. JURISDICTION:

1. Nature of Suit. Mark whether you are filing the complaint pursuant to 42 U.S.C. § 1983 for state, county, or city defendants; “Bivens v. Six Unknown Federal Narcotics Agents” for federal defendants; or “other.” If you mark “other,” identify the source of that authority.
2. Location. Identify the institution and city where the alleged violation of your rights occurred.
3. Defendants. Print all of the requested information about each of the defendants in the spaces provided. If you are naming more than four defendants, you must provide the necessary information about each additional defendant on separate pages labeled “2-A,” “2-B,” etc., at the bottom. Insert the additional page(s) immediately behind page 2.

Part B. PREVIOUS LAWSUITS:

You must identify any other lawsuit you have filed in either state or federal court while you were a prisoner. Print all of the requested information about each lawsuit in the spaces provided. If you have filed more than three lawsuits, you must provide the necessary information about each additional lawsuit on a separate page. Label the page(s) as “2-A,” “2-B,” etc., at the bottom of the page and insert the additional page(s) immediately behind page 2.

Part C. CAUSE OF ACTION:

You must identify what rights each defendant violated. The form provides space to allege three separate counts (**one violation per count**). If you are alleging more than three counts, you must provide the necessary information about each additional count on a separate page. Number the additional pages “5-A,” “5-B,” etc., and insert them immediately behind page 5. Remember that you are limited to a total of fifteen additional pages.

1. Counts. You must identify which civil right was violated. **You may allege the violation of only one civil right per count.**
2. Issue Involved. Check the box that most closely identifies the issue involved in your claim. **You may check only one box per count.** If you check the box marked “Other,” you must identify the specific issue involved.
