ORDER FOR PAYMENT
OF INMATE FILING FEE

17 **TO: THE DIRECTOR OF THE ARIZONA DEPARTMENT OF CORRECTIONS**

18 Plaintiff Eduardo Ramirez-Garcia, inmate #225690, who is confined in the
19 Arizona State Prison Complex-Florence, must pay the statutory filing fee of \$350.00.
20 Plaintiff must first pay an initial partial filing fee of \$0.23. Thereafter, Plaintiff must pay
21 the balance of the fee in monthly payments of 20% of the preceding month's income
22 credited to Plaintiff's trust account.

23 The Director of the Arizona Department of Corrections or his/her designee must
24 collect and forward these payments to the Clerk of Court each time the amount in the
25 account exceeds \$10.00.

26 **IT IS ORDERED:**

27 (1) The Director of the Arizona Department of Corrections or his/her designee
28 must forward to the Clerk of Court the initial partial filing fee of \$0.23. The balance of

1 the \$350.00 filing fee must be collected from Plaintiff's trust account in monthly
2 payments of 20% of the preceding month's income credited to the account. Payments
3 must be forwarded to the Clerk of Court each time the amount in the account exceeds
4 \$10.00. The payments must be clearly identified by the name and number assigned to
5 this action.

6 (2) The Director of the Arizona Department of Corrections or his/her designee
7 must notify the Clerk of Court in writing when Plaintiff is released or transferred to a
8 correctional institution other than the Arizona State Prison Complex-Florence, so new
9 billing arrangements may be made to collect any outstanding balance.

10 (3) The Clerk of Court must serve by mail a copy of this Order on the Director
11 of the Arizona Department of Corrections, 1601 West Jefferson, Phoenix, Arizona,
12 85007.

13 (4) The Clerk of Court must forward a copy of this Order to Financial
14 Administration for the Phoenix Division of the United States District Court for the
15 District of Arizona. Financial Administration must set up an account to receive payments
16 on the filing fee for this action and must notify the Court when the filing fee is paid in
17 full.
