15 Plaintiff John Calvin Neuendorf, II, who is confined in the Arizona State Prison  
16 Complex-Eyman, filed a *pro se* civil rights Complaint pursuant to 42 U.S.C. § 1983 and a  
17 deficient Application to Proceed *In Forma Pauperis*. On March 26, 2013, the Court  
18 denied the Application to Proceed and dismissed the action under the "three strikes"  
19 provision of 28 U.S.C. § 1915(g). On April 5, 2013, Plaintiff filed a Motion for  
20 Reconsideration (Doc. 10) in which he argued that the dismissal under § 1915(g) was in  
21 error. On May 21, 2013, Plaintiff filed a Notice of Appeal.

22 In a July 17, 2013 Order, the Court granted the Motion for Reconsideration and  
23 gave Plaintiff 30 days within which to file a complete Application to Proceed *In Forma*  
24 *Pauperis*. On September 19, 2013, Plaintiff's Appeal was dismissed for lack of  
25 jurisdiction. On November 4, 2013, Plaintiff filed a second appeal.

26 Pending before the Court is Plaintiff's August 26, 2013, incomplete Application to  
27 Proceed *In Forma Pauperis* (Doc. 26). The Court will deny the deficient Application and  
28

1 give Plaintiff a final 30 days to pay the filing fee or file a complete Application to  
2 Proceed *In Forma Pauperis*.

3 **I. Payment of Filing Fee**

4 When bringing an action, a prisoner must either pay the \$350.00 filing fee in a  
5 lump sum or, if granted the privilege of proceeding *in forma pauperis*, pay the fee  
6 incrementally as set forth in 28 U.S.C. § 1915(b)(1). An application to proceed *in forma*  
7 *pauperis* requires an affidavit of indigence and a *certified* copy of the inmate's trust  
8 account statement for the six months preceding the filing of the Complaint. 28 U.S.C.  
9 § 1915(a)(2). An inmate must submit statements from each institution where the inmate  
10 was confined during the six-month period. *Id.* To assist prisoners in meeting these  
11 requirements, the Court requires use of a form application. LRCiv 3.4.

12 If a prisoner is granted leave to proceed *in forma pauperis*, the Court will assess an  
13 initial partial filing fee of 20% of either the average monthly deposits or the average  
14 monthly balance in Plaintiff's account, whichever is greater. 28 U.S.C. § 1915(b)(1). An  
15 initial partial filing fee will only be collected when funds exist. 28 U.S.C. § 1915(b)(4).  
16 The balance of the fee will be collected in monthly payments of 20% of the preceding  
17 month's income credited to an inmate's account, each time the amount in the account  
18 exceeds \$10.00. 28 U.S.C. § 1915(b)(2).

19 **II. Application Fails to Comply With Statute**

20 Plaintiff's Application to Proceed was filed on the court-approved form, but the  
21 "Certificate of Correctional Official as to Status of Applicant's Trust Account" section is  
22 not completed and Plaintiff has not submitted a certified six-month trust account  
23 statement. In light of these deficiencies, the Court will give Plaintiff 30 days to either  
24 pay the \$350.00 filing fee or file a complete Application to Proceed *In Forma Pauperis*.

25 The Arizona Department of Corrections ("ADOC") has notified the Court that a  
26 certified trust fund account statement showing deposits and average monthly balances is  
27 available from the ADOC's Central Office. *Accordingly, Plaintiff must obtain the*  
28

1 *certified copy of his ADOC trust fund account statement for the six months immediately*  
2 *preceding the filing of the Complaint from the ADOC's Central Office.*

### 3 **III. Motions**

4 On August 14, 2013, Plaintiff filed a Motion to Amend/Correct seeking  
5 permission to file an amended complaint. The Court will grant the Motion and give  
6 Plaintiff 30 days within which to file an amended complaint. However, Plaintiff should  
7 note that if he does not comply with the *in forma pauperis* requirements, the Court will  
8 not review an amended complaint and will dismiss this action.

9 On September 4, 2013, Plaintiff filed a Motion for Clarification in which he  
10 requests the filing status of several documents. The Court will grant the Motion to the  
11 extent that the Court will direct the Clerk of Court to send Plaintiff a copy of the docket  
12 for this case. The Court will deny the Motion with respect to all other relief requested.  
13 To the extent he requests copies of documents, Plaintiff should note that the Clerk of  
14 Court charges 50 cents per page for reproducing any record or paper. *See* Judicial  
15 Conference Schedule of Fees ¶ 4, foll. 28 U.S.C. § 1914. An inmate has no right to free  
16 copies of pleadings. *See In Re Richard*, 914 F.2d 1526, 127 (6th Cir. 1990) (*per curiam*)  
17 (28 U.S.C. § 1915 “does not give a litigant a right to have documents copied and returned  
18 to him at government expense”).

19 On November 4, 2013, Plaintiff filed a Motion to Appoint Counsel. There is no  
20 constitutional right to the appointment of counsel in a civil case. *See Ivey v. Bd. of*  
21 *Regents of the Univ. of Alaska*, 673 F.2d 266, 269 (9th Cir. 1982). In proceedings *in*  
22 *forma pauperis*, the court may request an attorney to represent any person unable to  
23 afford one. 28 U.S.C. § 1915(e)(1). Appointment of counsel under 28 U.S.C.  
24 § 1915(e)(1) is required only when “exceptional circumstances” are present. *Terrell v.*  
25 *Brewer*, 935 F.2d 1015, 1017 (9th Cir. 1991). A determination with respect to  
26 exceptional circumstances requires an evaluation of the likelihood of success on the  
27 merits as well as the ability of Plaintiff to articulate his claims *pro se* in light of the  
28 complexity of the legal issue involved. *Id.* “Neither of these factors is dispositive and

1 both must be viewed together before reaching a decision.” *Id.* (quoting *Wilborn v.*  
2 *Escalderon*, 789 F.2d 1328, 1331 (9th Cir. 1986)).

3 Having considered both elements, it does not appear at this time that exceptional  
4 circumstances are present that would require the appointment of counsel in this case.  
5 Plaintiff is in no different position than many *pro se* prisoner litigants. The Court will  
6 deny without prejudice Plaintiff’s Motion to Appoint Counsel.

7 **IV. Warnings**

8 **A. Address Changes**

9 Plaintiff must file and serve a notice of a change of address in accordance with  
10 Rule 83.3(d) of the Local Rules of Civil Procedure. Plaintiff must not include a motion  
11 for other relief with a notice of change of address. Failure to comply may result in  
12 dismissal of this action.

13 **B. Copies**

14 Because Plaintiff is currently confined in ASPC-Eyman and this case is subject to  
15 General Order 12-25, Plaintiff is not required to submit an additional copy of every filing  
16 for use by the Court, as would ordinarily be required by Local Rule of Civil Procedure  
17 5.4. If Plaintiff is transferred to a prison other than ASPC-Eyman, he will be notified of  
18 the requirements regarding copies for the Court that are required for inmates whose cases  
19 are not subject to General Order 12-25.

20 **C. Possible Dismissal**

21 If Plaintiff fails to timely comply with every provision of this Order, including  
22 these warnings, the Court may dismiss this action without further notice. *See Ferdik v.*  
23 *Bonzelet*, 963 F.2d 1258, 1260-61 (9th Cir. 1992) (a district court may dismiss an action  
24 for failure to comply with any order of the Court).

25 **IT IS ORDERED:**

26 (1) Plaintiff’s August 26, 2013 Application to Proceed *In Forma Pauperis*  
27 (Doc. 27) is **denied**.

28

1 (2) Within 30 days of the date this Order is filed, Plaintiff must either pay the  
2 \$350.00 filing fee **or** file a complete Application to Proceed *In Forma Pauperis* **and a**  
3 **certified six-month trust account statement.**

4 (3) If Plaintiff fails to either pay the \$350.00 filing fee or file a complete  
5 Application to Proceed *In Forma Pauperis* within 30 days, the Clerk of Court must enter  
6 a judgment of dismissal of this action without prejudice and without further notice to  
7 Plaintiff.

8 (4) Plaintiff's August 14, 2013 Motion to Amend/Correct (Doc. 26) is **granted.**  
9 Plaintiff has 30 days from the filing date of this Order to file an amended complaint on  
10 the court-approved form.

11 (5) Plaintiff's September 4, 2013 Motion for Clarification (Doc. 28) is **granted**  
12 to the extent that the Clerk of Court must send Plaintiff a copy of the docket for this case.  
13 The Motion is **denied** with respect to all other relief requested.

14 (6) Plaintiff's October 29, 2013 Motion to Appoint Counsel (Doc. 30) is  
15 **denied.**

16 (7) The Clerk of the Court must mail Plaintiff a court-approved forms for  
17 filing an Application to Proceed *In Forma Pauperis* (Non-Habeas) **and** a civil rights  
18 complaint by a prisoner.

**Instructions for Prisoners Applying for Leave to Proceed *in Forma Pauperis*  
Pursuant to 28 U.S.C. § 1915 in a Civil Action (Non-habeas) in Federal Court**

You must pay the \$350.00 filing fee plus the \$50.00 administrative fees for a civil action. If you later file an appeal, you will be obligated to pay the \$455.00 filing fee for the appeal.

If you have enough money to pay the full \$400.00 filing and administrative fees, you should send a cashier's check or money order payable to the Clerk of the Court with your complaint.

If you do not have enough money to pay the full \$400.00 filing and administrative fees, you can file the action without prepaying the fees. However, the court will assess an initial partial filing fee. The initial partial filing fee will be the greater of 20% of the average monthly deposits or 20% of the average monthly balance in your prison or jail account for the six months immediately preceding the filing of the lawsuit. The court will order the agency that has custody of you to withdraw the initial partial filing fee from your prison or jail account as soon as funds are available and to forward the money to the court.

After the initial partial filing fee has been paid, you will owe the balance of the \$350.00 filing fee (you will not be required to pay the \$50.00 administrative fee). Until the filing fee is paid in full, each month you will owe 20% of your preceding month's income. The agency that holds you in custody will collect that money and forward it to the court any time the amount in your account exceeds \$10.00. The balance of the filing fee may be collected even if the action is later dismissed, summary judgment is granted against you, or you fail to prevail at trial.

To file an action without prepaying the filing fee, and to proceed with an action *in forma pauperis*, you must complete the attached form and return it to the court with your complaint. You must have a prison or jail official complete the certificate on the bottom of the form and attach a certified copy of your prison or jail account statement for the last six months. If you were incarcerated in a different institution during any part of the past six months, you must attach a certificate and a certified copy of your account statement from each institution at which you were confined. If you submit an incomplete form or do not submit a prison or jail account statement with the form, your request to proceed *in forma pauperis* will be denied.

Even if some or all of the filing fee has been paid, the court is required to dismiss your action if: (1) your allegation of poverty is untrue; (2) the action is frivolous or malicious; (3) your complaint does not state a claim upon which relief can be granted; or (4) your complaint makes a claim against a defendant for money damages and that defendant is immune from liability for money damages.

If you file more than three actions or appeals which are dismissed as frivolous or malicious or for failure to state a claim on which relief can be granted, you will be prohibited from filing any other action *in forma pauperis* unless you are in imminent danger of serious physical injury.

**Instructions for a Prisoner Filing a Civil Rights Complaint  
in the United States District Court for the District of Arizona**

1. Who May Use This Form. The civil rights complaint form is designed to help incarcerated persons prepare a complaint seeking relief for a violation of their federal civil rights. These complaints typically concern, but are not limited to, conditions of confinement. **This form should not be used to challenge your conviction or sentence.** If you want to challenge a state conviction or sentence, you should file a petition under 28 U.S.C. § 2254 for a writ of habeas corpus by a person in state custody. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment.
  
2. The Form. **Local Rule of Civil Procedure (LRCiv) 3.4(a) provides that complaints by incarcerated persons must be filed on the court-approved form.** The form must be typed or neatly handwritten. The form must be completely filled in to the extent applicable. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages, **but no more than fifteen additional pages**, of standard letter-sized paper. You must identify which part of the complaint is being continued and number all pages. If you do not fill out the form properly, you will be asked to submit additional or corrected information, which may delay the processing of your action. You do not need to cite law.
  
3. Your Signature. You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.
  
4. The Filing Fee. The filing fee for this action is \$350.00. If you are unable to immediately pay the filing fee, you may request leave to proceed *in forma pauperis*. Please review the “Information for Prisoners Seeking Leave to Proceed with a (Non-Habeas) Civil Action in Federal Court *In Forma Pauperis* Pursuant to 28 U.S.C. § 1915” for additional instructions.
  
5. Original and Judge’s Copy. You must send an **original plus one copy** of your complaint and of any other documents submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten.
  
6. Where to File. You should file your complaint in the division **where you were confined when your rights were allegedly violated.** See LRCiv 5.1(a) and 77.1(a). If you were confined in Maricopa, Pinal, Yuma, La Paz, or Gila County, file in the Phoenix Division. If you were confined in Apache, Navajo, Coconino, Mohave, or Yavapai County, file in the Prescott Division. If you were confined in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file in the Tucson Division. **Mail the original and one copy of the complaint with the \$350 filing fee or the application to proceed *in forma pauperis* to:**

7. Change of Address. You must immediately notify the Court and the defendants in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.**

8. Certificate of Service. You must furnish the defendants with a copy of any document you submit to the Court (except the initial complaint and application to proceed *in forma pauperis*). Each original document (except the initial complaint and application to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the defendants and the address to which it was mailed. See Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. A certificate of service should be in the following form:

9. Amended Complaint. If you need to change any of the information in the initial complaint, you must file an amended complaint. The amended complaint must be written on the court-approved civil rights complaint form. You may file one amended complaint without leave (permission) of Court before any defendant has answered your original complaint. See Fed. R. Civ. P. 15(a). After any defendant has filed an answer, you must file a motion for leave to amend and lodge (submit) a proposed amended complaint. LRCiv 15.1. In addition, an amended complaint may not incorporate by reference any part of your prior complaint. LRCiv 15.1(a)(2). **Any allegations or defendants not included in the amended complaint are considered dismissed.** All amended complaints are subject to screening under the Prison Litigation Reform Act; screening your amendment will take additional processing time.

10. Exhibits. You should not submit exhibits with the complaint or amended complaint. Instead, the relevant information should be paraphrased. You should keep the exhibits to use to support or oppose a motion to dismiss, a motion for summary judgment, or at trial.

11. Letters and Motions. It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

## 12. Completing the Civil Rights Complaint Form.

### **HEADING:**

1. Your Name. Print your name, prison or inmate number, and institutional mailing address on the lines provided.
2. Defendants. If there are **four or fewer** defendants, print the name of each. If you name **more than four** defendants, print the name of the first defendant on the first line, write the words “and others” on the second line, and attach an additional page listing the names of **all** of the defendants. Insert the additional page after page 1 and number it “1-A” at the bottom.
3. Jury Demand. If you want a jury trial, you must write “JURY TRIAL DEMANDED” in the space below “CIVIL RIGHTS COMPLAINT BY A PRISONER.” Failure to do so may result in the loss of the right to a jury trial. A jury trial is not available if you are seeking only injunctive relief.

### **Part A. JURISDICTION:**

1. Nature of Suit. Mark whether you are filing the complaint pursuant to 42 U.S.C. § 1983 for state, county, or city defendants; “Bivens v. Six Unknown Federal Narcotics Agents” for federal defendants; or “other.” If you mark “other,” identify the source of that authority.
2. Location. Identify the institution and city where the alleged violation of your rights occurred.
3. Defendants. Print all of the requested information about each of the defendants in the spaces provided. If you are naming more than four defendants, you must provide the necessary information about each additional defendant on separate pages labeled “2-A,” “2-B,” etc., at the bottom. Insert the additional page(s) immediately behind page 2.

### **Part B. PREVIOUS LAWSUITS:**

You must identify any other lawsuit you have filed in either state or federal court while you were a prisoner. Print all of the requested information about each lawsuit in the spaces provided. If you have filed more than three lawsuits, you must provide the necessary information about each additional lawsuit on a separate page. Label the page(s) as “2-A,” “2-B,” etc., at the bottom of the page and insert the additional page(s) immediately behind page 2.

### **Part C. CAUSE OF ACTION:**

You must identify what rights each defendant violated. The form provides space to allege three separate counts (**one violation per count**). If you are alleging more than three counts, you must provide the necessary information about each additional count on a separate page. Number the additional pages “5-A,” “5-B,” etc., and insert them immediately behind page 5. Remember that you are limited to a total of fifteen additional pages.

1. Counts. You must identify which civil right was violated. **You may allege the violation of only one civil right per count.**

2. Issue Involved. Check the box that most closely identifies the issue involved in your claim. **You may check only one box per count.** If you check the box marked “Other,” you must identify the specific issue involved.

3. Supporting Facts. After you have identified which civil right was violated, you must state the supporting facts. Be as specific as possible. You must state what each individual defendant did to violate your rights. If there is more than one defendant, you must identify which defendant did what act. You also should state the date(s) on which the act(s) occurred, if possible.

4. Injury. State precisely how you were injured by the alleged violation of your rights.

5. Administrative Remedies. You must exhaust any available administrative remedies before you file a civil rights complaint. See 42 U.S.C. § 1997e. Consequently, you should disclose whether you have exhausted the inmate grievance procedures or administrative appeals for each count in your complaint. If the grievance procedures were not available for any of your counts, fully explain why on the lines provided.

**Part D. REQUEST FOR RELIEF:**

Print the relief you are seeking in the space provided.

**SIGNATURE:**

You must sign your name and print the date you signed the complaint. Failure to sign the complaint will delay the processing of your action. Unless you are an attorney, you may not bring an action on behalf of anyone but yourself.

**FINAL NOTE**

You should follow these instructions carefully. Failure to do so may result in your complaint being stricken or dismissed. All questions must be answered concisely in the proper space on the form. If you need more space, you may attach no more than fifteen additional pages. But the form must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the complaint is being continued and number the pages.
