**ORDER FOR PAYMENT**  
**OF INMATE FILING FEE**

15 **TO: THE DIRECTOR OF THE ARIZONA DEPARTMENT OF CORRECTIONS**

16 Plaintiff Anthony Jackson, inmate #161243, who is confined in the Arizona State  
17 Prison Complex-Lewis, must pay the statutory filing fee of \$350.00. Plaintiff is not  
18 assessed an initial partial filing fee. Plaintiff must pay the filing fee in monthly payments  
19 of 20% of the preceding month's income credited to Plaintiff's trust account. The  
20 Director of the Arizona Department of Corrections or his/her designee must collect and  
21 forward these payments to the Clerk of Court each time the amount in the account  
22 exceeds \$10.00.

23 **IT IS ORDERED:**

24 (1) The Director of the Arizona Department of Corrections or his/her designee  
25 must collect the \$350.00 filing fee from Plaintiff's trust account in monthly payments of  
26 20% of the preceding month's income the account. Payments must be forwarded to the  
27 Clerk of Court each time the amount in the account exceeds \$10.00. The payments must  
28 be clearly identified by the name and number assigned to this action.

1           (2)    The Director of the Arizona Department of Corrections or his/her designee  
2 must notify the Clerk of Court in writing when Plaintiff is released or transferred to a  
3 correctional institution other than the Arizona State Prison Complex-Lewis, so new  
4 billing arrangements may be made to collect any outstanding balance.

5           (3)    The Clerk of Court must serve by mail a copy of this Order on the Director  
6 of the Arizona Department of Corrections, 1601 West Jefferson, Phoenix, Arizona,  
7 85007.

8           (4)    The Clerk of Court must forward a copy of this Order to Financial  
9 Administration for the Phoenix Division of the United States District Court for the  
10 District of Arizona. Financial Administration must set up an account to receive payments  
11 on the filing fee for this action and must notify the Court when the filing fee is paid in  
12 full.
