**ORDER**

On July 11, 2013, Petitioner Brian Odell Hopson, who is confined in the Arizona State Prison Complex-Tucson, filed a “Motion for Extension of Time to File Petition for Writ of Habeas Corpus” (Doc. 1). On August 12, 2013, Petitioner filed an Application to Proceed *In Forma Pauperis*, lodged a *pro se* Petition Under 28 U.S.C. § 2254 for a Writ of Habeas Corpus by a Person in State Custody, and lodged a Memorandum in Support of Writ of Habeas Corpus.

**I. Motion for Extension of Time**

In his Motion for Extension of Time, Petitioner asks that the Court grant him an additional 30 to 90 days within which to file a habeas petition. Petitioner is essentially asking the Court to toll the statute of limitations and deem Petitioner’s Petition as timely filed. The Court will not rule on the issue of whether Petitioner filed within the statute of limitations before Respondents have been served. The Court will therefore deny the Motion for Extension of Time.

1           The Court will direct the Clerk of Court to file the Petition and Memorandum in  
2 Support with the filing date of August 12, 2013, the date the Court received the Petition.

3 **II.    Application to Proceed *In Forma Pauperis***

4           Petitioner’s Application to Proceed to Proceed *In Forma Pauperis* indicates that  
5 his inmate trust account balance is less than \$25.00. Accordingly, the Application to  
6 Proceed *In Forma Pauperis* will be granted. See LRCiv 3.5(b).

7 **III.   Petition**

8           Petitioner challenges his conviction in Maricopa County Superior Court, case  
9 number CR 2009-120677-001DT for four counts of aggravated assault. Petitioner was  
10 sentenced to a 20-year term of imprisonment. Petitioner names Charles Ryan as  
11 Respondent and the Arizona Attorney General as an additional Respondent.

12           Petitioner raises two claims for relief:

- 13           (1)   “Erroneous prejudicial procedural-denial with respect to Ariz. Court of  
14 Appeals, Div. 1, special action petition, . . . being denied review in Ariz.  
15 Supreme Court, . . . unduly denying defendant relief on the merits put-forth  
16 theretofore. As such constitutes unreasonable determination of the factual  
17 evidence represented thereupon, and misapplication contrary to constitution  
18 due process/equal protection of laws”; and  
19           (2)   “Erroneous prejudicial procedural-denial, with respect to Ariz. Supreme  
20 Court dismissing new petition for special action, . . . thereby denying  
21 defendant du[e] relief on the merits of U.S. Constitutional/Federal and state  
22 law issues put forth.”

23 **IV.   Dismissal with Leave to Amend**

24           Pursuant to 28 U.S.C. § 2254, “a district court shall entertain an application for  
25 writ of habeas corpus in behalf of a person in custody pursuant to the judgment of a State  
26 court only on the ground that he is in custody in violation of the Constitution or laws or  
27 treaties of the United States.” In this case, Petitioner alleges that the Arizona Court of  
28 Appeals and Arizona Supreme Court failed to follow state law when declining review of  
his state actions. Petitioner does not describe how this denial of review violated his  
federal constitutional rights, nor does he allege that his conviction and sentence were in

1 violation of his federal constitutional rights. Accordingly, the Court will dismiss the  
2 Petition with leave to amend.

3 Within 30 days, Petitioner may submit a first amended petition to cure the  
4 deficiencies outlined above. The Clerk of Court will mail Petitioner a court-approved  
5 form to use for filing an amended petition.

6 Petitioner's amended petition should clearly set out each claim Petitioner is  
7 making and should also provide information as to how Petitioner has first exhausted his  
8 state-court remedies as to each and every claim. If Petitioner cannot fit all of his  
9 supporting facts or arguments in favor of a particular ground on the court-approved form,  
10 then he may continue on an attachment, but each matter on any attachment must be  
11 clearly referenced to a particular ground on the court-approved form. **Petitioner must**  
12 **attach supporting exhibits and documents to the end of his amended petition.**

13 Petitioner is cautioned that if he fails to file his amended petition on the court-  
14 approved form included with this Order, it will be stricken and the action dismissed  
15 without further notice to Petitioner.

16 Petitioner is advised that the amended petition must be retyped or rewritten in its  
17 entirety on the court-approved form and may not incorporate any part of the original  
18 Petition by reference. Any amended petition submitted by Petitioner should be clearly  
19 designated as such on the face of the document.

20 An amended petition supersedes the original Petition. *Ferdik v. Bonzelet*, 963  
21 F.2d 1258, 1262 (9th Cir. 1992); *Hal Roach Studios v. Richard Feiner & Co., Inc.*, 896  
22 F.2d 1542, 1546 (9th Cir. 1990). After amendment, the original pleading is treated as  
23 nonexistent. *Ferdik*, 963 F.2d at 1262. Accordingly, grounds for relief alleged in the  
24 Petition which are not alleged in an amended petition are waived. *King v. Atiyeh*, 814  
25 F.2d 565, 567 (9th Cir. 1987).

## 26 **V. Warnings**

### 27 **A. Address Changes**

28 Petitioner must file and serve a notice of a change of address in accordance with

1 Rule 83.3(d) of the Local Rules of Civil Procedure. Petitioner must not include a motion  
2 for other relief with a notice of change of address. Failure to comply may result in  
3 dismissal of this action.

4 **B. Copies**

5 Plaintiff must submit an additional copy of every filing for use by the Court. *See*  
6 LRCiv 5.4. Failure to comply may result in the filing being stricken without further  
7 notice to Plaintiff.

8 **C. Possible Dismissal**

9 If Petitioner fails to timely comply with every provision of this Order, including  
10 these warnings, the Court may dismiss this action without further notice. *See Ferdik*, 963  
11 F.2d at 1260-61 (a district court may dismiss an action for failure to comply with any  
12 order of the Court).

13 **IT IS ORDERED:**

14 (1) Petitioner's July 11, 2013 Motion for Extension of Time (Doc. 1) is **denied**.

15 (2) The Clerk of Court **must file** the Petition for Writ of Habeas Corpus and  
16 Memorandum in Support of Petition for Writ of Habeas Corpus with the filing date of  
17 August 12, 2013.

18 (3) Petitioner's Application to Proceed *In Forma Pauperis* (Doc. 3) is **granted**.

19 (4) The Petition is **dismissed** with leave to amend; Petitioner has 30 days from  
20 the date this Order is signed to file an amended petition on a court-approved form.

21 (5) The Clerk of Court must enter a judgment of dismissal of this action  
22 without prejudice, without further notice to Petitioner, if Petitioner fails to file an  
23 amended petition within 30 days from the date this Order is signed.

**Instructions for Filing a Petition Under 28 U.S.C. § 2254  
for a Writ of Habeas Corpus by a Person in State Custody  
in the United States District Court for the District of Arizona**

1. Who May Use This Form. To use this form, you must be a person who is currently serving a sentence under a judgment against you in a state court. You are asking for relief from the conviction or the sentence on the grounds that your conviction or sentence violates the United States Constitution or other federal law. You also may use this form to challenge a state judgment that imposed a sentence to be served in the future, but you must fill in the name of the state where the judgment was entered. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment. **This form should not be used in death penalty cases.** If you were sentenced to death, you are entitled to the assistance of counsel and you should request the appointment of counsel.
2. The Form. **Local Rule of Civil Procedure (LRCiv) 3.5(a) provides that habeas corpus petitions must be filed on the court-approved form.** The form must be typed or neatly handwritten. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages. The form, however, must be completely filled in to the extent applicable. You do not need to cite law. If you want to file a brief or arguments, you must attach a separate memorandum.
3. Your Signature. You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.
4. The Filing Fee. The filing fee for this action is \$5.00. If you are unable to pay the filing fee, you may request permission to proceed *in forma pauperis* by completing and signing the Application to Proceed *In Forma Pauperis* provided with the petition form. You must have an official at the prison or jail complete the certificate at the bottom of the application form. If the amount of money in your account exceeds \$25.00, you must pay the \$5.00 filing fee. LRCiv 3.5(b).
5. Original and Judge's Copy. You must send an **original plus one copy** of your petition and of any other document submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten.
6. Where to File. You should **file your petition in the division where you were convicted.** See LRCiv 5.1(b). If you are challenging a judgment of conviction entered in Maricopa, Pinal, Yuma, La Paz, or Gila County, file your petition in the Phoenix Division. If you are challenging a judgment of conviction entered in Apache, Navajo, Coconino, Mohave, or Yavapai County, file your petition in the Prescott Division. If you are challenging a judgment of conviction entered in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file your petition in the Tucson Division. See LRCiv 5.1(b) and 77.1(a).

7. Change of Address. You must immediately notify the Court and respondents in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.**

8. Certificate of Service. You must provide the respondents with a copy of any document you submit to the Court (except the initial petition and application to proceed *in forma pauperis*). Each original document (except the initial petition and application to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the respondents and the address to which it was mailed. Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. A certificate of service should be in the following form:

9. Amended Petition. If you need to change any of the information in the initial petition, you must file an amended petition. The amended petition must be written on the court-approved form. You may file one amended petition without leave (permission) of Court before any respondent has answered your original petition. See Fed. R. Civ. P. 15(a). After any respondent has filed an answer, you must file a motion for leave to amend and lodge (submit) a proposed amended petition. LRCiv 15.1. An amended petition may not incorporate by reference any part of your prior petition. LRCiv 15.1(a)(2). **Any grounds not included in the amended petition are considered dismissed.**

10. Exhibits. If available, you should attach a copy of all state and federal court written decisions regarding the conviction you are challenging. Do **not** submit any other exhibits with the petition. Instead, you should paraphrase the relevant information in the petition.

11. Letters and Motions. It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

12. Warnings.

- a. Judgment Entered by a Single Court. You may challenge the judgment entered by only one court. Multiple counts which resulted in a judgment by the same court may be challenged in the same petition. If you wish to challenge judgments entered by more than one court, however, you must file separate petitions for each judgment.
- b. Grounds for Relief. You must raise all grounds for relief that relate to this conviction or sentence. Any grounds not raised in this petition will likely be barred from being raised in any subsequent federal action.
- c. Exhaustion. In order to proceed in federal court, you ordinarily must exhaust the remedies available to you in the state courts as to each claim on which you request action by the federal court. If you did not fairly present each of your grounds to the Arizona Court of Appeals, your petition may be dismissed. If you did not present one or more of your grounds to the Arizona Court of Appeals, explain why you did not.

**FINAL NOTE**

You should follow these instructions carefully. Failure to do so may result in your petition being stricken or dismissed by the Court. All questions must be answered concisely in the proper space on the form. If you need more space, you may attach additional pages. But the form must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the petition is being continued and number all pages.

\*Section 2244(d) provides in part that:

(1) A 1-year period of limitation shall apply to an application for a writ of habeas corpus by a person in custody pursuant to the judgment of a State court. The limitation period shall run from the latest of-

(A) the date on which the judgment became final by the conclusion of direct review or the expiration of the time for seeking such review;

(B) the date on which the impediment to filing an application created by State action in violation of the Constitution or laws of the United States is removed, if the applicant was prevented from filing by such State action;

(C) the date on which the constitutional right asserted was initially recognized by the Supreme Court, if the right has been newly recognized by the Supreme Court and made retroactively applicable to cases on collateral review; or

(D) the date on which the factual predicate of the claim or claims presented could have been discovered through the exercise of due diligence.

(2) The time during which a properly filed application for State post-conviction or other collateral review with respect to the pertinent judgment or claim is pending shall not be counted toward any period of limitation under this subsection.
