ORDER FOR PAYMENT
OF INMATE FILING FEE

15 **TO: MARICOPA COUNTY SHERIFF JOSEPH M. ARPAIO**

16 Plaintiff Jeffrey Alan Taylor, inmate #P897880, who is confined in the Lower
17 Buckeye Jail, must pay the statutory filing fee of \$350.00. Plaintiff must first pay an
18 initial partial filing fee of \$6.10. Thereafter, Plaintiff must pay the balance of the fee in
19 monthly payments of 20% of the preceding month's income credited to Plaintiff's trust
20 account.

21 Maricopa County Sheriff Joseph M. Arpaio or his designee must collect and
22 forward these payments to the Clerk of Court each time the amount in the account
23 exceeds \$10.00.

24 **IT IS ORDERED:**

25 (1) Maricopa County Sheriff Joseph M. Arpaio or his designee must forward to
26 the Clerk of Court the initial partial filing fee of \$6.10. The balance of the \$350.00 filing
27 fee must be collected from Plaintiff's trust account in monthly payments of 20% of the
28 preceding month's income credited to the account. Payments must be forwarded to the

1 Clerk of Court each time the amount in the account exceeds \$10.00. The payments must
2 be clearly identified by the name and number assigned to this action.

3 (2) Maricopa County Sheriff Joseph M. Arpaio or his designee must notify the
4 Clerk of Court in writing when Plaintiff is released or transferred to a correctional
5 institution other than the Lower Buckeye Jail, so new billing arrangements may be made
6 to collect any outstanding balance.

7 (3) The Clerk of Court must serve by mail a copy of this Order on the
8 Maricopa County Sheriff's Office, Office of Inmate Legal Services, 201 S. Fourth
9 Avenue, Phoenix, Arizona, 85003.

10 (4) The Clerk of Court must forward a copy of this Order to Financial
11 Administration for the Phoenix Division of the United States District Court for the
12 District of Arizona. Financial Administration must set up an account to receive payments
13 on the filing fee for this action and must notify the Court when the filing fee is paid in
14 full.
