ORDER

15 Pro se Plaintiff has filed an application to proceed in forma pauperis (“IFP”)
16 without prepaying fees or costs. Doc. 3. The Court will grant the motion. The Court
17 will screen Plaintiff’s complaint pursuant to 28 U.S.C. § 1915(e)(2) before it is allowed
18 to be served. Pursuant to that screening, Plaintiff’s complaint (Doc. 1) will be dismissed.

19 **I. Legal Standard.**

20 In IFP proceedings, a district court “shall dismiss the case at any time if the court
21 determines that ... the action ... fails to state a claim on which relief can be granted[.]”
22 28 U.S.C. § 1915(e)(2). While much of section 1915 concerns prisoner litigation, section
23 1915(e) applies to all IFP proceedings. *Lopez v. Smith*, 203 F.3d 1122, 1126 n. 7 (9th
24 Cir. 2000) (en banc). “Section 1915(e) (2)(B)(ii) ... allows a district court to dismiss[]
25 sua sponte ... a complaint that fails to state a claim[.]” *Id.* at 1130. A district court
26 dismissing under section 1915(e)(2)(B)(ii) “should grant leave to amend even if no
27 request to amend the pleading was made, unless it determines that the pleading could not
28 possibly be cured by the allegation of other facts.” *Id.* at 1127–29 (citations omitted).

1 Rule 8 of the Federal Rules of Civil Procedure provides that “[a] pleading that
2 states a claim for relief must contain ... a short and plain statement of the claim showing
3 that the pleader is entitled to relief.” Fed.R.Civ.P. 8(a). This short and plain statement
4 “need not contain detailed factual allegations; rather, it must plead ‘enough facts to state
5 a claim to relief that is plausible on its face.’” *Clemens v. DaimlerChrysler Corp.*, 534
6 F.3d 1017, 1022 (9th Cir.2008) (quoting *Bell Atl. Corp. v. Twombly*, 550 U.S. 544, 570
7 (2007)). Legal conclusions couched as factual allegations are not given a presumption of
8 truthfulness and “conclusory allegations of law and unwarranted inferences are not
9 sufficient.” *Pareto v. F.D.I.C.*, 139 F.3d 696, 699 (9th Cir.1998). Dismissal is
10 appropriate where the complaint lacks a cognizable legal theory, lacks sufficient facts
11 alleged under a cognizable legal theory, or contains allegations disclosing some absolute
12 defense or bar to recovery. See *Balistreri v. Pacifica Police Dept.*, 901 F.2d 696, 699
13 (9th Cir.1988); *Weisbuch v. County of L.A.*, 119 F.3d 778, 783, n. 1 (9th Cir.1997).

14 **II. Plaintiff's Complaint.**

15 The one-page complaint in this case names the United States Department of
16 Health and Human Services, the Arizona Healthcare Cost Containment System, the
17 Arizona Department of Economic Security, and the Arizona State Legislature as
18 Defendants. Doc. 1. It contains no factual allegations; it merely quotes two state statutes
19 and demands seven billion dollars. *Id.* The complaint fails to state a claim against any
20 named defendant.

21 **III. Leave to Amend and Plaintiff's Obligations.**

22 In this circuit, “[a] pro se litigant must be given leave to amend his or her
23 complaint unless it is absolutely clear that the deficiencies of the complaint could not be
24 cured by amendment.” *Karim–Panahi v. L.A. Police Dep't*, 839 F.2d 621, 623 (9th Cir.
25 1988). The Court will dismiss the complaint without prejudice and allow Plaintiff to file
26 an amended complaint that properly states a claim for relief. Plaintiff shall have until
27 **Friday, December 6, 2013** to file an amended complaint. If an amended complaint is
28 not filed by that date, the Clerk is directed to terminate this action without further order.

1 Plaintiff is advised that he must become familiar with, and follow, the Federal
2 Rules of Civil Procedure and the Rules of the United States District Court for the District
3 of Arizona (“Local Rules”), which may be obtained in the Clerk of Court's office. For
4 purposes of the amended complaint, Plaintiff is directed to Rule 8 of the Federal Rules of
5 Civil Procedure. Rule 8(a) provides that a complaint “must contain (1) a short and plain
6 statement of the grounds for the court's jurisdiction, ... (2) a short and plain statement of
7 the claim showing that the pleader is entitled to relief, and (3) a demand for the relief
8 sought.” Fed.R.Civ.P. 8(a). These pleading requirements shall be set forth in separate
9 and discrete paragraphs. Rule 8(d) provides that each such paragraph “must be simple,
10 concise, and direct.” Fed.R.Civ.P. 8(d)(1).

11 The “short and plain statement of the claim” required by Rule 8(a)(2) must not
12 only designate a cause of action, but must also include enough factual allegations to
13 render the claim plausible. If Plaintiff chooses to file an amended complaint asserting
14 constitutional violations by federal or state officials, his pleading should include a
15 statement of the constitutional rights Plaintiff believes to have been violated, how each
16 right was violated, how each defendant contributed to the violation, and what injury was
17 caused by each alleged constitutional violation. Such factual allegations must provide
18 enough information to “allow[] the court to draw the reasonable inference that the
19 defendant[s are] liable for the misconduct alleged.” *Iqbal*, 129 S.Ct. at 1149.

20 If Plaintiff fails to prosecute this action or to comply with the rules or any Court
21 order, the Court may dismiss the action with prejudice pursuant to Federal Rule of Civil
22 Procedure 41(b). *See Ferdik v. Bonzelet*, 963 F.2d 1258, 1260–61 (9th Cir.1992)
23 (holding that the district court did not abuse its discretion in dismissing a pro se plaintiff's
24 complaint for failing to comply with a court order).


25 **IT IS ORDERED:**
