**ORDER**

15 Plaintiff Chris Leroy Thinelk, who is confined in the Arizona State Prison  
16 Complex-Eyman in Florence, Arizona, has filed a *pro se* civil rights Complaint pursuant  
17 to 42 U.S.C. § 1983 and an Application to Proceed *In Forma Pauperis* (Doc. 2). The  
18 Court will deny the deficient Application to Proceed and will give Plaintiff 30 days to  
19 pay the filing and administrative fees or file a complete Application to Proceed *In Forma*  
20 *Pauperis*.

21 **I. Payment of Filing Fee**

22 When bringing an action, a prisoner must either pay the \$350.00 filing fee and a  
23 \$50.00 administrative fee in a lump sum or, if granted the privilege of proceeding *in*  
24 *forma pauperis*, pay the \$350.00 filing fee<sup>1</sup> incrementally as set forth in 28 U.S.C.

26 <sup>1</sup> Effective May 1, 2013, the Clerks of Court for the United States District Courts  
27 are required to collect a \$50.00 administrative fee for the filing of a civil action, suit, or  
28 proceeding in a district court. See Judicial Conference Schedule of Fees, District Court  
Miscellaneous Fee Schedule ¶14 (effective May 1, 2013), foll. 28 U.S.C. § 1914.  
However, the administrative fee “does not apply to applications for a writ of habeas  
corpus or to persons granted *in forma pauperis* status under 28 U.S.C. § 1915.” *Id.*

1 § 1915(b)(1). An application to proceed *in forma pauperis* requires an affidavit of  
2 indigence and a *certified* copy of the inmate’s trust account statement for the six months  
3 preceding the filing of the Complaint. 28 U.S.C. § 1915(a)(2). An inmate must submit  
4 statements from each institution where the inmate was confined during the six-month  
5 period. *Id.* To assist prisoners in meeting these requirements, the Court requires use of a  
6 form application. LRCiv 3.4.

7 If a prisoner is granted leave to proceed *in forma pauperis*, the Court will assess an  
8 initial partial filing fee of 20% of either the average monthly deposits or the average  
9 monthly balance in Plaintiff’s account, whichever is greater. 28 U.S.C. § 1915(b)(1). An  
10 initial partial filing fee will only be collected when funds exist. 28 U.S.C. § 1915(b)(4).  
11 The balance of the \$ 350.00 filing fee will be collected in monthly payments of 20% of  
12 the preceding month’s income credited to an inmate’s account, each time the amount in  
13 the account exceeds \$10.00. 28 U.S.C. § 1915(b)(2).

## 14 **II. Application Fails to Comply With Statute**

15 Plaintiff has used the court-approved form, but the “Certificate of Correctional  
16 Official as to Status of Applicant’s Trust Account” section has not been completed by a  
17 *correctional official*, and Plaintiff has not submitted a certified six-month trust account  
18 statement. In addition, Plaintiff, although answering under penalty of perjury, states in  
19 his Application that he has never brought an action or appeal in a federal court while  
20 incarcerated or detained. This is untrue. *See Thinelk v. Madden*, 12-CV-1789-PHX-RCB  
21 (SPL) (D. Ariz.); *Thinelk v. Madden*, 12-CV-1019-PHX-RCB (SPL) (D. Ariz.). In light  
22 of these deficiencies, the Court will deny the Application to Proceed and will give  
23 Plaintiff 30 days to either pay the \$400.00 filing and administrative fees or file a  
24 complete Application to Proceed *In Forma Pauperis*.

25 The Arizona Department of Corrections (“ADOC”) has notified the Court that a  
26 certified trust fund account statement showing deposits and average monthly balances is  
27 available from the ADOC’s Central Office. *Accordingly, Plaintiff must obtain the*

1 *certified copy of his ADOC trust fund account statement for the six months immediately*  
2 *preceding the filing of the Complaint from the ADOC's Central Office.*

3 **III. Warnings**

4 **A. Address Changes**

5 Plaintiff must file and serve a notice of a change of address in accordance with  
6 Rule 83.3(d) of the Local Rules of Civil Procedure. Plaintiff must not include a motion  
7 for other relief with a notice of change of address. Failure to comply may result in  
8 dismissal of this action.

9 **B. Copies**

10 Because Plaintiff is currently confined in ASPC-Eyman and this case is subject to  
11 General Order 13-19, Plaintiff is not required to submit an additional copy of every filing  
12 for use by the Court, as would ordinarily be required by Local Rule of Civil Procedure  
13 5.4. If Plaintiff is transferred to a prison other than ASPC-Eyman, he will be notified of  
14 the requirements regarding copies for the Court that are required for inmates whose cases  
15 are not subject to General Order 13-19.

16 **C. Possible Dismissal**

17 If Plaintiff fails to timely comply with every provision of this Order, including  
18 these warnings, the Court may dismiss this action without further notice. *See Ferdik v.*  
19 *Bonzelet*, 963 F.2d 1258, 1260-61 (9th Cir. 1992) (a district court may dismiss an action  
20 for failure to comply with any order of the Court).

21 **IT IS ORDERED:**

22 (1) Plaintiff's Application to Proceed *In Forma Pauperis* (Doc. 2) is **denied**  
23 **without prejudice.**

24 (2) Within 30 days of the date this Order is filed, Plaintiff must either pay the  
25 \$400.00 filing and administrative fees **or** file a complete Application to Proceed *In*  
26 *Forma Pauperis* and a certified six-month trust account statement.

27 (3) If Plaintiff fails to either pay the \$400.00 filing and administrative fees or  
28 file a complete Application to Proceed *In Forma Pauperis* within 30 days, the Clerk of

Court must enter a judgment of dismissal of this action without prejudice and without further notice to Plaintiff.

(4) The Clerk of the Court must mail Plaintiff a court-approved form for filing an Application to Proceed *In Forma Pauperis* (Non-Habeas).

**Instructions for Prisoners Applying for Leave to Proceed *in Forma Pauperis*  
Pursuant to 28 U.S.C. § 1915 in a Civil Action (Non-habeas) in Federal Court**

You must pay the \$350.00 filing fee plus the \$50.00 administrative fees for a civil action. If you later file an appeal, you will be obligated to pay the \$455.00 filing fee for the appeal.

If you have enough money to pay the full \$400.00 filing and administrative fees, you should send a cashier's check or money order payable to the Clerk of the Court with your complaint.

If you do not have enough money to pay the full \$400.00 filing and administrative fees, you can file the action without prepaying the fees. However, the court will assess an initial partial filing fee. The initial partial filing fee will be the greater of 20% of the average monthly deposits or 20% of the average monthly balance in your prison or jail account for the six months immediately preceding the filing of the lawsuit. The court will order the agency that has custody of you to withdraw the initial partial filing fee from your prison or jail account as soon as funds are available and to forward the money to the court.

After the initial partial filing fee has been paid, you will owe the balance of the \$350.00 filing fee (you will not be required to pay the \$50.00 administrative fee). Until the filing fee is paid in full, each month you will owe 20% of your preceding month's income. The agency that holds you in custody will collect that money and forward it to the court any time the amount in your account exceeds \$10.00. The balance of the filing fee may be collected even if the action is later dismissed, summary judgment is granted against you, or you fail to prevail at trial.

To file an action without prepaying the filing fee, and to proceed with an action *in forma pauperis*, you must complete the attached form and return it to the court with your complaint. You must have a prison or jail official complete the certificate on the bottom of the form and attach a certified copy of your prison or jail account statement for the last six months. If you were incarcerated in a different institution during any part of the past six months, you must attach a certificate and a certified copy of your account statement from each institution at which you were confined. If you submit an incomplete form or do not submit a prison or jail account statement with the form, your request to proceed *in forma pauperis* will be denied.

Even if some or all of the filing fee has been paid, the court is required to dismiss your action if: (1) your allegation of poverty is untrue; (2) the action is frivolous or malicious; (3) your complaint does not state a claim upon which relief can be granted; or (4) your complaint makes a claim against a defendant for money damages and that defendant is immune from liability for money damages.

If you file more than three actions or appeals which are dismissed as frivolous or malicious or for failure to state a claim on which relief can be granted, you will be prohibited from filing any other action *in forma pauperis* unless you are in imminent danger of serious physical injury.

### CONSENT TO COLLECTION OF FEES FROM TRUST ACCOUNT

Whenever the amount in my account reaches \$10.00, correctional officials will withdraw that amount and forward it to the Court until the required filing fee is paid in full. I understand that I am liable for paying the entire fee, even if my case is dismissed by the Court before the fee is fully paid.
