15	Kenneth James Myers, and 40 other p	risoners, who are apparently all confined in
16	the Gila County Jail in Globe, Arizona, filed a	a pro se civil rights Complaint pursuant to 42
17	U.S.C. § 1983 (Doc. 1). Plaintiff Myers also	filed an incomplete Application to Proceed
18	In Forma Pauperis (Doc. 2). The Court will	dismiss this action and direct the Clerk of
19	Court to open a new separate action on behalf	of each Plaintiff.
20	I. Severance of Action into Separate A	ctions
21	Generally, plaintiffs may join in one a	ction if they assert any right to relief arising
22	out of the same occurrence or series of occur	rrences and if any question of law or fact in
23	common to all plaintiffs will arise in the actio	n. Fed. R. Civ. P. 20. However, Rule 21 of
24	the Federal Rules of Civil Procedure authorize	es the Court to drop parties on just terms and
25	sever claims. See Desert Empire Bank v. Ins.	Co. of N. Am., 623 F.2d 1371, 1375 (9th Cir.
26	1980) (even if the specific requirements of H	Rule 20 may be satisfied, a trial court must
27	examine other relevant factors to determine	e if joinder of a party will comport with
28	principles of fundamental fairness).	

1 Even if Plaintiffs in this action are properly joined, the Court has found that 2 management of pro se multi-plaintiff inmate litigation presents significant burdens to both 3 the parties and the Court. Plaintiffs are prisoners proceeding pro se, and, although each 4 Plaintiff may appear on his own behalf, no other Plaintiff may appear on behalf of another 5 Plaintiff. Johns v. County of San Diego, 114 F.3d 874, 877 (9th Cir. 1997). Therefore, during the prosecution of this action, each Plaintiff would be required to sign and submit 6 7 his own motions and notices related to his claims in the action, and each Plaintiff would be 8 required to individually sign any motion or notice filed on behalf of all of the Plaintiffs. 9 However, because of security concerns related to prisoner correspondence and face-to-face 10 communications, Plaintiffs would have at best only a very limited opportunity to discuss 11 case strategy, share discovery, or even provide each other copies of the motions and notices 12 they file with the Court. Thus, continued administration of the lawsuit by the prisoners is 13 limited, if not virtually impossible, due to the regulation of prisoner-to-prisoner 14 correspondence. Moreover, prisoners are subject to transfer at any time to a facility other 15 than the one they are incarcerated in at the time of the lawsuit.

16 With these concerns in mind, the Court concludes that unitary adjudication of 17 Plaintiffs' claims would result in unfairness to Plaintiffs, Defendants, and the Court's goals 18 of achieving judicial economy and maintaining efficient control of the Court's docket. 19 Allowing each Plaintiff to proceed separately, however, would overcome the unfairness 20 created by these circumstances. Therefore, the Court will sever this action into individual 21 cases and a new case number will be assigned to each individually named Plaintiff. A copy 22 of the Complaint and this Order will be placed in each new case. Further, as discussed 23 below, the Court will direct the Clerk of Court to send to each Plaintiff a copy of the court-24 approved Application to Proceed In Forma Pauperis.

## Payment of Filing Fee

When bringing an action, a prisoner must either pay the \$350.00 filing fee and a \$52.00 administrative fee in a lump sum or, if granted the privilege of proceeding in forma pauperis, pay the \$350.00 filing fee incrementally as set forth in 28 U.S.C. § 1915(b)(1).

An application to proceed in forma pauperis requires an affidavit of indigence and a *certified* copy of the inmate's trust account statement for the six months preceding the filing of the Complaint. 28 U.S.C. § 1915(a)(2). An inmate must submit statements from each institution where he was confined during the six-month period. Id. To assist prisoners in meeting these requirements, the Court requires use of a form application. LRCiv 3.4.

6 If a prisoner is granted leave to proceed in forma pauperis, the Court will assess an initial partial filing fee of 20% of either the average monthly deposits or the average 8 monthly balance in Plaintiff's account, whichever is greater. 28 U.S.C. § 1915(b)(1). An initial partial filing fee will only be collected when funds exist. 28 U.S.C. § 1915(b)(4). 10 The balance of the \$350.00 filing fee will be collected in monthly payments of 20% of the preceding month's income credited to an inmate's account, each time the amount in the account exceeds \$10.00. 28 U.S.C. § 1915(b)(2).

#### A. Plaintiff Myers' Application Fails to Comply with Statute

14 Although Plaintiff Myers filed an Application to Proceed In Forma Pauperis using 15 the court-approved form, Plaintiff Myers has not submitted a certified six-month trust 16 account statement. In light of that deficiency, the Court will deny Plaintiff Myers' 17 Application to Proceed and will give Plaintiff Myers 30 days to either pay the \$402.00 18 filing and administrative fees or file a complete Application to Proceed In Forma Pauperis.

#### В. **Remaining Plaintiffs**

20 The remaining Plaintiffs have neither paid the filing and administrative fees, nor 21 filed Applications to Proceed In Forma Pauperis. Therefore, each of these Plaintiffs will 22 be permitted 30 days from the filing date of this Order to submit a properly executed and 23 certified Application to Proceed In Forma Pauperis, in his individual case, using the form 24 included with this Order, or pay the \$402.00 filing and administrative fees.

25 III. Complaint

26 The Court has the inherent authority to sua sponte to require a party to replead, 27 pursuant to Rule 12(e) of the Federal Rules of Civil Procedure, when a "pleading is so 28 vague or ambiguous that [a] party cannot reasonably prepare a response." See Wagner v. 1 First Horizon Pharm. Corp., 464 F.3d 1273, 1275 (11th Cir. 2006) ("We also remind 2 district courts of their supervisory obligation to sua sponte order repleading pursuant to 3 Federal Rule of Civil Procedure 12(e) when a shotgun complaint fails to link adequately a 4 cause of action to its factual predicates."); Cobb v. Marshall, 481 F. Supp. 2d 1248, 1259 5 (M.D. Ala. 2007) ("Although Defendant did not expressly request the remedy available to 6 him under Rule 12(e), the court has the 'inherent authority' to act on its own and sua sponte 7 direct a plaintiff to replead a complaint." (quoting Fikes v. City of Daphne, 79 F.3d 1079, 8 1083 n.6 (11th Cir.1996)).

9 Because the Complaint was originally filed as a multi-plaintiff Complaint and the 10 Court cannot ascertain which allegations in Plaintiffs' Complaint pertain to which Plaintiff, 11 the Court will dismiss the Complaint without prejudice and will permit each Plaintiff, in 12 his individual case, to file an amended complaint that provides specific facts regarding 13 how *he* was personally injured by the alleged constitutional violations and omitting facts 14 regarding his former co-plaintiffs.

15

#### IV. Leave to Amend

16 Within 30 days, each Plaintiff may file an amended complaint in his individual 17 case—not this case—that raises only his claims for relief. The Clerk of Court will mail 18 each Plaintiff a court-approved form to use for filing a first amended complaint. A Plaintiff 19 must clearly designate on the document that it is the "First Amended Complaint." The first 20 amended complaint must be retyped or rewritten in its entirety and may not incorporate 21 any part of the original complaint by reference.

22

An amended complaint supersedes the original Complaint. Ferdik v. Bonzelet, 963 23 F.2d 1258, 1262 (9th Cir. 1992); Hal Roach Studios v. Richard Feiner & Co., 896 F.2d 24 1542, 1546 (9th Cir. 1990). After amendment, the Court will treat the original Complaint 25 as nonexistent. Ferdik, 963 F.2d at 1262. Any cause of action that was raised in the 26 original Complaint and that was voluntarily dismissed or was dismissed without prejudice 27 is waived if it is not alleged in a first amended complaint. Lacey v. Maricopa County, 693 28 F.3d 896, 928 (9th Cir. 2012) (en banc).

A Plaintiff that files an amended complaint must write short, plain statements telling the Court: (1) the constitutional right the Plaintiff believes was violated; (2) the name of the Defendant who violated the right; (3) exactly what that Defendant did or failed to do; (4) how the action or inaction of that Defendant violated that Plaintiff's constitutional rights; and (5) what specific injury that Plaintiff suffered because of that Defendant's conduct. *See Rizzo v. Goode*, 423 U.S. 362, 371-72, 377 (1976).

A Plaintiff must repeat this process for each person he names as a Defendant. If a
Plaintiff fails to affirmatively link the conduct of each named Defendant with the specific
injury suffered by Plaintiff, the allegations against that Defendant will be dismissed for
failure to state a claim. Conclusory allegations that a Defendant or group of
Defendants has violated a constitutional right are not acceptable and will be
dismissed.

13 The rulings in this Order shall apply in each new case. The individual Plaintiffs 14 must proceed independently from this point and will not be regarded as co-plaintiffs, except 15 upon further order of the Court. All further pleadings, motions or other papers submitted 16 for filing by an individual Plaintiff in his separate case must be signed by the individual 17 Plaintiff, or they will be stricken.

# A. Address Changes

Each Plaintiff must file and serve a notice of a change of address in accordance with Rule 83.3(d) of the Local Rules of Civil Procedure. Plaintiffs must not include a motion for other relief with a notice of change of address. Failure to comply may result in dismissal of this action.

# **B.** Copies

Each Plaintiff must serve Defendants, or counsel if an appearance has been entered,
a copy of every document that the Plaintiff files. Fed. R. Civ. P. 5(a). Each filing must
include a certificate stating that a copy of the filing was served. Fed. R. Civ. P. 5(d). Also,
each Plaintiff must submit an additional copy of every filing for use by the Court. *See* LR

1 Civ 5.4. Failure to comply may result in the filing being stricken without further notice to 2 the Plaintiff.

**IT IS ORDERED:** 

4 (1)Plaintiff Myers' Application to Proceed In Forma Pauperis (Doc. 2) is 5 denied.

6 This case is severed into individual actions, one for each named Plaintiff. (2)7 The Clerk of Court **must assign** a new case number to each new individual action.

8 (3)The Clerk of Court **must file** a copy of the Complaint (Doc. 1) and this Order 9 in each new case. The rulings in this Order shall apply in each new case.

3

10 (4)The individual Plaintiffs must proceed independently from this point and 11 will not be regarded as co-plaintiffs, except upon further order of the Court. All further 12 pleadings, motions or other papers submitted for filing by an individual Plaintiff in his 13 separate case must be signed by the individual Plaintiff, or they will be stricken.

14 (5)Within **30 days** of the date this Order is filed, each Plaintiff must either pay 15 the \$350.00 filing fee and \$52.00 administrative fee or file a complete Application to 16 Proceed In Forma Pauperis and a certified six-month trust account statement in his 17 individual case.

18 If a Plaintiff fails to either pay the \$350.00 filing fee and \$52.00 (6)19 administrative fee or file a complete Application to Proceed In Forma Pauperis in his new 20 within 30 days, the Clerk of Court must enter a judgment of dismissal of this action without 21 prejudice and without further notice to Plaintiff and deny any pending unrelated motions 22 as moot.

23

(7)The Complaint (Doc. 1) is **dismissed without prejudice**.

24 (8) Each Plaintiff has **30 days** to file an amended complaint **in his individual** 25 case, not in this case, asserting only his claims.

26 (9)If a Plaintiff fails to file an amended complaint in his individual case within 27 30 days, the Clerk of Court must enter a judgment of dismissal of that action without 28 prejudice and without further notice the Plaintiff and deny any pending unrelated motions as moot.

(10) The Clerk of Court **must close** this case (CV 21-00212-PHX-JAT (CDB)) and **enter judgment** accordingly.

(11) The Clerk of Court must mail each Plaintiff a court-approved form for filing an Application to Proceed In Forma Pauperis and a civil rights complaint by a prisoner.

(12) Because the address of the Gila County Jail is the only address provided to the Court for the Plaintiffs, the Clerk of Court is directed to use this address as the mailing address for each Plaintiff when mailing a copy of this Order and the case-opening paperwork in the new actions. The Clerk of Court must mail a copy of the Complaint to each individual Plaintiff.

### Instructions for a Prisoner Filing a Civil Rights Complaint in the United States District Court for the District of Arizona

1. <u>Who May Use This Form</u>. The civil rights complaint form is designed to help incarcerated persons prepare a complaint seeking relief for a violation of their federal civil rights. These complaints typically concern, but are not limited to, conditions of confinement. **This form should not be used to challenge your conviction or sentence**. If you want to challenge a state conviction or sentence, you should file a petition under 28 U.S.C. § 2254 for a writ of habeas corpus by a person in state custody. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment.

2. <u>The Form</u>. Local Rule of Civil Procedure (LRCiv) 3.4(a) provides that complaints by incarcerated persons must be filed on the court-approved form. The form must be typed or neatly handwritten. The form must be completely filled in to the extent applicable. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages, but no more than fifteen additional pages, of standard letter-sized paper. You must identify which part of the complaint is being continued and number all pages. If you do not fill out the form properly, you will be asked to submit additional or corrected information, which may delay the processing of your action. You do not need to cite law.

3. <u>Your Signature</u>. You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.

4. <u>The Filing and Administrative Fees</u>. The total fees for this action are \$400.00 (\$350.00 filing fee plus \$50.00 administrative fee). If you are unable to immediately pay the fees, you may request leave to proceed in forma pauperis. Please review the "Information for Prisoners Seeking Leave to Proceed with a (Non-Habeas) Civil Action in Federal Court In Forma Pauperis Pursuant to 28 U.S.C. § 1915" for additional instructions.

5. <u>Original and Judge's Copy</u>. You must send an **original plus one copy** of your complaint and of any other documents submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten. This section does not apply to inmates housed at an Arizona Department of Corrections facility that participates in electronic filing.

6. <u>Where to File</u>. You should file your complaint in the division where you were confined when your rights were allegedly violated. *See* LRCiv 5.1(a) and 77.1(a). If you were confined in Maricopa, Pinal, Yuma, La Paz, or Gila County, file in the Phoenix Division. If you were confined in Apache, Navajo, Coconino, Mohave, or Yavapai County, file in the Prescott Division. If you were confined in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file in the Tucson Division. Mail the original and one copy of the complaint with the \$400 filing and administrative fees or the application to proceed in forma pauperis to:

7. <u>Change of Address</u>. You must immediately notify the Court and the defendants in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.** 

8. <u>Certificate of Service</u>. You must furnish the defendants with a copy of any document you submit to the Court (except the initial complaint and application to proceed in forma pauperis). Each original document (except the initial complaint and application to proceed in forma pauperis) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the defendants and the address to which it was mailed. *See* Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. This section does not apply to inmates housed at an Arizona Department of Corrections facility that participates in electronic filing.

9. <u>Amended Complaint</u>. If you need to change any of the information in the initial complaint, you must file an amended complaint. The amended complaint must be written on the court-approved civil rights complaint form. You may file one amended complaint without leave (permission) of Court within 21 days after serving it or within 21 days after any defendant has filed an answer, whichever is earlier. *See* Fed. R. Civ. P. 15(a). Thereafter, you must file a motion for leave to amend and lodge (submit) a proposed amended complaint. LRCiv 15.1. In addition, an amended complaint may not incorporate by reference any part of your prior complaint. LRCiv 15.1(a)(2). Any allegations or defendants not included in the amended complaint are considered dismissed. All amended complaints are subject to screening under the Prison Litigation Reform Act; screening your amendment will take additional processing time.

10. <u>Exhibits</u>. You should not submit exhibits with the complaint or amended complaint. Instead, the relevant information should be paraphrased. You should keep the exhibits to use to support or oppose a motion to dismiss, a motion for summary judgment, or at trial.

11. <u>Letters and Motions</u>. It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

#### 12. Completing the Civil Rights Complaint Form.

#### **HEADING:**

1. <u>Your Name</u>. Print your name, prison or inmate number, and institutional mailing address on the lines provided.

2. <u>Defendants</u>. If there are **four or fewer** defendants, print the name of each. If you name **more than four** defendants, print the name of the first defendant on the first line, write the words "and others" on the second line, and attach an additional page listing the names of **all** of the defendants. Insert the additional page after page 1 and number it "1-A" at the bottom.

3. <u>Jury Demand</u>. If you want a jury trial, you must write "JURY TRIAL DEMANDED" in the space below "CIVIL RIGHTS COMPLAINT BY A PRISONER." Failure to do so may result in the loss of the right to a jury trial. A jury trial is not available if you are seeking only injunctive relief.

#### Part A. JURISDICTION:

1. <u>Nature of Suit</u>. Mark whether you are filing the complaint pursuant to 42 U.S.C. § 1983 for state, county, or city defendants; "*Bivens v. Six Unknown Federal Narcotics Agents*" for federal defendants; or "other." If you mark "other," identify the source of that authority.

2. <u>Location</u>. Identify the institution and city where the alleged violation of your rights occurred.

3. <u>Defendants</u>. Print all of the requested information about each of the defendants in the spaces provided. If you are naming more than four defendants, you must provide the necessary information about each additional defendant on separate pages labeled "2-A," "2-B," etc., at the bottom. Insert the additional page(s) immediately behind page 2.

#### Part B. PREVIOUS LAWSUITS:

You must identify any other lawsuit you have filed in either state or federal court while you were a prisoner. Print all of the requested information about each lawsuit in the spaces provided. If you have filed more than three lawsuits, you must provide the necessary information about each additional lawsuit on a separate page. Label the page(s) as "2-A," "2-B," etc., at the bottom of the page and insert the additional page(s) immediately behind page 2.

#### Part C. CAUSE OF ACTION:

You must identify what rights each defendant violated. The form provides space to allege three separate counts (**one violation per count**). If you are alleging more than three counts, you must provide the necessary information about each additional count on a separate page. Number the additional pages "5-A," "5-B," etc., and insert them immediately behind page 5. Remember that you are limited to a total of fifteen additional pages.

1. <u>Counts</u>. You must identify which civil right was violated. You may allege the violation of only one civil right per count.

2. <u>Issue Involved</u>. Check the box that most closely identifies the issue involved in your claim. **You may check only one box per count**. If you check the box marked "Other," you must identify the specific issue involved.

3. <u>Supporting Facts</u>. After you have identified which civil right was violated, you must state the supporting facts. Be as specific as possible. You must state what each individual defendant did to violate your rights. If there is more than one defendant, you must identify which defendant did what act. You also should state the date(s) on which the act(s) occurred, if possible.

4. <u>Injury</u>. State precisely how you were injured by the alleged violation of your rights.

5. <u>Administrative Remedies</u>. You must exhaust any available administrative remedies before you file a civil rights complaint. *See* 42 U.S.C. § 1997e. Consequently, you should disclose whether you have exhausted the inmate grievance procedures or administrative appeals for each count in your complaint. If the grievance procedures were not available for any of your counts, fully explain why on the lines provided.

#### Part D. REQUEST FOR RELIEF:

Print the relief you are seeking in the space provided.

#### **SIGNATURE:**

You must sign your name and print the date you signed the complaint. Failure to sign the complaint will delay the processing of your action. Unless you are an attorney, you may not bring an action on behalf of anyone but yourself.

#### FINAL NOTE

You should follow these instructions carefully. Failure to do so may result in your complaint being stricken or dismissed. All questions must be answered concisely in the proper space on the form. If you need more space, you may attach no more than fifteen additional pages. But the form must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the complaint is being continued and number the pages.

### Instructions for Prisoners Applying for Leave to Proceed In Forma Pauperis Pursuant to 28 U.S.C. § 1915 in a Civil Action (Non-habeas) in Federal Court

You must pay the \$350.00 filing fee plus the \$50.00 administrative fees for a civil action. If you later file an appeal, you will be obligated to pay the \$505.00 filing fee for the appeal.

If you have enough money to pay the full \$400.00 filing and administrative fees, you should send a cashier's check or money order payable to the Clerk of the Court with your complaint.

If you do not have enough money to pay the full \$400.00 filing and administrative fees, you can file the action without prepaying the fees. However, the Court will assess an initial partial filing fee. The initial partial filing fee will be the greater of 20% of the average monthly deposits or 20% of the average monthly balance in your prison or jail account for the six months immediately preceding the filing of the lawsuit. The Court will order the agency that has custody of you to withdraw the initial partial filing fee from your prison or jail account as soon as funds are available and to forward the money to the Court.

After the initial partial filing fee has been paid, you will owe the balance of the \$350.00 filing fee (you will not be required to pay the \$50.00 administrative fee). Until the filing fee is paid in full, each month you will owe 20% of your preceding month's income. The agency that holds you in custody will collect that money and forward it to the Court any time the amount in your account exceeds \$10.00. These installment fees are calculated on a per-case basis. This means that you will be required to pay 20% of your preceding month's income for **each** civil non-habeas corpus case in which you have an outstanding filing fee balance. For example, if you are making payments toward filing fee balances in two civil non-habeas corpus cases, 40% of your preceding month's income will be collected each month. The balance of the filing fee may be collected even if the action is later dismissed, summary judgment is granted against you, or you fail to prevail at trial.

To file an action without prepaying the filing fee, and to proceed with an action in forma pauperis, you must complete the attached form and return it to the Court with your complaint. You must have a prison or jail official complete the certificate on the bottom of the form and attach a certified copy of your prison or jail account statement for the last six months. If you were incarcerated in a different institution during any part of the past six months, you must attach a certificate and a certified copy of your account statement from <u>each</u> institution at which you were confined. If you submit an incomplete form or do not submit a prison or jail account statement with the form, your request to proceed in forma pauperis will be denied.

Even if some or all of the filing fee has been paid, the Court is required to dismiss your action if: (1) your allegation of poverty is untrue; (2) the action is frivolous or malicious; (3) your complaint does not state a claim upon which relief can be granted; or (4) your complaint makes a claim against a defendant for money damages and that defendant is immune from liability for money damages.

If you file more than three actions or appeals which are dismissed as frivolous or malicious or for failure to state a claim on which relief can be granted, you will be prohibited from filing any other action in forma pauperis unless you are in imminent danger of serious physical injury.
