Before the Court is the Joint Request to Extend Deadlines submitted by the parties(Doc. 188). The parties request an extension of the discovery and dispositive motion deadlines due to the large number of discovery undertaken in this case. 2 **IT IS HEREBY ORDERED GRANTING** the parties' Joint Request to Extend
3 Deadlines (Doc. 188).

4 **IT IS FURTHER ORDERED** extending the case deadlines for liability issues as
5 follows:

- 6 A. The deadline to conduct all liability witness depositions is extended to June 16,
7 2010.
- 8 B. The deadline for Plaintiff's disclose of expert witnesses and reports is
9 extended to July 23, 2010.
- 10 C. The deadline for Defendants' disclosure of expert witnesses and reports is
11 extended to August 23, 2010.
- 12 D. The deadline for the parties to conduct a private mediation is extended to
13 September 3, 2010.
- 14 E. The deadline to disclose rebuttal expert witnesses and reports is extended to
15 September 13, 2010.
- 16 F. The deadline to conduct expert depositions is extended to October 15, 2010.
- 17 G. The dispositive motion deadline is extended to November 12, 2010.

18 **IT IS FURTHER ORDERED** setting a status conference before the Honorable
19 Stephen M. McNamee for **September 13, 2010 at 2 p.m.** in Courtroom 605, 401 West
20 Washington Street, Phoenix, Arizona 85003.
