On January 3, 2011, Petitioner Richard Lee Thompson, who is confined in the Arizona State Prison Complex-Tucson, filed a *pro se* Petition for Writ of Habeas Corpus pursuant to 28 U.S.C. § 2254 (Doc. 1). Petitioner did not immediately pay the \$5.00 filing fee or file an Application to Proceed *In Forma Pauperis*.

By Order filed January 14, 2011 (Doc. 3), the Court gave Petitioner 30 days from the filing date of the Order to either pay the \$5.00 filing fee or file a completed Application to Proceed *In Forma Pauperis* using the form included with the Order. On February 9, 2011, Petitioner filed a “Motion For 30[-]Day Extension Of Time Of 28 U.S.C. 2254 And Civil Suit 42 U[.]S[.]C[.] 1983” (Doc. 4). On February 9, 2011, Petitioner also filed a completed Application to Proceed *In Forma Pauperis* (Doc. 5).

The Court will deny the Motion as moot, grant the Application to Proceed *In Forma Pauperis*, and dismiss the Petition without prejudice, with leave to amend.

1 **I. Application to Proceed *In Forma Pauperis***

2 Petitioner’s Application to Proceed *In Forma Pauperis* (Doc. 5) indicates that his
3 inmate trust account balance is less than \$25.00. Accordingly, the Application to Proceed
4 *In Forma Pauperis* will be granted. See LRCiv 3.5(b).

5 **II. Petition**

6 Named as Respondent in the Petition (Doc. 1) is Sandra Walker. The Attorney
7 General of the State of Arizona is named as an Additional Respondent.

8 Petitioner presents four grounds for habeas corpus relief:

- 9 (1) “No defense counsel violation of all my due process and all
10 counsel rights”;
11 (2) “Violates all my const. rights. No defense attorney was
12 appointed[.] Anderson[’s] court[] was state[’]s version of lies”;
13 (3) “Violates all of my const. rights. Anderson[’]s court was
14 state[’]s version of lies”; and
15 (4) “All my const[.] rights.”

16 Petitioner alleges that the issues raised in Grounds I, II, and III were not presented to
17 the Arizona Supreme Court. Petitioner does not indicate if the issue in Ground IV was
18 presented to the Arizona Supreme Court. Petitioner also does not indicate whether any of
19 his grounds were presented to the Arizona Court of Appeals.

20 **III. Dismissal of Petition With Leave to Amend**

21 Pursuant to 28 U.S.C. § 2254, federal courts “shall entertain an application for a writ
22 of habeas corpus in behalf of a person in custody pursuant to the judgment of a State court
23 **only on the ground that he is in custody in violation of the Constitution or laws or**
24 **treaties of the United States.”** 28 U.S.C. § 2254(a) (emphasis added); see also Engle v.
25 Isaac, 456 U.S. 107, 119 (1982). Federal courts may intervene in the state judicial process
26 only to correct wrongs of a constitutional dimension. Mabry v. Johnson, 467 U.S. 504, 507
27 (1984); Wainwright v. Goode, 464 U.S. 78, 84 (1983). Habeas corpus relief is not available
28 for errors of state law, procedure, or evidentiary rulings. Gutierrez v. Griggs, 695 F.2d 1195,
1197 (9th Cir. 1983); Quiroz v. Wawrzaszek, 749 F.2d 1375, 1377 (9th Cir. 1984).

1 Petitioner does not make reference in any of his grounds to a specific provisions of
2 the United States Constitution, or to any laws or treaties of the United States. Instead,
3 Petitioner vaguely alleges in Grounds II, III, and IV that all his “const. rights” were violated.
4 Moreover, Petitioner has not presented sufficient supporting facts in any of his grounds to
5 state a constitutional claim. Essentially, Petitioner’s extremely vague and conclusory
6 grounds are not reviewable in any meaningful way by this Court. Accordingly, the Petition
7 will be dismissed without prejudice.

8 However, in the interests of justice, the Court will grant Petitioner leave to file an
9 amended petition, if he so desires, to show how he is being held in custody in violation of
10 specific provisions of the Constitution, laws or treaties of the United States; to specify all the
11 exhausted grounds for relief which are available to him; to set forth in summary form the
12 facts supporting each of his grounds; and to provide information as to how he has first
13 exhausted his state court remedies as to each ground on which he requests action by this
14 Court. Accordingly, for each ground Petitioner alleges in an amended petition, he must
15 allege how he is in custody in violation of a specific provision of the Constitution or laws or
16 treaties of the United States, and should also provide information as to how he has first
17 exhausted his state court remedies as to each and every claim.¹

18 Petitioner must limit each ground to the allegation of the violation of a single
19 constitutional right, must describe the right and its source in the United States Constitution,
20 and must clearly state supporting facts showing how that constitutional right was violated.
21 The grounds and facts must be clearly set out as fully as possible on the court-approved
22 petition form itself. If Petitioner cannot fit all of his supporting facts or arguments in favor
23 of a particular ground on the court-approved form, then he may continue on an attachment,

25 ¹A prisoner attacking his or her state conviction must exhaust state remedies before
26 a federal court will entertain a petition for writ of habeas corpus. Rose v. Lundy, 455 U.S.
27 509 (1982); Szeto v. Rushen, 709 F.2d 1340 (9th Cir. 1983). The federal court will not
28 entertain a petition for writ of habeas corpus unless each and every issue has been exhausted.
Rose, 455 U.S. at 521-22. The failure to exhaust subjects the Petition to dismissal. Gutierrez
v. Griggs, 695 F.2d 1195 (9th Cir. 1983).

1 but each matter on any attachment must be clearly referenced to a particular ground on the
2 court-approved form.

3 Petitioner should take notice that by amending his Petition, he will be presumed to
4 have deliberately waived his right to raise any constitutional errors or deprivations other than
5 those set forth in his amended habeas petition, and the Court may dismiss any subsequent
6 petitions. 28 U.S.C. § 2244.²

7 Petitioner should further take notice that all grounds alleged in his original Petition
8 which are not alleged in any amended petition will be waived. Hal Roach Studios v. Richard
9 Feiner & Co., 896 F.2d 1542, 1546 (9th Cir. 1990) (“an amended pleading supersedes the
10 original”); King v. Atiyeh, 814 F.2d 565 (9th Cir. 1987).

11 **IV. Motion for Extension of Time**

12 On February 9, 2011, Petitioner filed a “Motion For 30[-]Day Extension Of Time Of
13 28 U.S.C. 2254 And Civil Suit 42 U[.]S[.]C[.] 1983” (Doc. 4). However, because Petitioner
14 timely complied with the Court’s January 14, 2011 Order (Doc. 3), by filing a completed
15 Application to Proceed *In Forma Pauperis* (Doc. 5) on February 9, 2011, the Court will deny
16 Petitioner’s Motion as moot.

17 **V. Warnings**

18 **A. Address Changes**

19 Petitioner must file and serve a notice of a change of address in accordance with Rule
20 83.3(d) of the Local Rules of Civil Procedure. Petitioner must not include a motion for other
21 relief with a notice of change of address. Failure to comply may result in dismissal of this
22 action.

23 **B. Copies**

24 Petitioner must submit an additional copy of every document that he files for use by
25

26 ²Title 28 U.S.C. § 2244(b) states that a District Court shall dismiss a claim presented in a
27 second or successive habeas corpus application under section 2254 that was not presented in a prior
28 application, except under certain circumstances. Furthermore, under 28 U.S.C. § 2244(b)(3)(A),
before a second or successive application is filed in the district court, the applicant shall move in the
court of appeals for an order authorizing the district court to consider the application.

1 the Court. See LRCiv 5.4. Failure to comply may result in the filing being stricken without
2 further notice to Petitioner.

3 **C. Possible Dismissal**

4 If Petitioner fails to timely comply with every provision of this Order, including these
5 warnings, the Court may dismiss this action without further notice. See Ferdik v. Bonzelet,
6 963 F.2d 1258, 1260-61 (9th Cir. 1992) (a district court may dismiss an action for failure to
7 comply with any order of the Court).

8 **IT IS ORDERED:**

9 (1) Petitioner's "Motion For 30[-]Day Extension Of Time Of 28 U.S.C. 2254 And
10 Civil Suit 42 U[.]S[.]C[.] 1983" (Doc. 4) is **denied as moot**.

11 (2) Petitioner's Application to Proceed *In Forma Pauperis* (Doc. 5) is **granted**.

12 (3) The Petition (Doc. 1) is **dismissed without prejudice, with leave to amend**.
13 Petitioner has **30 days** from the filing date of this Order to amend his original Petition to
14 show how he is being held in custody in violation of the Constitution, laws or treaties of the
15 United States, to specify all the exhausted grounds for relief which are available to him, to
16 set forth in summary form the facts supporting each of his grounds, and to provide
17 information as to how he has first exhausted his state court remedies as to each ground on
18 which he requests action by this Court.

19 (4) The Clerk of Court **must enter** a judgment of dismissal of this action without
20 prejudice, without further notice to Petitioner, if Petitioner fails to file an amended petition
21 within 30 days from the filing date of this Order.

22 (5) The Clerk of Court **must provide** Petitioner with a current court-approved
23 form for filing a "Petition For Writ Of Habeas Corpus By A Person In State Custody
24 Pursuant To 28 U.S.C. § 2254 (Non-Death Penalty)."

**Instructions for Filing a Petition Under 28 U.S.C. § 2254
for a Writ of Habeas Corpus by a Person in State Custody
in the United States District Court for the District of Arizona**

1. Who May Use This Form. To use this form, you must be a person who is currently serving a sentence under a judgment against you in a state court. You are asking for relief from the conviction or the sentence on the grounds that your conviction or sentence violates the United States Constitution or other federal law. You also may use this form to challenge a state judgment that imposed a sentence to be served in the future, but you must fill in the name of the state where the judgment was entered. If you want to challenge a federal conviction or sentence, you should file a motion under 28 U.S.C. § 2255 to vacate sentence in the federal court that entered the judgment. **This form should not be used in death penalty cases.** If you were sentenced to death, you are entitled to the assistance of counsel and you should request the appointment of counsel.
2. The Form. **Local Rule of Civil Procedure (LRCiv) 3.5(a) provides that habeas corpus petitions must be filed on the court-approved form.** The form must be typed or neatly handwritten. All questions must be answered clearly and concisely in the appropriate space on the form. If needed, you may attach additional pages. The form, however, must be completely filled in to the extent applicable. You do not need to cite law. If you want to file a brief or arguments, you must attach a separate memorandum.
3. Your Signature. You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.
4. The Filing Fee. The filing fee for this action is \$5.00. If you are unable to pay the filing fee, you may request permission to proceed *in forma pauperis* by completing and signing the Application to Proceed *In Forma Pauperis* provided with the petition form. You must have an official at the prison or jail complete the certificate at the bottom of the application form. If the amount of money in your account exceeds \$25.00, you must pay the \$5.00 filing fee. LRCiv 3.5(b).
5. Original and Judge's Copy. You must send an **original plus one copy** of your petition and of any other document submitted to the Court. You must send one additional copy to the Court if you wish to have a file-stamped copy of the document returned to you. All copies must be identical to the original. Copies may be legibly handwritten.
6. Where to File. You should **file your petition in the division where you were convicted.** See LRCiv 5.1(b). If you are challenging a judgment of conviction entered in Maricopa, Pinal, Yuma, La Paz, or Gila County, file your petition in the Phoenix Division. If you are challenging a judgment of conviction entered in Apache, Navajo, Coconino, Mohave, or Yavapai County, file your petition in the Prescott Division. If you are challenging a judgment of conviction entered in Pima, Cochise, Santa Cruz, Graham, or Greenlee County, file your petition in the Tucson Division. See LRCiv 5.1(b) and 77.1(a).

7. Change of Address. You must immediately notify the Court and respondents in writing of any change in your mailing address. **Failure to notify the Court of any change in your mailing address may result in the dismissal of your case.**

8. Certificate of Service. You must provide the respondents with a copy of any document you submit to the Court (except the initial petition and application to proceed *in forma pauperis*). Each original document (except the initial petition and application to proceed *in forma pauperis*) must include a certificate of service on the last page of the document stating the date a copy of the document was mailed to the respondents and the address to which it was mailed. Fed. R. Civ. P. 5(a), (d). Any document received by the Court that does not include a certificate of service may be stricken. A certificate of service should be in the following form:

9. Amended Petition. If you need to change any of the information in the initial petition, you must file an amended petition. The amended petition must be written on the court-approved form. You may file one amended petition without leave (permission) of Court before any respondent has answered your original petition. See Fed. R. Civ. P. 15(a). After any respondent has filed an answer, you must file a motion for leave to amend and lodge (submit) a proposed amended petition. LRCiv 15.1. An amended petition may not incorporate by reference any part of your prior petition. LRCiv 15.1(a)(2). **Any grounds not included in the amended petition are considered dismissed.**

10. Exhibits. If available, you should attach a copy of all state and federal court written decisions regarding the conviction you are challenging. Do **not** submit any other exhibits with the petition. Instead, you should paraphrase the relevant information in the petition.

11. Letters and Motions. It is generally inappropriate to write a letter to any judge or the staff of any judge. The only appropriate way to communicate with the Court is by filing a written pleading or motion.

12. Warnings.

- a. Judgment Entered by a Single Court. You may challenge the judgment entered by only one court. Multiple counts which resulted in a judgment by the same court may be challenged in the same petition. If you wish to challenge judgments entered by more than one court, however, you must file separate petitions for each judgment.
- b. Grounds for Relief. You must raise all grounds for relief that relate to this conviction or sentence. Any grounds not raised in this petition will likely be barred from being raised in any subsequent federal action.
- c. Exhaustion. In order to proceed in federal court, you ordinarily must exhaust the remedies available to you in the state courts as to each claim on which you request action by the federal court. If you did not fairly present each of your grounds to the Arizona Court of Appeals, your petition may be dismissed. If you did not present one or more of your grounds to the Arizona Court of Appeals, explain why you did not.

FINAL NOTE

You should follow these instructions carefully. Failure to do so may result in your petition being stricken or dismissed by the Court. All questions must be answered concisely in the proper space on the form. If you need more space, you may attach additional pages. But the form must be completely filled in to the extent applicable. If you attach additional pages, be sure to identify which section of the petition is being continued and number all pages.

(C) the date on which the constitutional right asserted was initially recognized by the Supreme Court, if the right has been newly recognized by the Supreme Court and made retroactively applicable to cases on collateral review; or

(D) the date on which the factual predicate of the claim or claims presented could have been discovered through the exercise of due diligence.

(2) The time during which a properly filed application for State post-conviction or other collateral review with respect to the pertinent judgment or claim is pending shall not be counted toward any period of limitation under this subsection.
