Governor Jan Brewer Announces Appointment of Counsel to Defend Immigration Laws

PHOENIX - Governor Jan Brewer today announced that Mr. John Bouma, chairman of the law firm Snell & Wilmer, will represent her in federal lawsuits challenging Arizona's new immigration laws.

The Governor recently signed SB 1070 and HB 2162, which contain numerous provisions relating to immigration enforcement in Arizona. These laws go into effect on July 29, 2010. Five federal lawsuits have been filed challenging the constitutionality of the new laws. The Governor is named as a defendant in four of the five challenges. Although the Attorney General is named as a defendant along with the Governor in one of the suits, he declined to represent the Governor, thus requiring the Governor to obtain outside counsel to defend these laws.

"There are five lawsuits with over forty attorneys representing numerous plaintiffs," said Governor Brewer. "It is important for me to hire excellent and highly experienced counsel with the resources and expertise to defend Arizona's immigration laws. I am confident John Bouma and his team at Snell & Wilmer will successfully defend our immigration laws."

Under the terms of the agreement with Snell & Wilmer, legal fees and costs will be funded through (1) monies raised from a legal defense fund established under A.R.S. § 41-1105; (2) funds appropriated or allocated for payment of legal fees in accordance with A.R.S. § 35-154; and/or (3) any other funds lawfully available to the Governor, other than the Governor's general operating appropriation. Moreover, in an effort to reduce expenses, Snell & Wilmer has agreed to work with counsel outside the firm who have indicated a willingness to help with legal research and other matters on a pro bono basis.
