

At issue is the Motion for Preliminary Injunction filed by Plaintiff the United States (“Pl.’s Mot.”) (Doc. 27).

I. SUMMARY

Against a backdrop of rampant illegal immigration, escalating drug and human trafficking crimes, and serious public safety concerns, the Arizona Legislature enacted a set of statutes and statutory amendments in the form of Senate Bill 1070, the “Support Our Law Enforcement and Safe Neighborhoods Act,” 2010 Arizona Session Laws, Chapter 113, which Governor Janice K. Brewer signed into law on April 23, 2010. Seven days later, the Governor signed into law a set of amendments to Senate Bill 1070 under House Bill 2162, 2010 Arizona Session Laws, Chapter 211.¹ Among other things, S.B. 1070 requires officers

1 to check a person’s immigration status under certain circumstances (Section 2) and
2 authorizes officers to make a warrantless arrest of a person where there is probable cause to
3 believe that the person committed a public offense that makes the person removable from the
4 United States (Section 6). S.B. 1070 also creates or amends crimes for the failure of an alien
5 to apply for or carry registration papers (Section 3), the smuggling of human beings (Section
6 4), the performance of work by unauthorized aliens, and the transport or harboring of
7 unlawfully present aliens (Section 5).

8 On July 6, 2010, the United States filed a Complaint with this Court challenging the
9 constitutionality of S.B. 1070, and it also filed a Motion requesting that the Court issue a
10 preliminary injunction to enjoin Arizona from enforcing S.B. 1070 until the Court can make
11 a final determination as to its constitutionality. The United States argues principally that the
12 power to regulate immigration is vested exclusively in the federal government, and that the
13 provisions of S.B. 1070 are therefore preempted by federal law.

14 The Court notes that S.B. 1070 is not a freestanding statute; rather, it is an enactment
15 of the Arizona Legislature that adds some new sections to the Arizona Revised Statutes
16 (“A.R.S.”) and amends some preexisting sections. S.B. 1070 also contains a severability
17 clause, providing that,

18 [i]f a provision of this act or its application to any person or circumstance is
19 held invalid, the invalidity does not affect other provisions or applications of
20 the act that can be given effect without the invalid provision or application,
and to this end the provisions of this act are severable.

21 S.B. 1070 § 12(A). Therefore, the Court cannot and will not enjoin S.B. 1070 in its entirety,
22 as certain parties to lawsuits challenging the enactment have requested. The Court is
23 obligated to consider S.B. 1070 on a section by section and provision by provision basis.

24 Other than seeking a preliminary injunction as to “S.B. 1070,” the United States has
25 not made any argument to preliminarily enjoin and the Court therefore does *not* enjoin the
26 following provisions of S.B. 1070:

27 Section 1 of S.B. 1070

10 less than the full extent permitted by federal law

11 Section 4 of S.B. 1070²
12 A.R.S. § 13-2319: amending the crime of human smuggling

13 Portion of Section 5 of S.B. 1070
14 A.R.S. § 13-2928(A)-(B): creating a crime for stopping a motor vehicle to pick up
15 day laborers and for day laborers to get in a motor
16 vehicle if it impedes the normal movement of traffic

17 Section 7 of S.B. 1070
18 A.R.S. § 23-212: amending the crime of knowing employment of
19 unauthorized aliens

20 Section 8 of S.B. 1070
21 A.R.S. § 23-212.01: amending the crime of intentional employment of
22 unauthorized aliens

23 Section 9 of S.B. 1070
24 A.R.S. § 23-214: amending the requirements for checking employment
25 eligibility

26 Section 11 of S.B. 1070
27 A.R.S. § 41-1724: creating the gang and immigration intelligence team
28 enforcement mission fund

Sections 12 & 13 of S.B. 1070
no A.R.S. citation: administering S.B. 1070

Applying the proper legal standards based upon well-established precedent, the Court finds that the United States is not likely to succeed on the merits in showing that the following provisions of S.B. 1070 are preempted by federal law, and the Court therefore does *not* enjoin the enforcement of the following provisions of S.B. 1070:

1 Portion of Section 5 of S.B. 1070
A.R.S. § 13-2929: creating a separate crime for a person in violation of a
2 criminal offense to transport or harbor an unlawfully
3 present alien or encourage or induce an unlawfully present
alien to come to or live in Arizona

4 Section 10 of S.B. 1070
A.R.S. § 28-3511: amending the provisions for the removal or impoundment
5 of a vehicle to permit impoundment of vehicles used in
6 the transporting or harboring of unlawfully present aliens

7 Applying the proper legal standards based upon well-established precedent, the Court
8 finds that the United States *is* likely to succeed on the merits in showing that the following
9 Sections of S.B. 1070 are preempted by federal law:

10 Portion of Section 2 of S.B. 1070
A.R.S. § 11-1051(B): requiring that an officer make a reasonable attempt to
11 determine the immigration status of a person stopped,
12 detained or arrested if there is a reasonable suspicion that
13 the person is unlawfully present in the United States, and
requiring verification of the immigration status of any
person arrested prior to releasing that person

14 Section 3 of S.B. 1070
A.R.S. § 13-1509: creating a crime for the failure to apply for or carry alien
15 registration papers

16 Portion of Section 5 of S.B. 1070
A.R.S. § 13-2928(C): creating a crime for an unauthorized alien to solicit, apply
17 for, or perform work

18 Section 6 of S.B. 1070
A.R.S. § 13-3883(A)(5): authorizing the warrantless arrest of a person where there
19 is probable cause to believe the person has committed a
20 public offense that makes the person removable from the
United States

21 The Court also finds that the United States is likely to suffer irreparable harm if the Court
22 does not preliminarily enjoin enforcement of these Sections of S.B. 1070 and that the balance
23 of equities tips in the United States' favor considering the public interest. The Court therefore
24 issues a preliminary injunction enjoining the enforcement of the portion of Section 2 creating
25 A.R.S. § 11-1051(B), Section 3 creating A.R.S. § 13-1509, the portion of Section 5 creating
26 A.R.S. § 13-2928(C), and Section 6 creating A.R.S. § 13-3883(A)(5).

1 **II. BACKGROUND**

2 **A. Overview of Federal Immigration Law**

3 Congress has created and refined a complex and detailed statutory framework
4 regulating immigration. The federal immigration scheme is largely enacted through the
5 Immigration and Nationality Act (“INA”), 8 U.S.C. § 1101, *et seq.*, which empowers various
6 federal agencies (including the Department of Justice (“DOJ”), Department of Homeland
7 Security (“DHS”), and Department of State (“DOS”)) to administer and enforce the
8 immigration laws. *See, e.g., id.* §§ 1103-1104. Among its many provisions, the INA sets forth
9 the conditions under which a foreign national may be admitted to and remain in the United
10 States. *Id.* §§ 1181-1182, 1184. The INA also contains an alien registration system intended
11 to monitor the entry and movement of aliens in the United States. *Id.* §§ 1201(b), 1301-1306.
12 Various actions may subject an alien to being placed in removal proceedings, such as entering
13 the United States without inspection, presenting fraudulent documents at a port of entry,
14 violating the conditions of admission, or engaging in certain other proscribed conduct. *Id.* §§
15 1225, 1227, 1228, 1229, 1229c, 1231. Violations of immigration laws may also subject an
16 alien to civil and criminal sanctions. *E.g., id.* §§ 1325, 1306, 1324c. Unlawful presence in the
17 United States is not a federal crime, although it may make the alien removable. *See id.* §§
18 1182(a)(6)(A)(i), 1227(a)(1)(B)-(C).³

19 Federal alien smuggling laws make it a crime to knowingly bring an unauthorized alien
20 into the country, as well as to harbor such a person or to facilitate unlawful immigration. *Id.*
21 § 1324. Congress also created sanctions to be implemented against employers who knowingly
22 employ aliens who are not authorized to work when it passed the Immigration Reform and
23 Control Act (“IRCA”) in 1986. *Id.* § 1324a(a)(1)-(2). Federal law contains no criminal
24 sanction for working without authorization, although document fraud is a civil violation under
25 IRCA. *Id.* § 1324c. In 1996, Congress passed the Illegal Immigration Reform and Immigrant

28 § 1326, and unlawful entry into the United States is also a federal crime, 8 U.S.C. § 1325.

1 Responsibility Act (“IRIRA”), which, among other things, created various employment
2 eligibility verification programs. *See Chicanos Por La Causa, Inc. v. Napolitano (Chicanos*
3 *Por La Causa II)*, 558 F.3d 856, 861 (9th Cir. 2009).

4 Federal immigration law also envisions certain areas of cooperation in immigration
5 enforcement among the federal government and state and local governments. *See* 8 U.S.C. §
6 1357(g)(1)-(9) (permitting DHS to enter into agreements whereby appropriately trained and
7 supervised state and local officials can perform certain immigration responsibilities); *id.* §
8 1373 (establishing parameters for information-sharing between state and local officials and
9 federal immigration officials); *id.* § 1252c (authorizing state and local law enforcement
10 officials to arrest aliens unlawfully present in the United States who have previously been
11 convicted of a felony and deported). DHS has also established the Law Enforcement Support
12 Center (“LESC”), which is administered by Immigration and Customs Enforcement (“ICE”)
13 and serves as a national enforcement information center, answering queries from state and
14 local officials regarding immigration status. (Pl.’s Mot., Ex. 3, Decl. of David Palmatier, Unit
15 Chief for LESC (“Palmatier Decl.”) ¶¶ 3-6.)

16 **B. Overview of S.B. 1070**

17 **1. Section 1**

18 Section 1 of S.B. 1070 states that “the intent of [S.B. 1070] is to make attrition through
19 enforcement the public policy of all state and local government agencies in Arizona” and that
20 “[t]he provisions of this act are intended to work together to discourage and deter the unlawful
21 entry and presence of aliens and economic activity by persons unlawfully present in the
22 United States.” Section 1 also states that “there is a compelling interest in the cooperative
23 enforcement of federal immigration laws throughout all of Arizona.”

24 **2. Section 2**

25 Section 2 of S.B. 1070 adds A.R.S. § 11-1051. Section 2 contains twelve separate
26 subsections. Subsection 2(A) prohibits Arizona officials, agencies and political subdivisions
27 from limiting or restricting the enforcement of federal immigration laws. A.R.S. § 11-
28 1051(A). Subsection 2(B) requires officers to make a reasonable attempt, when practicable,

1 to determine an individual’s immigration status during any lawful stop, detention, or arrest
2 where reasonable suspicion exists that the person is unlawfully present in the United States.
3 *Id.* § 11-1051(B). Subsection 2(B) also requires that all persons who are arrested have their
4 immigration status verified prior to release. *Id.* Subsections 2(B) and 2(E) provide the process
5 for verifying immigration status and list documents that create a presumption of lawful
6 presence. *Id.* § 11-1051(B), (E). Mandatory stops for the purpose of immigration status
7 verification are not required or authorized by Subsection 2(B). Subsection 2(C) requires
8 notification of ICE or Customs and Border Protection whenever an unlawfully present alien
9 is discharged or assessed a monetary obligation. *Id.* § 11-1051(C). Subsections 2(D) and (F)
10 permit law enforcement to securely transport unlawfully present aliens and send, receive, and
11 exchange information related to immigration status. *Id.* § 11-1051(D), (F).

12 In addition, Subsection 2(H) permits legal residents of Arizona to bring actions in state
13 court “to challenge any official or agency of [Arizona] that adopts or implements a policy or
14 practice that limits or restricts the enforcement of federal immigration laws to less than the
15 full extent permitted by federal law.” *Id.* § 11-1051(H). Subsections 2(I) and (J) address the
16 civil penalties arising from such civil suits, and Subsection 2(K) provides that law
17 enforcement officers are indemnified against reasonable costs and expenses incurred by the
18 officer in connection with any suit initiated under this Section unless the officer is found to
19 have acted in bad faith. *Id.* § 11-1051(I)-(K).

20 3. Section 3

21 Section 3 of S.B. 1070 adds A.R.S. § 13-1509, which provides that “a person is guilty
22 of willful failure to complete or carry an alien registration document if the person is in
23 violation of [8 U.S.C. §§] 1304(e) or 1306(a),” federal statutes that require aliens to carry
24 documentation of registration and penalize the willful failure to register. A.R.S. § 13-1509(A).
25 Violation of Section 3 is a class 1 misdemeanor and results in a maximum fine of \$100 and
26 a maximum of 20 days in jail for a first violation and up to 30 days in jail for any subsequent
27 violation. *Id.* § 13-1509(H). Section 3 limits a violator’s eligibility for a suspended sentence,
28 probation, pardon, and commutation of a sentence and requires violators to pay jail costs. *Id.*

1 § 13-1509(D), (E). In the enforcement of Section 3, immigration status may be determined
2 by a law enforcement officer authorized by the federal government or pursuant to 8 U.S.C.
3 § 1373(c). *Id.* § 13-1509(B). Pursuant to Subsection 3(C), law enforcement officers are not
4 permitted to consider race, color, or national origin in the enforcement of Section 3. *Id.* § 13-
5 1509(C). Finally, Section 3 does not apply to “a person who maintains authorization from the
6 federal government to remain in the United States.” *Id.* § 13-1509(F).

7 **4. Section 4**

8 In Section 4 of S.B. 1070, the Arizona Legislature revised A.R.S. § 13-2319 by adding
9 a provision that permits officers enforcing Arizona’s human smuggling statute to stop any
10 person who is operating a motor vehicle if the officer has reasonable suspicion to believe that
11 the person is in violation of any civil traffic law. *Id.* § 13-2319(E). Section 4 does not make
12 any other changes or additions to Arizona’s human smuggling statute, A.R.S. § 13-2319.

13 **5. Section 5**

14 Section 5 of S.B. 1070 adds two provisions to the Arizona Criminal Code, A.R.S. §§
15 13-2928 and 13-2929. A.R.S. § 13-2928(A) provides that it is unlawful for an occupant of a
16 motor vehicle that is stopped on a street, roadway, or highway and is impeding traffic to
17 attempt to hire a person for work at another location. *Id.* § 13-2928(A). Similarly, A.R.S. §
18 13-2928(B) provides that it is unlawful for a person to enter a motor vehicle in order to be
19 hired if the vehicle is stopped on a street, roadway, or highway and is impeding traffic. *Id.* §
20 13-2928(B). Finally, A.R.S. § 13-2928(C) provides that it is unlawful “for a person who is
21 unlawfully present in the United States and who is an unauthorized alien to knowingly apply
22 for work, solicit work in a public place or perform work as an employee or independent
23 contractor in this state.” *Id.* § 13-2928(C). Violation of A.R.S. § 13-2928 is a class 1
24 misdemeanor. *Id.* § 13-2928(F).

25 Section 5 of S.B. 1070 also creates A.R.S. § 13-2929, which provides that it is
26 unlawful for a person who is in violation of a criminal offense to: (1) transport or move or
27 attempt to transport or move an alien in Arizona in furtherance of the alien’s unlawful
28 presence in the United States; (2) conceal, harbor, or shield or attempt to conceal, harbor, or

1 shield an alien from detection in Arizona; and (3) encourage or induce an alien to come to or
2 live in Arizona. *Id.* § 13-2929(A)(1)-(3). In order to violate A.R.S. § 13-2929(A), a person
3 must also know or recklessly disregard the fact that the alien is unlawfully present in the
4 United States. *Id.* Violation of A.R.S. § 13-2929 is a class 1 misdemeanor. *Id.* § 13-2929(F).

5 **6. Section 6**

6 Section 6 of S.B. 1070 amends A.R.S. § 13-3883 to permit an officer to arrest a person
7 without a warrant if the officer has probable cause to believe that “the person to be arrested
8 has committed any public offense that makes the person removable from the United States.”
9 *Id.* § 13-3883(A)(5).

10 **7. Sections 7-13**

11 Sections 7, 8, and 9 amend Arizona’s law imposing sanctions on employers who hire
12 unlawfully present aliens. *See* A.R.S. §§ 23-212, 23-212.01, 23-214. Section 10 amends
13 A.R.S. § 28-3511 to allow for the immobilization or impoundment of vehicles used in the
14 transporting and concealing of unlawfully present aliens where the driver of the vehicle knew
15 or recklessly disregarded the fact that the alien was unlawfully present. Section 11 creates the
16 “gang and immigration intelligence team enforcement mission fund” for civil penalties paid
17 pursuant to Subsection 2(I). Finally, Section 12 provides for the severance of any
18 unconstitutional provisions, and Section 13 provides a short title for the enactment.

19 **C. Procedural Posture**

20 The United States filed its Complaint challenging the constitutionality of S.B. 1070 on
21 July 6, 2010, naming as Defendants the State of Arizona and Governor Brewer in her official
22 capacity (collectively, “Arizona”). On the same day, it also filed a Motion requesting that the
23 Court preliminarily enjoin Arizona from enforcing S.B. 1070 until the Court can make a final
24 determination as to its constitutionality. (Doc. 6, Pl.’s Lodged Proposed Mot. for Prelim. Inj.)
25 The United States argues principally that the power to regulate immigration is vested
26 exclusively with the federal government, and the provisions of S.B. 1070 are therefore
27 preempted by federal law. The Court held a Hearing on Plaintiff’s Motion on July 22, 2010
28

1 (“the Hearing”). S.B. 1070 has an effective date of July 29, 2010. The Court now considers
2 the United States’ Motion for Preliminary Injunction.

3 **III. LEGAL STANDARDS AND ANALYSIS**

4 **A. General Legal Standards**

5 “A plaintiff seeking a preliminary injunction must establish that he is likely to succeed
6 on the merits, that he is likely to suffer irreparable harm in the absence of preliminary relief,
7 that the balance of equities tips in his favor, and that an injunction is in the public interest.”
8 *Winter v. Natural Res. Def. Council, Inc.*, 129 S. Ct. 365, 374 (2008) (citations omitted).

9 The United States primarily asserts that the statutory provisions contained in S.B. 1070
10 are preempted by federal law. The Supremacy Clause of the United States Constitution makes
11 federal law “the supreme law of the land.” U.S. Const. art. VI, cl. 2. The Supreme Court has
12 consistently ruled that the federal government has broad and exclusive authority to regulate
13 immigration, supported by both enumerated and implied constitutional powers.⁴ While
14 holding that the “[p]ower to regulate immigration is unquestionably exclusively a federal
15 power,” the Supreme Court concluded that not every state enactment “which in any way deals
16 with aliens is a regulation of immigration and thus per se preempted by this constitutional
17 power, whether latent or exercised.” *De Canas v. Bica*, 424 U.S. 351, 354-355 (1976).

18 Federal preemption can be either express or implied. *Chicanos Por La Causa v.*
19 *Napolitano (Chicanos Por La Causa I)*, 544 F.3d 976, 982 (9th Cir. 2008), *cert. granted*, 78
20 U.S.L.W. 3065, 78 U.S.L.W. 3754, 78 U.S.L.W. 3762 (U.S. June 28, 2010) (No. 09-115).
21 There are two types of implied preemption: field preemption and conflict preemption. *Id.*
22 Field preemption occurs “where ‘the depth and breadth of a congressional scheme . . .
23 occupies the legislative field.’” *Id.* (quoting *Lorillard Tobacco Co. v. Reilly*, 533 U.S. 525,
24

25 ⁴ A variety of enumerated powers implicate the federal government’s long-recognized
26 immigration power, including the Commerce Clause, the Naturalization Clause, and the
27 Migration and Importation Clause. *See* U.S. Const. art. I, § 8, cl. 3-4; art. I, § 9, cl. 1; *see also*
28 *Fong Yue Ting v. United States*, 149 U.S. 698, 706 (1893); *Chae Chan Ping v. United States*,
130 U.S. 581, 603-04 (1889).

1 541 (2001)). Conflict preemption describes a situation in which “compliance with both federal
2 and state regulations is a physical impossibility or where state law stands as an obstacle to the
3 accomplishment and execution of the full purposes and objectives of Congress.” *Id.* (internal
4 quotations and citations omitted). An actual, as opposed to hypothetical or potential, conflict
5 must exist for conflict preemption to apply. *Id.*

6 **B. Likelihood of Success on the Merits**

7 The United States must first demonstrate a likelihood of success on the merits. *Winter*,
8 129 S. Ct. at 374. The United States challenges S.B. 1070 on its face, before it takes effect on
9 July 29, 2010. (Pl.’s Mot. at 7.) “A facial challenge to a legislative Act is, of course, the most
10 difficult challenge to mount successfully, since the challenger must establish that no set of
11 circumstances exists under which the Act would be valid.” *United States v. Salerno*, 481 U.S.
12 739, 745 (1987). The Supreme Court later observed, in considering a facial challenge,
13 “[S]ome Members of the Court have criticized the *Salerno* formulation, [but] all agree that
14 a facial challenge must fail where a statute has a ‘plainly legitimate sweep.’” *Wash. State*
15 *Grange v. Wash. State Republican Party*, 552 U.S. 442, 449 (2008) (quoting *Washington v.*
16 *Glucksberg*, 521 U.S. 702, 739-40 & n.7 (1997) (Stevens, J., concurring in judgments)). In
17 deciding a facial challenge, courts “must be careful not to go beyond the statute’s facial
18 requirements and speculate about ‘hypothetical’ or ‘imaginary’ cases.” *Id.* at 449-50 (quoting
19 *United States v. Raines*, 362 U.S. 17, 22 (1960)).

20 **1. Preemption of Overall Statutory Scheme**

21 As discussed above, S.B. 1070 contains several provisions adding to and amending
22 Arizona law. While the United States has requested that the Court enjoin S.B. 1070 in its
23 entirety, it specifically challenges only select provisions of S.B. 1070. (*See* Pl.’s Mot. at 12
24 n.8 (noting that “the instant motion does not seek to enjoin” Sections 7-9 of S.B. 1070 and that
25 Sections 11-13 “are administrative provisions which are not the subject of this dispute”).) The
26 United States also argues that the overall statutory scheme of S.B. 1070 is preempted because
27 it attempts to set immigration policy at the state level and interferes and conflicts with federal
28

1 immigration law, foreign relations, and foreign policy. (*Id.* at 12-25.) Section 1 of S.B. 1070
2 declares a unified, state-wide public policy, providing:

3 The legislature declares that the intent of this act is to make attrition through
4 enforcement the public policy of all state and local government agencies in
5 Arizona. The provisions of this act are intended to work together to discourage
and deter the unlawful entry and presence of aliens and economic activity by
persons unlawfully present in the United States.

6 S.B. 1070 § 1. The United States urges the Court to enjoin S.B. 1070 as an integrated statutory
7 enactment with interlocking provisions. (Pl.’s Mot. at 12-25.) The United States asserts that
8 Section 1 animates and “infuses” the operative sections of the law. (Hr’g Tr. 13:4-14:5.)

9 “[W]hen the constitutionality of a state statute is challenged, principles of state law
10 guide the severability analysis and [courts] should strike down only those provisions which
11 are inseparable from the invalid provisions.” *Costco Wholesale Corp. v. Maleng*, 522 F.3d
12 874, 886 (9th Cir. 2008) (citing *Tucson Woman’s Clinic v. Eden*, 379 F.3d 531, 556-57 (9th
13 Cir. 2004)). “A court should not declare an entire statute unconstitutional if the constitutional
14 portions can be severed from those which are unconstitutional.” *State v. Ramsey*, 831 P.2d
15 408, 413 (Ariz. Ct. App. 1992) (citing *State v. Prentiss*, 786 P.2d 932, 937 (Ariz. 1989)).

16 Under Arizona law,

17 it is well settled . . . that where the valid parts of a statute are effective and
18 enforceable standing alone and independent of those portions declared
19 unconstitutional, the court will not disturb the valid law if the valid and invalid
portions are not so intimately connected as to raise the presumption the
legislature would not have enacted one without the other, and the invalid
portion was not the inducement of the act.

20 *Selective Life Ins. Co. v. Equitable Life Assurance Soc’y of the U.S.*, 422 P.2d 710, 715 (Ariz.
21 1967) (citing *McCune v. City of Phx.*, 317 P.2d 537, 542 (Ariz. 1957)). In determining
22 whether potentially unconstitutional provisions of S.B. 1070 may be severed from the
23 remainder of the enactment, the primary concern is legislative intent. *See id.* at 715-16 (citing
24 *City of Mesa v. Killingsworth*, 394 P.2d 410, 413 (Ariz. 1964)). Where a statute contains a
25 severability provision, Arizona courts generally attempt to give effect to the severability
26 clause. *Id.* at 715.

1 Section 12(A) of S.B. 1070 provides for the severability of S.B. 1070’s provisions,
2 stating that if any provision of the Act “is held invalid, the invalidity does not affect other
3 provisions . . . that can be given effect without the invalid provision.” Arizona’s Legislature
4 intended the provisions of S.B. 1070 to be severable in order to preserve the constitutional
5 provisions of the Act. As a result, where the provisions of S.B. 1070 are “effective and
6 enforceable standing alone and independent” of any unconstitutional provisions and the valid
7 portions are not so “intimately connected” to any invalid provision as to raise the presumption
8 that the Arizona Legislature would not have enacted the valid provisions without the invalid
9 provisions, S.B. 1070’s provisions are severable. *See Selective Life Ins.*, 422 P.2d at 715.

10 While Section 1 of S.B. 1070 provides a statement of the Act’s intent and purpose, it
11 does not create a single and unified statutory scheme incapable of careful provision by
12 provision analysis. The Court cannot enjoin a purpose; the Arizona Legislature is free to
13 express its viewpoint and intention as it wishes, and Section 1 has no operative function.
14 However, this is not to say that Section 1 is irrelevant. The expression of the Legislature’s
15 intent provides context and backdrop for the functional enactments of S.B. 1070, and the
16 Court considers it in this capacity as it analyzes the other provisions of the law.

17 S.B. 1070 will not be enjoined in its entirety. The Court will not ignore the obligation
18 to preserve the constitutional provisions of a state legislative enactment or S.B. 1070’s
19 severability clause. The Court thus evaluates the constitutionality of the individual provisions
20 of S.B. 1070 challenged by the United States.

21 **2. Section 2(B): A.R.S. § 11-1051(B)**

22 Section 2(B) of S.B. 1070 provides as follows:

23 For any lawful stop, detention or arrest made by [an Arizona] law enforcement
24 official or . . . law enforcement agency . . . in the enforcement of any other law
25 or ordinance of a county, city or town of this state where reasonable suspicion
26 exists that the person is an alien and is unlawfully present in the United States,
27 a reasonable attempt shall be made, when practicable, to determine the
28 immigration status of the person, except if the determination may hinder or
obstruct an investigation. Any person who is arrested shall have the person’s
immigration status determined before the person is released.

1 A.R.S. § 11-1051(B). Section 2(B) also states that if an officer is presented with one of the
2 following forms of identification, the officer is to presume that the person is not an
3 unauthorized alien: (1) a valid Arizona driver license or identification license; (2) a valid
4 tribal enrollment card or other form of tribal identification; or (3) a valid United States federal,
5 state, or local form of identification, provided that the issuing entity requires proof of
6 citizenship before issuance. *Id.* The United States argues that this section is preempted
7 because it will result in the harassment of lawfully present aliens and will burden federal
8 resources and impede federal enforcement and policy priorities. (Pl.’s Mot. at 25-32.)

9 **a. Mandatory Immigration Status Determination Upon Arrest**

10 The Court first addresses the second sentence of Section 2(B): “Any person who is
11 arrested shall have the person’s immigration status determined before the person is released.”
12 Arizona advances that the proper interpretation of this sentence is “that *only* where a
13 reasonable suspicion exists that a person arrested is an alien and is unlawfully present in the
14 United States *must* the person’s immigration status be determined before the person is
15 released.” (Defs.’ Resp. to Pl.’s Mot. (“Defs.’ Resp.”) at 10.)⁵ Arizona goes on to state, “[T]he
16 Arizona Legislature could not have intended to compel Arizona’s law enforcement officers
17 to determine and verify the immigration status of *every single person* arrested – even for
18 United States citizens and when there is absolutely no reason to believe the person is
19 unlawfully present in the country.” (*Id.*)

20 The Court cannot interpret this provision as Arizona suggests. Before the passage of
21 H.B. 2162, the first sentence of Section 2(B) of the original S.B. 1070 began, “For any lawful
22 contact” rather than “For any lawful stop, detention or arrest.” (*Compare* original S.B. 1070
23 § 2(B) *with* H.B. 2162 § 3(B).) The second sentence was identical in the original version and
24 as modified by H.B. 2162. It is not a logical interpretation of the Arizona Legislature’s intent
25 to state that it originally intended the first two sentences of Section 2(B) to be read as
26

27 ⁵ Arizona acknowledges that this sentence of Section 2(B) “might well have been more
28 artfully worded.” (*Id.*)

1 dependent on one another. As initially written, the first sentence of Section 2(B) did not
2 contain the word “arrest,” such that the second sentence could be read as modifying or
3 explicating the first sentence. In S.B. 1070 as originally enacted, the first two sentences of
4 Section 2(B) are clearly independent of one another. Therefore, it does not follow logically
5 that by changing “any lawful contact” to “any lawful stop, detention or arrest” in the first
6 sentence, the Arizona Legislature intended to alter the meaning of the second sentence in any
7 way. If that had been the Legislature’s intent, it could easily have modified the second
8 sentence accordingly.

9 As a result of this conclusion, the Court reads the second sentence of Section 2(B)
10 independently from the first sentence. The Court also concludes that the list of forms of
11 identification that could provide a presumption that a person is not an unlawfully present alien
12 applies only to the first sentence of Section 2(B) because the second sentence makes no
13 mention of unlawful presence: the second sentence states plainly that “[a]ny person who is
14 arrested” must have his or her immigration status determined before release. A presumption
15 against unlawful presence would not dispose of the requirement that immigration status be
16 checked because a legal permanent resident might have a valid Arizona driver’s license, but
17 an inquiry would still need to be made to satisfy the requirement that the person’s
18 “immigration status” be determined prior to release.

19 The United States asserts that mandatory determination of immigration status for all
20 arrestees “conflicts with federal law because it necessarily imposes substantial burdens on
21 lawful immigrants in a way that frustrates the concern of Congress for nationally-uniform
22 rules governing the treatment of aliens throughout the country – rules designed to ensure ‘our
23 traditional policy of not treating aliens as a thing apart.’” (Pl.’s Mot. at 26 (quoting *Hines v.*
24 *Davidowitz*, 312 U.S. 52, 73 (1941)).) Finding a state law related to alien registration to be
25 preempted, the Supreme Court in *Hines* observed that Congress “manifested a purpose to
26 [regulate immigration] in such a way as to protect the personal liberties of law-abiding aliens
27 through one uniform national . . . system[] and to leave them free from the possibility of
28 inquisitorial practices and police surveillance.” 312 U.S. at 74.

1 Requiring Arizona law enforcement officials and agencies to determine the
2 immigration status of every person who is arrested burdens lawfully-present aliens because
3 their liberty will be restricted while their status is checked. Given the large number of people
4 who are technically “arrested” but never booked into jail or perhaps even transported to a law
5 enforcement facility, detention time for this category of arrestee will certainly be extended
6 during an immigration status verification. (*See Escobar, et al. v. City of Tucson, et al.*, No. CV
7 10-249-TUC-SRB, Doc. 9, City of Tucson’s Answer & Cross-cl., ¶ 38 (stating that during
8 fiscal year 2009, Tucson used the cite-and-release procedure provided by A.R.S. § 13-3903
9 to “arrest” and immediately release 36,821 people).) Under Section 2(B) of S.B. 1070, all
10 arrestees will be required to prove their immigration status to the satisfaction of state
11 authorities, thus increasing the intrusion of police presence into the lives of legally-present
12 aliens (and even United States citizens), who will necessarily be swept up by this
13 requirement.⁶

14 The United States argues that the influx of requests for immigration status
15 determination directed to the federal government or federally-qualified officials would
16 “impermissibly shift the allocation of federal resources away from federal priorities.” (Pl.’s
17 Mot. at 30.) State laws have been found to be preempted where they imposed a burden on a
18 federal agency’s resources that impeded the agency’s function. *See Buckman Co. v. Plaintiffs’*
19 *Legal Comm.*, 531 U.S. 341, 351 (2001) (finding a state law preempted in part because it
20 would create an incentive for individuals to “submit a deluge of information that the [federal
21 agency] neither wants nor needs, resulting in additional burdens on the FDA’s evaluation of
22 an application”); *cf. Garrett v. City of Escondido*, 465 F. Supp. 2d 1043, 1057 (S.D. Cal.
23 2006) (expressing concern in preemption analysis for preliminary injunction purposes that
24 burden on DOJ and DHS as a result of immigration status checks could “impede the functions
25 of those federal agencies”).

26
27 ⁶The Court is also cognizant of the potentially serious Fourth Amendment problems with the
28 inevitable increase in length of detention while immigration status is determined, as raised
by the plaintiffs in *Friendly House, et al. v. Whiting, et al.*, No. CV 10-1061-PHX-SRB.

1 Pursuant to 8 U.S.C. § 1373(c), DHS is required to “respond to an inquiry by a Federal,
2 State, or local government agency, seeking to verify or ascertain the citizenship or
3 immigration status . . . for any purpose authorized by law, by providing the requested
4 verification or status information.” DHS has, in its discretion, set up LESC, which is
5 administered by ICE and “serves as a national enforcement operations center that promptly
6 provides immigration status and identity information to local, state, and federal law
7 enforcement agencies regarding aliens suspected of, arrested for, or convicted of criminal
8 activity.” (Pl.’s Mot. at 6-7 (citing Palmatier Decl. ¶¶ 3-6).) Mr. Palmatier states in his
9 Declaration that LESC resources are currently dedicated in part to national security objectives
10 such as requests for immigration status determination from the United States Secret Service,
11 the FBI, and employment-related requests at “national security related locations that could be
12 vulnerable to sabotage, attack, or exploitation.” (Palmatier Decl. ¶ 4.) Thus, an increase in the
13 number of requests for determinations of immigration status, such as is likely to result from
14 the mandatory requirement that Arizona law enforcement officials and agencies check the
15 immigration status of any person who is arrested, will divert resources from the federal
16 government’s other responsibilities and priorities.

17 For these reasons, the United States has demonstrated that it is likely to succeed on its
18 claim that the mandatory immigration verification upon arrest requirement contained in
19 Section 2(B) of S.B. 1070 is preempted by federal law. This requirement, as stated above, is
20 likely to burden legally-present aliens, in contravention of the Supreme Court’s directive in
21 *Hines* that aliens not be subject to “the possibility of inquisitorial practices and police
22 surveillance.” 312 U.S. at 74. Further, the number of requests that will emanate from Arizona
23 as a result of determining the status of every arrestee is likely to impermissibly burden federal
24 resources and redirect federal agencies away from the priorities they have established.⁷

25
26 ⁷ The problems associated with burdening federal resources are even more acute when
27 considered in light of other state laws similar to this provision. (See Pl.’s Mot. at 31-32
28 (citing to a newspaper article stating that at least 18 other states are considering parallel
legislation).); see also *North Dakota v. United States*, 495 U.S. 423, 458-59 (1990) (Brennan,

1 countries,⁸ individuals who have applied for asylum but not yet received an adjudication,
2 people with temporary protected status, U and T non-immigrant visa applicants, or people
3 who have self-petitioned for relief under the Violence Against Women Act. (*Id.* at 26-27.)
4 Also, the United States points out that United States citizens are not required to carry
5 identification, and some citizens might not have easy access to a form of identification that
6 would satisfy the requirement of Section 2(B).⁹

7 The United States contends that the impact on lawfully-present aliens of the
8 requirement that law enforcement officials, where practicable, check the immigration status
9 of a person lawfully stopped, detained, or arrested where there is reasonable suspicion that the
10 person is an alien and is unlawfully present will be exacerbated by several factors. (*Id.* at 28-
11 29.) First, the United States suggests that the impact on lawfully-present aliens is enhanced
12 because this requirement applies to stops for even very minor, non-criminal violations of state
13 law, including jaywalking, failing to have a dog on a leash, or riding a bicycle on the
14 sidewalk. (*Id.* at 28.) Also, the United States argues that the impact will be increased because
15 other provisions in S.B. 1070 put pressure on law enforcement agencies and officials to
16 enforce the immigration laws vigorously.¹⁰ (*Id.* at 29.)

17 *Hines* cautions against imposing burdens on lawfully-present aliens such as those
18 described above. *See* 312 U.S. at 73-74. Legal residents will certainly be swept up by this
19 requirement, particularly when the impacts of the provisions pressuring law enforcement
20

21 ⁸ The Visa Waiver Program permits visitors from certain countries to enter the United States
22 without a visa, so long as various requirements are met. *See, e.g.*, 8 U.S.C. § 1187; 8 C.F.R.
23 §§ 217.1-217.7.

24 ⁹ Also, upon a check with LESC or a federally-authorized state official, the status of a United
25 States citizen might not be easily confirmable as many people born in the United States likely
do not have an entry in a DHS database.

26 ¹⁰ These provisions include Sections 2(A) and 2(H), which, respectively, prohibit agencies
27 from restricting the enforcement of immigration laws and create a private right of action for
28 legal residents to sue agencies if they believe the laws are not being enforced aggressively
enough.

1 agencies to enforce immigration laws are considered. *See* A.R.S. § 11-1051(A), (H). Certain
2 categories of people with transitional status and foreign visitors from countries that are part
3 of the Visa Waiver Program will not have readily available documentation of their
4 authorization to remain in the United States, thus potentially subjecting them to arrest or
5 detention, in addition to the burden of “the possibility of inquisitorial practices and police
6 surveillance.” *Hines*, 312 U.S. at 74. In *Hines*, the Supreme Court emphasized the important
7 federal responsibility to maintain international relationships, for the protection of American
8 citizens abroad as well as to ensure uniform national foreign policy. *Id.* at 62-66; *see also*
9 *Zadvydas v. Davis*, 533 U.S. 678, 700 (2001) (“We recognize . . . the Nation’s need to ‘speak
10 with one voice’ in immigration matters.”). The United States asserts, and the Court agrees,
11 that “the federal government has long rejected a system by which aliens’ papers are routinely
12 demanded and checked.” (Pl.’s Mot. at 26.)¹¹ The Court finds that this requirement imposes
13 an unacceptable burden on lawfully-present aliens.

14 With respect to the United States’ arguments regarding the burden on and impediment
15 of federal resources as they relate to the first sentence of Section 2(B), the Court’s conclusions
16 mirror those stated above regarding the second sentence of Section 2(B). Federal resources
17 will be taxed and diverted from federal enforcement priorities as a result of the increase in
18 requests for immigration status determination that will flow from Arizona if law enforcement
19 officials are required to verify immigration status whenever, during the course of a lawful
20 stop, detention, or arrest, the law enforcement official has reasonable suspicion of unlawful
21 presence in the United States.¹² In combination with the impermissible burden this provision
22 will place on lawfully-present aliens, the burden on federal resources and priorities also leads
23

24 ¹¹ The Court notes, but does not analyze here, the arguments raised by the plaintiffs in
25 *Friendly House*, No. CV 10-1061-PHX-SRB, regarding racial profiling.

26 ¹² Many law enforcement officials already have the *discretion* to verify immigration status
27 if they have reasonable suspicion, in the absence of S.B. 1070; Section 2 of S.B. 1070
28 removes that discretion by making immigration status determinations mandatory where
practicable. (*See* Pl.’s Mot. at 26; Defs.’ Resp. at 20.)

1 to an inference of preemption. Therefore, for the purposes of preliminary injunction analysis,
2 the Court concludes that the United States has demonstrated a likelihood of success on its
3 challenge to the first sentence of Section 2(B). Section 2(B) in its entirety is likely preempted
4 by federal law.

5 **3. Section 3: A.R.S. § 13-1509**

6 Section 3 states that “a person is guilty of willful failure to complete or carry an alien
7 registration document if the person is in violation of 8 [U.S.C. §§] 1304(e) or 1306(a).” A.R.S.
8 § 13-1509(A).¹³ The penalties for violation of Section 3, a class 1 misdemeanor, are a
9 maximum fine of \$100 and a maximum of 20 days in jail for a first violation and up to 30
10 days in jail for any subsequent violation. A.R.S. § 13-1509(H). Section 3 also limits violators’
11 eligibility for suspension of sentence, probation, pardon, and commutation of a sentence and
12 requires violators to pay jail costs. A.R.S. § 13-1509(D), (E). Section 3 does not apply to “a
13 person who maintains authorization from the federal government to remain in the United
14 States.” A.R.S. § 13-1509(F). Essentially, Section 3 makes it a state crime to violate federal
15 registration laws and provides for state prosecutions and penalties for violations of the federal
16 registration law. The United States argues that Section 3 is preempted because it interferes
17 with comprehensive federal alien registration law, seeks to criminalize unlawful presence, and
18 will result in the harassment of aliens. (Pl.’s Mot. at 34-39.) Arizona asserts that Section 3
19 neither conflicts with federal law nor regulates in a federally occupied field. (Defs.’ Resp. at
20 21-22.)

21 “[T]he power to restrict, limit, regulate, and register aliens as a distinct group is not an
22 equal and continuously existing concurrent power of state and nation[;] . . . whatever power
23

24
25 ¹³ 8 U.S.C. § 1306(a) makes it a misdemeanor, subject to a maximum fine of \$1000 and a
26 maximum of six months imprisonment, to willfully fail or refuse to apply for registration
27 when such application is required. Similarly, 8 U.S.C. § 1304(e) requires an alien to carry
28 a certificate of alien registration or alien registration receipt and makes a failure to comply
with these requirements a misdemeanor subject to a maximum fine of \$100 and
imprisonment for up to 30 days.

1 a state may have is subordinate to supreme national law.” *Hines*, 312 U.S. at 68. In *Hines*, the
2 Supreme Court found that,

3 where the federal government, in the exercise of its superior authority in this
4 field, has enacted a complete scheme of regulation and has therein provided
5 a standard for the registration of aliens, states cannot, inconsistently with the
purpose of Congress, conflict or interfere with, curtail or complement, the
federal law, or enforce additional or auxiliary regulations.

6 312 U.S. at 66-67. *Hines* also stated that a state statute is preempted where it “stands as an
7 obstacle to the accomplishment and execution of the full purposes and objectives of
8 Congress.” *Id.* at 67. The Supreme Court determined in *Hines* that the purpose of the Federal
9 Alien Registration Act was to “make a harmonious whole” and that the Alien Registration Act
10 “provided a standard for alien registration in a single integrated and all-embracing system.”
11 *Id.* at 72, 74. As a result, the *Hines* court held that the state registration scheme at issue could
12 not be enforced. *Id.* at 74.

13 The current federal alien registration requirements create an integrated and
14 comprehensive system of registration. *See id.* (finding that the Alien Registration Act, the
15 precursor to the current alien registration scheme, created a “single integrated and all-
16 embracing system” of registration); 8 U.S.C. §§ 1201, 1301-06 (providing federal registration
17 requirements and penalties). While the Supreme Court rejected the possibility that the INA
18 is so comprehensive that it leaves no room for state action that impacts aliens, *De Canas*, 424
19 U.S. at 358, the Supreme Court has also evaluated the impact of the comprehensive federal
20 alien registration scheme and determined that the complete scheme of registration precludes
21 states from conflicting with or complementing the federal law. *Hines*, 312 U.S. at 66-67.

22 Section 3 attempts to supplement or complement the uniform, national registration
23 scheme by making it a state crime to violate the federal alien registration requirements, which
24 a state may not do “inconsistently with the purpose of Congress.” *Hines*, 312 U.S. at 66-67;
25 *see also* A.R.S. § 13-1509(A). While Section 3 does not create additional registration
26 requirements, the statute does aim to create state penalties and lead to state prosecutions for
27 violation of the federal law. Although the alien registration requirements remain uniform,
28 Section 3 alters the penalties established by Congress under the federal registration scheme.

1 Section 3 stands as an obstacle to the uniform, federal registration scheme and is therefore an
2 impermissible attempt by Arizona to regulate alien registration. *See Hines*, 312 U.S. at 67. As
3 a result, the Court finds that the United States is likely to succeed on its claim that Section 3
4 is preempted by federal law.¹⁴

5 **4. Section 4: Amendment to A.R.S. § 13-2319**

6 Section 4 of S.B. 1070 amends Arizona’s human smuggling statute, A.R.S. § 13-2319.
7 Section 4 adds, “Notwithstanding any other law, in the enforcement of this section a peace
8 officer may lawfully stop any person who is operating a motor vehicle if the officer has
9 reasonable suspicion to believe the person is in violation of any civil traffic law.” A.R.S. § 13-
10 2319(E). The United States requests an injunction prohibiting the enforcement of Section 4
11 but does not seek an injunction as to A.R.S. § 13-2319. (Pl.’s Compl. at 24 (requesting a
12 preliminary and permanent injunction prohibiting the enforcement of Sections 1-6 of S.B.
13 1070).)¹⁵ However, the arguments asserted by the United States in support of enjoining
14 Section 4 pertain entirely to separate provisions of A.R.S. § 13-2319 and do not challenge the
15 change embodied in Section 4. (Pl.’s Mot. at 39-42.)

16 Section 4 makes a minor change to Arizona’s preexisting human smuggling statute,
17 which is not specifically challenged by the United States. Nothing about the section standing
18 alone warrants an injunction. As a result, the Court finds that the United States is not likely
19 to succeed on a claim that Section 4 of S.B. 1070 is preempted by federal law.

20 **5. Section 5: A.R.S. § 13-2928(C)**¹⁶

21 _____
22 ¹⁴ Subsections (B)-(H) pertain to the implementation and enforcement of Section 3. No
23 provisions of Section 3 retain any effect absent Section 3’s operative provision.

24 ¹⁵ At the July 22, 2010, Hearing on the United States’ Motion for a Preliminary Injunction,
25 the United States confirmed that it does not seek to enjoin A.R.S. § 13-2319. (Hr’g Tr. 5:10-
20.)

26 ¹⁶ Two provisions of Section 5 prohibit the act of hiring and being hired by the occupant of
27 a motor vehicle. A.R.S. § 13-2928(A), (B). The Court finds that the June 9, 2010, decision
28 of the Ninth Circuit Court of Appeals in a case contesting a virtually identical local ordinance
in Redondo Beach, California forecloses a challenge to A.R.S. §§ 13-2928 (A) and (B) on

1 Section 5 of S.B. 1070 creates A.R.S. § 13-2928(C), which provides that “it is unlawful
2 for a person who is unlawfully present in the United States and who is an unauthorized alien
3 to knowingly apply for work, solicit work in a public place or perform work as an employee
4 or independent contractor in this state.” This violation is a class 1 misdemeanor. A.R.S. § 13-
5 2928(F). The United States asserts that this provision “is preempted by Congress’s
6 comprehensive scheme, set forth in [IRCA] for regulating the employment of aliens.” (Pl.’s
7 Mot. at 42.) The United States argues that “IRCA reflects Congress’s deliberate choice *not*
8 to criminally penalize unlawfully present aliens for performing work, much less for attempting
9 to perform it.” (*Id.*) Arizona responds that “Congress could have, but chose not to, expressly
10 preempt state and local laws that impose civil or criminal sanctions upon employees.” (Defs.’
11 Resp. at 25.) Arizona contends that, in an area of traditional state sovereignty such as
12 employment, “[p]reemption cannot be lightly inferred.” (*Id.*)

13 “States possess broad authority under their police powers to regulate the employment
14 relationship to protect workers within the State.” *De Canas*, 424 U.S. at 356. Interpreting *De*
15 *Canas* and considering a state law sanctioning employers who hire unauthorized workers, the
16 Ninth Circuit Court of Appeals held that, “because the power to regulate the employment of
17 unauthorized aliens remains within the states’ historic police powers, an assumption of non-
18 preemption appli[ed].” *Chicanos Por La Causa I*, 544 F.3d at 984; *accord Wyeth v. Levine*,
19 129 S. Ct. 1187, 1194-95 (2009) (observing that “[i]n all pre-emption cases, and particularly
20 in those in which Congress has legislated . . . in a field which the States have traditionally
21 occupied, . . . we start with the assumption that the historic police powers of the States were
22 not to be superseded by the Federal Act unless that was the clear and manifest purpose of
23 Congress” (internal quotations and citation omitted)).

24 A.R.S. § 13-2928(C), as amended, regulates the employment of unauthorized aliens
25 in Arizona, and, thus, a presumption against preemption applies in the context of this
26

27 First Amendment grounds. *See Comite de Jornaleros de Redondo Beach v. City of Redondo*
28 *Beach*, 607 F.3d 1178, 1184-93 (9th Cir. 2010).

1 provision. However, while deliberate federal inaction does not always imply preemption,
2 “[w]here a comprehensive federal scheme intentionally leaves a portion of the regulated field
3 without controls, *then* the pre-emptive inference can be drawn, not from federal inaction alone
4 but from inaction joined with action.” *P.R. Dep’t of Consumer Affairs v. Isla Petroleum Corp.*,
5 485 U.S. 495, 503 (1988). The Supreme Court explained in *Puerto Rico Department of*
6 *Consumer Affairs* that with some “extant action” by Congress, there can arise “an inference
7 of pre-emption in an unregulated segment of an otherwise regulated field.” *Id.* at 504; *see also*
8 *Geier v. Am. Honda Motor Co.*, 529 U.S. 861, 869 (2000) (concluding that neither an express
9 pre-emption provision nor a saving clause “bar[s] the ordinary working of conflict pre-
10 emption principles”).

11 IRCA provides penalties for employers who knowingly hire or continue to employ an
12 alien without work authorization. 8 U.S.C. § 1324a(a)(1)-(2), (e)(4). IRCA also prohibits
13 employers from recruiting or referring for a fee unauthorized workers. *Id.* § 1324a(a)(1).
14 IRCA makes it unlawful to use contractors or subcontractors to hire unauthorized alien
15 workers. *Id.* § 1324a(a)(4). Under IRCA, employers are required to comply with an
16 “employment verification system” set up by the statute. *Id.* § 1324a(b).¹⁷ IRCA also instituted
17 a compliance scheme and a series of escalating sanctions for violations, entailing increasing
18 monetary fines for each subsequent violation and the possibility of injunctive sanctions. *Id.*
19 § 1324a(e)(4); 8 C.F.R. § 274a.10 (outlining civil and criminal penalties for violations of 8
20 U.S.C. § 1324a(a)(1)(A) or (a)(2)).

21 While it is readily apparent that Congress’s central focus in IRCA was employer
22 sanctions, there are also targeted sanctions directed at employees. *See* 8 U.S.C. § 1324c
23 (making it a civil violation to make or use a false document or to use a document belonging
24 to another person, in the context of unlawful employment of an unauthorized alien). As the
25 Ninth Circuit Court of Appeals observed, “While Congress initially discussed the merits of

26
27 ¹⁷ IIRIRA created three pilot programs for employee verification; of those three, only the
28 program commonly known as E-Verify is still in existence. *See Chamber of Commerce of*
the United States v. Edmondson, 594 F.3d 742, 752 (10th Cir. 2010).

1 fining, detaining or adopting criminal sanctions against the *employee*, it ultimately rejected
2 all such proposals.” *Nat’l Ctr. for Immigrants’ Rights, Inc. v. INS*, 913 F.2d 1350, 1368 (9th
3 Cir. 1990) (examining IRCA’s legislative history), *rev’d on other grounds*, 502 U.S. 183
4 (1991). The court in *National Center for Immigrants’ Rights* found that the determination to
5 reduce or deter employment of unauthorized workers by sanctioning employers, rather than
6 employees, was “a congressional policy choice clearly elaborated in IRCA.” *Id.* at 1370.

7 IRCA also requires that an individual seeking employment “attest, under penalty of
8 perjury . . . that the individual is a citizen or national of the United States, an alien lawfully
9 admitted for permanent residence, or an alien who is authorized . . . to be hired, recruited, or
10 referred for such employment.” 8 U.S.C. § 1324a(b)(2). This attestation is to be made on a
11 form “designated or established by the Attorney General,” and IRCA states that the form “and
12 any information contained in or appended to such form[] may not be used for purposes other
13 than for enforcement of this chapter and sections 1001, 1028, 1546, and 1621 of Title 18” of
14 the federal criminal code. *Id.* § 1324a(b)(5). The provisions of Title 18 referenced in §
15 1324a(b)(5) of Title 8 make it a federal crime to, in any matter within the jurisdiction of the
16 federal government:

- 17 18 U.S.C. § 1001(a): (1) falsify, conceal, or cover up any material fact;
18 (2) knowingly make or use a materially false,
19 fictitious, or fraudulent statement; or (3) make or
20 use any false writing or document.
- 21 18 U.S.C. § 1028(a): knowingly make, use, or transfer a false or stolen
22 identification document or identification document
23 belonging to another person or any implement or
24 feature for use in creating a false identification
25 document.
- 26 18 U.S.C. § 1546: (a) forge or falsify an immigration document; or
27 (b) use a false identification document, a document
28 not properly issued to the user, or a false
attestation.
- 18 U.S.C. § 1621: commit perjury by knowingly making a false
statement after taking an oath to tell the truth
during a proceeding or on any document signed
under penalty of perjury.

1 Accordingly, the attestation forms described in 8 U.S.C. § 1324a(b)(2) may only be used for
2 these limited purposes.

3 The provision limiting the use of attestation forms and the civil penalties outlined for
4 document fraud in Title 8 and the robust sanctions for employers who hire, continue to
5 employ, or refer unauthorized workers convince the Court that Congress has comprehensively
6 regulated in the field of employment of unauthorized aliens. These “extant actions,” in
7 combination with an absence of regulation for the particular violation of working without
8 authorization, lead to the conclusion that Congress intended not to penalize this action, other
9 than the specific sanctions outlined above. *See P.R. Dep’t of Consumer Affairs*, 485 U.S. at
10 503-04. Thus, the Court finds that Plaintiff is likely to succeed on its claim that Arizona’s new
11 crime for working without authorization, set forth in Section 5(C) of S.B. 1070, conflicts with
12 a comprehensive federal scheme and is preempted.

13 **6. Section 5: A.R.S. § 13-2929**

14 Section 5 of S.B. 1070 also creates A.R.S. § 13-2929, which makes it illegal for a
15 person who is in violation of a criminal offense to: (1) transport or move or attempt to
16 transport or move an alien in Arizona in furtherance of the alien’s unlawful presence in the
17 United States; (2) conceal, harbor, or shield or attempt to conceal, harbor, or shield an alien
18 from detection in Arizona; and (3) encourage or induce an alien to come to or live in Arizona.
19 A.R.S. § 13-2929(A)(1)-(3). In order to violate A.R.S. § 13-2929(A), a person must also know
20 or recklessly disregard the fact that the alien is unlawfully present in the United States. *Id.* The
21 United States asserts that this provision is preempted as an impermissible regulation of
22 immigration and that the provision violates the dormant Commerce Clause. (Pl.’s Mot. at 44-
23 46.)¹⁸

24
25 ¹⁸ The United States also asserts in a footnote that A.R.S. § 13-2929 directly conflicts with
26 8 U.S.C. § 1324(a)(1)(C), a section of the federal alien smuggling statute, which provides an
27 exception for certain religious groups for contact with volunteer ministers and missionaries.
28 (*Id.* at 46 n.40.) While the federal statute includes a narrow exception for religious
organizations engaged in certain conduct not specifically exempted under A.R.S. § 13-2929,
the new Arizona statute is narrower than its federal counterpart because it requires that the

a. Regulation of Immigration

The “[p]ower to regulate immigration is unquestionably exclusively a federal power.” *De Canas*, 424 U.S. at 354. The regulation of immigration is “essentially a determination of who should or should not be admitted into the country, and the conditions under which a legal entrant may remain.” *Id.* at 355. “[T]he fact that aliens are the subject of a state statute does not render it a regulation of immigration.” *Id.* The United States argues that “to the extent Section 5 is not a restriction on interstate movement, it is necessarily a restriction on unlawful entry into the United States.” (Pl.’s Mot. at 45.)

A.R.S. § 13-2929 does not attempt to regulate who should or should not be admitted into the United States, and it does not regulate the conditions under which legal entrants may remain in the United States. *See De Canas*, 424 U.S. at 355. Therefore, the Court concludes that the United States is not likely to succeed on its claim that A.R.S. § 13-2929 is an impermissible regulation of immigration.

b. The Dormant Commerce Clause

The Commerce Clause provides Congress with the power to “regulate Commerce . . . among the several States.” U.S. Const. art. I, § 8, cl. 1, 3. The Supreme Court has interpreted the Commerce Clause “to have a ‘negative’ aspect that denies the States the power unjustifiably to discriminate against or burden the interstate flow of articles of commerce.” *Or. Waste Sys., Inc. v. Dep’t of Env’tl. Quality*, 511 U.S. 93, 98 (1994). This doctrine is often referred to as the “dormant Commerce Clause.” *United Haulers Ass’n v. Oneida-Herkimer*

person already be in violation of a criminal offense. In light of the intentional narrowing of the Arizona enactment, the Court would have to imagine a set of remote circumstances in order to find a potential conflict between the federal and the state law. In addition, Arizona asserts that A.R.S. § 13-2929 targets criminals who engage unlawfully present aliens to be involved in a criminal enterprise. On a facial challenge, “the challenger must establish that no set of circumstances exists under which the Act would be valid.” *Salerno*, 481 U.S. at 745. In deciding a facial challenge, courts “must be careful not to go beyond the statute’s facial requirements and speculate about ‘hypothetical’ or ‘imaginary’ cases.” *Wash. State Grange*, 552 U.S. at 449-50 (quoting *Raines*, 362 U.S. at 22). A.R.S. § 13-2929 is narrower than the federal law, and the Court will not speculate about hypothetical cases in order to find a conflict between the two.

1 *Solid Waste Mgmt. Auth.*, 550 U.S. 330, 338 (2007). “The dormant Commerce Clause is
2 implicated if state laws regulate an activity that ‘has a substantial effect’ on interstate
3 commerce such that Congress could regulate the activity.” *Nat’l Ass’n of Optometrists &
4 Opticians Lenscrafters, Inc. v. Brown*, 567 F.3d 521, 525 (9th Cir. 2009) (quoting
5 *Conservation Force, Inc. v. Manning*, 301 F.3d 985, 993 (9th Cir. 2002)).

6 If a state statute implicates the dormant Commerce Clause, the Court must then
7 determine “whether [the statute] discriminates on its face against interstate commerce.”
8 *United Haulers*, 550 U.S. at 338. “In this context, discrimination simply means differential
9 treatment of in-state and out-of-state economic interests that benefits the former and burdens
10 the latter.” *Id.* (internal quotation and citation omitted). Nondiscriminatory statutes directed
11 at legitimate local concerns do not violate the dormant Commerce Clause ““unless the burden
12 imposed on [interstate] commerce is clearly excessive in relation to the putative local
13 benefits.”” *Id.* at 346 (quoting *Pike v. Bruce Church, Inc.*, 397 U.S. 137, 142 (1970)).

14 The United States argues that A.R.S. § 13-2929 “offends the [d]ormant Commerce
15 Clause by restricting the interstate movement of aliens.” (Pl.’s Mot. at 45.) A.R.S. § 13-2929
16 does not restrict or limit which aliens can enter Arizona. While the regulation of immigration
17 does have an impact on interstate commerce, the United States has not provided a satisfactory
18 explanation of how A.R.S. § 13-2929, which creates parallel state statutory provisions for
19 conduct already prohibited by federal law, has a substantial effect on interstate commerce.¹⁹

22 ¹⁹ The United States argues that the dormant Commerce Clause “forbids certain state
23 regulations attempting to discourage or otherwise restrict the movement of people between
24 states.” (Pl.’s Mot. at 45 (citing *Edwards v. California*, 314 U.S. 160, 172-73 (1941)).)
25 However, the United States fails to cite any authority supporting the proposition that
26 unlawfully present aliens must be permitted to travel from state to state. In *Edwards*, the
27 Supreme Court struck down a California statute prohibiting the transportation of indigent
28 people into California. *Edwards*, 314 U.S. at 173. Unlike the California statute at issue in
Edwards, A.R.S. § 13-2929 prohibits the transportation of people who are unlawfully present
in the United States. Moreover, A.R.S. § 13-2929 does not attempt to prohibit entry into
Arizona, but rather criminalizes specific conduct already prohibited by federal law.

1 Even assuming that A.R.S. § 13-2929 implicates the Commerce Clause, the statutory
2 provision does not discriminate between in-state and out-of-state economic interests. *See*
3 *United Haulers*, 550 U.S. at 338. A.R.S. § 13-2929 governs conduct occurring in Arizona and
4 does not differentiate between in-state and out-of-state economic interests or burden out-of-
5 state interests in a way that benefits in-state interests. Further, Arizona’s nondiscriminatory
6 statute is directed at legitimate local concerns related to public safety. Therefore, A.R.S. § 13-
7 2929 does not violate the dormant Commerce Clause ““unless the burden imposed on
8 [interstate] commerce is clearly excessive in relation to the putative local benefits.”” *Id.* at 346
9 (quoting *Pike*, 397 U.S. at 142). Here, any incidental burden on interstate commerce is
10 minimal in comparison with the putative local benefits. The Court finds that the United States
11 is not likely to succeed on its claim that Section 5’s addition of A.R.S. § 13-2929 violates the
12 dormant Commerce Clause or is an impermissible attempt to regulate immigration.²⁰

13 **7. Section 6: Amendment to A.R.S. § 13-3883(A)**

14 In Section 6 of S.B. 1070, the Arizona Legislature revised A.R.S. § 13-3883 to provide
15 that an officer may arrest a person without a warrant if the officer has probable cause to
16 believe that “the person to be arrested has committed any public offense that makes the person
17 removable from the United States.” A.R.S. § 13-3883(A)(5). In Arizona, a “public offense”
18 is

19 conduct for which a sentence to a term of imprisonment or of a fine is provided
20 by any law of the state in which it occurred or by any law, regulation or
21 ordinance of a political subdivision of that state and, if the act occurred in a
22 state other than this state, it would be so punishable under the laws, regulations
or ordinances of this state or of a political subdivision of this state if the act had
occurred in this state.

23 A.R.S. § 13-105(26). Because A.R.S. § 13-3883 already provides for the warrantless arrest
24 of a person who commits a felony, misdemeanor, petty offense, or one of certain criminal

25 ²⁰ The United States asserts that Section 10 of S.B. 1070 “is preempted insofar as it is based
26 on the state law violations identified in Sections 4 and 5, which are preempted for the reasons
27 discussed herein.” (Pl.’s Mot. at 12 n.8.) As discussed above, the Court finds that Sections
28 4 and 5 are not likely to be preempted by federal law. Therefore, the United States is also not
likely to succeed on its claim that Section 10 is preempted.

1 violations in connection with a traffic accident, the effect of Section 6 on warrantless arrest
2 authority is not entirely clear. Indeed, the Arizona officer training materials state that the
3 revision to A.R.S. § 13-3883 “does not appear to change Arizona law.” *Implementation of the*
4 *2010 Ariz. Immigration Laws - Statutory Provisions for Peace Officers* 11 (June 2010),
5 http://agency.azpost.gov/supporting_docs/ArizonaImmigrationStatutesOutline.pdf. Both the
6 United States, in its Motion, and Arizona, at the Hearing, suggested that the revision provides
7 for the warrantless arrest of a person where there is probable cause to believe the person
8 *committed a crime in another state* that would be considered a crime if it had been committed
9 in Arizona and that would subject the person to removal from the United States. (Pl’s Mot.
10 at 32-33; Hr’g Tr. 46-48.) What is clear is that the statutory revision targets only aliens—legal
11 and illegal—because only aliens are removable. *See Hughes v. Ashcroft*, 255 F.3d 752, 756 (9th
12 Cir. 2001) (citing 8 U.S.C. § 1227).

13 In its brief, Arizona originally asserted that the new provision in A.R.S. § 13-3883 was
14 “based upon a memorandum the DOJ’s Office of Legal Counsel prepared in which it
15 concluded that federal law does not ‘preclude[] state police from arresting aliens on the basis
16 of civil deportability.’” (Defs.’ Resp. at 14 (quoting *id.*, Ex. 4, Mem. from Jay S. Bybee,
17 Assistant Att’y Gen., Re: Non-preemption of the authority of state and local law enforcement
18 officials to arrest aliens for immigration violations, at 13).) Although neither party asserted
19 it at the Hearing, the Arizona Legislature’s intent may have been to provide for the
20 warrantless arrest of an alien who was *previously convicted of a crime in Arizona but never*
21 *referred to DHS for potential removal proceedings*. This alternate interpretation of the
22 revision to A.R.S. § 13-3883 would be in keeping with a goal of conferring on state officers
23 the authority to arrest aliens on the basis of civil deportability.

24 Under the interpretation suggested by both parties that the revision to A.R.S. § 13-3883
25 is directed at the arrest of aliens who committed a crime in another state, the statute first
26 requires an officer to determine whether an alien’s out-of-state crime would have been a crime
27 if it had been committed in Arizona, a determination that requires knowledge of out-of-state
28 statutes and their relationship with Arizona’s statutes. *See State v. Roque*, 141 P.3d 368, 391

1 (Ariz. 2006) (concluding that the California and Arizona robbery statutes are not coterminous
2 and, under certain facts, a person may be convicted of attempted robbery in California but not
3 Arizona). Under any interpretation of the revision to A.R.S. § 13-3883, it requires an officer
4 to determine whether an alien’s public offense makes the alien removable from the United
5 States, a task of considerable complexity that falls under the exclusive authority of the federal
6 government. Justice Alito has commented that

7 providing advice on whether a conviction for a particular offense will make an
8 alien removable is often quite complex. “Most crimes affecting immigration
9 status are not specifically mentioned by the [Immigration and Nationality Act
10 (INA)], but instead fall under a broad category of crimes such as *crimes*
11 *involving moral turpitude* or *aggravated felonies*.” M. Garcia & L. Eig, CRS
Report for Congress, *Immigration Consequences of Criminal Activity* (Sept. 20,
2006) (summary) (emphasis in original). As has been widely acknowledged,
determining whether a particular crime is an “aggravated felony” or a “crime
involving moral turpitude [(CIMT)]” is not an easy task.

12 *Padilla v. Kentucky*, 130 S. Ct. 1473, 1488 (2010) (Alito, J., concurring) (some citations
13 omitted). Within the complicated scheme of determining removability, some federal officials
14 are, under certain circumstances, authorized to change the immigration consequences of the
15 commission of a public offense and cancel or suspend the removal of an alien. *See, e.g.*, 8
16 U.S.C. §§ 1229b(a), 1253(a)(3). Ultimately, immigration court judges and federal appeals
17 court judges determine whether an alien’s offense makes an alien removable. *See id.* §
18 1182(a)(2) (describing crimes that qualify as grounds for inadmissibility); *id.* § 1227(a)(2)
19 (describing crimes that qualify as grounds for deportation).

20 In its Motion, the United States provided evidence that Arizona police officers have
21 no familiarity with assessing whether a public offense would make an alien removable from
22 the United States. (Pl.’s Mot., Ex. 8, Decl. of Tony Estrada, Sheriff of Santa Cruz Cnty. ¶¶
23 8-9; Ex. 9, Decl. of Roberto Villaseñor, Chief of Police, Tucson Police Dep’t ¶ 6.) In its
24 Response, Arizona asserted that, under the new A.R.S. § 11-1051, Arizona officers can
25 contact DHS to determine the immigration status of aliens. (Defs.’ Resp. at 19.) But the
26 revision to A.R.S. § 13-3883 does not state that an officer must contact DHS to assess
27
28

1 removability; the revision simply extends the authority for an officer to make a warrantless
2 arrest.²¹

3 Considering the substantial complexity in determining whether a particular public
4 offense makes an alien removable from the United States and the fact that this determination
5 is ultimately made by federal judges, there is a substantial likelihood that officers will
6 wrongfully arrest legal resident aliens under the new A.R.S. § 13-3883(A)(5). By enforcing
7 this statute, Arizona would impose a “distinct, unusual and extraordinary” burden on legal
8 resident aliens that only the federal government has the authority to impose. *Hines*, 312 U.S.
9 at 65-66. The Court thus finds that the United States is likely to succeed on the merits in
10 showing that A.R.S. § 13-3883(A)(5), created by Section 6 of S.B. 1070, is preempted by
11 federal law.

12 **C. Likelihood of Irreparable Harm**

13 The Supreme Court has repeatedly recognized the “basic doctrine of equity
14 jurisprudence that courts of equity should not act . . . when the moving party has an adequate
15 remedy at law and will not suffer irreparable injury if denied equitable relief.” *Younger v.*
16 *Harris*, 401 U.S. 37, 43-44 (1971). Thus the United States also has the burden to establish
17 that, absent a preliminary injunction, there is a likelihood—not just a possibility—that it will
18 suffer irreparable harm. *Winter*, 129 S. Ct. at 374-75.

19 The Ninth Circuit Court of Appeals has stated ““that an alleged constitutional
20 infringement will often alone constitute irreparable harm.”” *Monterey Mech. Co. v. Wilson*,
21 125 F.3d 702, 715 (9th Cir. 1997) (quoting *Assoc. Gen. Contractors of Cal., Inc. v. Coal. for*

22
23 ²¹ Even if an officer does contact LESC for the immigration status of an alien, it is not clear
24 that LESC will have any information regarding whether a particular public offense that an
25 alien may have committed will make the alien removable from the United States. “Congress
26 established the LESC to provide alien status determination support to federal, state, and local
27 law enforcement on a 24-hour-a-day, seven-days-a-week basis. The enabling legislation is
28 codified in 8 U.S.C. §§ 1226(d)(1)(A) & 1252 Note.” (Palmatier Decl. ¶ 5.) The statute only
directs LESC to determine the immigration status of an arrested individual. 8 U.S.C. §
1226(d)(1)(A). For its part, Arizona did not provide any evidence that LESC would be able
to advise an officer whether a particular public offense makes an alien removable.

1 *Econ. Equal.*, 950 F.2d 1401, 1412 (9th Cir. 1991)). Indeed, if an individual or entity faces
2 the imminent threat of enforcement of a preempted state law and the resulting injury may not
3 be remedied by monetary damages, the individual or entity is likely to suffer irreparable harm.
4 *See Morales v. Trans World Airlines, Inc.*, 504 U.S. 374, 381 (1992) (stating that a federal
5 court may properly enjoin “state officers ‘who threaten and are about to commence
6 proceedings, either of a civil or criminal nature, to enforce against parties affected an
7 unconstitutional act, violating the Federal Constitution’” (quoting *Ex parte Young*, 209 U.S.
8 123, 156 (1908)); *New Orleans Pub. Serv., Inc. v. Council of New Orleans*, 491 U.S. 350,
9 366-67 (1989) (suggesting that irreparable injury is an inherent result of the enforcement of
10 a state law that is preempted on its face); *Edmondson*, 594 F.3d at 771 (concluding that
11 plaintiff is likely to suffer irreparable injury if enforcement of state law that is likely
12 preempted by IRCA and IIRIRA is not enjoined); *Villas at Parkside Partners v. City of*
13 *Farmers Branch*, 577 F. Supp. 2d 858, 878 (N.D. Tex. 2008) (concluding that there is a
14 likelihood of irreparable injury if enforcement of a city ordinance that is preempted by the
15 INA is not enjoined).

16 If enforcement of the portions of S.B. 1070 for which the Court finds a likelihood of
17 preemption is not enjoined, the United States is likely to suffer irreparable harm. This is so
18 because the federal government’s ability to enforce its policies and achieve its objectives will
19 be undermined by the state’s enforcement of statutes that interfere with federal law, even if
20 the Court were to conclude that the state statutes have substantially the same goals as federal
21 law. *See Crosby v. Nat’l Foreign Trade Council*, 530 U.S. 363, 379-80 & n.14 (2000). For
22 this injury, the United States will have no remedy at law. The Court thus finds a likelihood
23 of irreparable harm to the interests of the United States that warrants preliminary injunctive
24 relief. *See Am. Ins. Ass’n v. Garamendi*, 539 U.S. 396, 413, 427 (2003) (enjoining
25 permanently the enforcement of a state statute that is preempted by federal law because it
26 interferes with the federal government’s ability to enforce its policies); *Crosby*, 530 U.S. at
27 372, 379-80 (same).

1 **D. The Balance of Equities and the Public Interest**

2 The United States also has the burden to show that the balance of equities tips in its
3 favor and that a preliminary injunction is in the public interest. *Winter*, 129 S. Ct. at 374. “A
4 preliminary injunction is an extraordinary remedy never awarded as of right.” *Id.* at 376
5 (citing *Munaf v. Green*, 128 S. Ct. 2207, 2218-19 (2008)). “In each case, courts ‘must balance
6 the competing claims of injury and must consider the effect on each party of the granting or
7 withholding of the requested relief,’” paying particular attention to the public consequences.
8 *Id.* at 376-77 (quoting *Amoco Prod. Co. v. Vill. of Gambell, Alaska*, 480 U.S. 531, 542
9 (1987)).

10 The Ninth Circuit Court of Appeals has concluded that allowing a state to enforce a
11 state law in violation of the Supremacy Clause is neither equitable nor in the public interest.
12 *Cal. Pharmacists Ass’n v. Maxwell-Jolly*, 563 F.3d 847, 852-53 (9th Cir. 2009); *Am. Trucking*
13 *Ass’ns, Inc. v. City of L.A.*, 559 F.3d 1046, 1059-60 (9th Cir. 2009). If Arizona were to
14 enforce the portions of S.B. 1070 for which the Court has found a likelihood of preemption,
15 such enforcement would likely burden legal resident aliens and interfere with federal policy.
16 A preliminary injunction would allow the federal government to continue to pursue federal
17 priorities, which is inherently in the public interest, until a final judgment is reached in this
18 case. *See Am. Trucking*, 559 F.3d at 1059-60.

19 The Court by no means disregards Arizona’s interests in controlling illegal
20 immigration and addressing the concurrent problems with crime including the trafficking of
21 humans, drugs, guns, and money. Even though Arizona’s interests may be consistent with
22 those of the federal government, it is not in the public interest for Arizona to enforce
23 preempted laws. *See Edmondson*, 594 F.3d at 771. The Court therefore finds that preserving
24 the status quo through a preliminary injunction is less harmful than allowing state laws that
25 are likely preempted by federal law to be enforced. *See Cal. Pharmacists*, 563 F.3d at 852-53;
26 *Am. Trucking*, 559 F.3d at 1059-60.


27 **IT IS THEREFORE ORDERED** granting in part and denying in part the United
28 States’ Motion for Preliminary Injunction (Doc. 27).

1 **IT IS FURTHER ORDERED** denying the United States' Motion for Preliminary
2 Injunction as to the following Sections of Senate Bill 1070 (as amended by House Bill 2162):
3 Section 1, Section 2(A) and (C)-(L), Section 4, the portion of Section 5 creating A.R.S. § 13-
4 2929, the portion of Section 5 creating A.R.S. § 13-2928(A) and (B), and Sections 7-13.

5 **IT IS FURTHER ORDERED** preliminarily enjoining the State of Arizona and
6 Governor Brewer from enforcing the following Sections of Senate Bill 1070 (as amended by
7 House Bill 2162): Section 2(B) creating A.R.S. § 11-1051(B), Section 3 creating A.R.S. §
8 13-1509, the portion of Section 5 creating A.R.S. § 13-2928(C), and Section 6 creating A.R.S.
9 § 13-3883(A)(5).
