**STIPULATION FOR
EXTENSION OF TIME TO
FILE RESPONSE TO
DEFENDANT BREWER'S
MOTION FOR JUDGMENT ON
THE PLEADINGS**

1 On July 2, 2010, defendant Jan Brewer, in her official capacity as
2 Governor of the State of Arizona ("Brewer"), filed a motion for judgment
3 on the pleadings (doc. 68). The response from the City of Tucson
4 ("Tucson") is due August 10, 2010 (doc. 78). On August 5, 2010,
5 Tucson and Brewer filed a stipulation for the dismissal without prejudice
6 of Tucson's motion for a preliminary injunction (doc. 82). The Court
7 granted the withdrawal of Tucson's motion for preliminary injunction on
8 August 10, 2010 (doc. 83).

9 Brewer and Tucson are now attempting to resolve open issues
10 with respect to Brewer's motion for judgment on the pleadings.
11 Accordingly, the parties stipulate and request that Tucson's response to
12 Brewer's motion for judgment on the pleadings shall not be due until
13 September 10, 2010.
