**SECOND STIPULATION FOR

1 On August 5, 2010, defendant Jan Brewer, in her official capacity as
2 Governor of the State of Arizona ("Brewer"), and the City of Tucson
3 ("Tucson") filed a stipulation for extension of time to file response to
4 defendant Brewer's motion for judgment on the pleadings (doc. 85). The
5 Court extended the response deadline for Tucson's response to Brewer's
6 motion for judgment on the pleadings to September 10, 2010 (doc. 88).

7 Brewer and Tucson believe that a further extension will clarify the
8 issues to be presented to the Court. Accordingly, the parties stipulate and
9 request that Tucson's response to Brewer's motion for judgment on the
10 pleadings shall not be due until October 1, 2010.
