Additional Information:

SAYRES appeared in the Boone County Circuit Court on 4/15/05 and was sentenced to a term of 6 years in the ADC for the felony offenses of Forgery, Possession of a forgery device, and Possession of Firearm Certain Persons (x2). He was initially released from the ADC on 4/21/06. Since that time, he has been revoked to the ADC once and to TVP once. His latest release from the ADC occurred on 10/29/10 and he had the following special conditions: Total Abstinence, Employment Plan, Maximum Supervision, and Community Service Hours.

History:

On 8/26/2013, Officer Martin received a call from the Boone County SO and they stated that they were at the offenders home and he would not let them in. Sgt. Dees of the Boone County SO stated that they had a report from this offenders girlfriend that he slapped her and had guns in his house. Officer Martin arrived at the offenders home around 12am on 8/26/2013. The Officers stated that no one was in the offenders home like they thought. Officer Martin found several rounds of ammunition around the offenders home along with around 5 cases of beer. The offender was no where to be found. The sheriffs Office stated that they were going to charge the offender with felon in possession of a firearm. The offender also has a Failure to Appear Warrant on him along with a Hot Check Violation which is a pending felony which is a H-3 violation of the ARAIM and calls for Immediate arrest and Revocation Hearing.

Facts of Violation:

On 8/26/2013, the offender called Officer Martin and stated that he was hiding in the woods when the Sheriffs Office and Officer Martin arrived at his home. The offender stated that he did in fact have Fire Arms and did drink a lot of beer. Officer Martin told the offender that he was a felon and it is against the law for a felon to have a firearm and it was against the law for him to drink alcohol. The offender sounded like he was intoxicated and had slurred speech. Officer Martin asked the offender to turn himself in on 8/27/2013 at 10 am due to his phone call being place after hours. The offender was speaking in a joking manor and Officer Martin told him that this was no joke and that he needed to turn himself in. The offender stated that he would never harm anyone and that he was not a threat to anyone. The offender kept saying that we would all have to go through Judge Webb to send him back to prison and that he didn't think the Judge would let us send him back. Officer Martin assured the offender that the Judge would not agree to him being in violation of the law and his Parole. Offender stated that he would think about turning himself in. Officer Martin told the offender that if he did not arrive at his office at 10am on 8/27/2013, Officer Martin would have no choice but to conduct a violation report and request an Abscond warrant and the offender stated that he understood. The offender stated that if he did not turn himself in he would stay on the run. The offender then hung up. On 8/27/2013, the offender failed to report and did not call.

At this time the offender is purposely making himself unavailable for supervision and his whereabouts are unknown. This will be the offenders 3rd Abscond Violation which is an H-9 of the ARAIM and calls for a revocation hearing.

Subject's Statement:

Stated that he had firearms and has been drinking in excess.

Violations:

Condition#1-REPORTS: On 8/27/2013, Sayres failed to report and did not call.

Condition#4-LAWS- On 8/26/2013, Sayres admitted to officer Martin that he had firearms in his possession and committed the offences of Felon in Possession of a Firearm, Failure to Appear and Hot Check Violation which is a pending felony.

Condition#6-ALCOHOL/CONTROLLED SUBSTANCES: On 8/26/2013, Sayres admitted to Officer Martin that he had been drinking excess amounts of alcohol.

Condition#9-COOPERATION: On 8/26/2013, Sayres admitted that he hid in the woods while Law Enforcement was trying to make contact with him, therefore, purposely making himself unavailable and for causing Law Enforcement to search for him when they could have been helping the public in other areas.


