26 On December 12, 2007, judgment was entered by Plaintiff JOHN MICHAEL
 27 PAULSON, TRUSTEE OF THE ALLEN E. PAULSON LIVING TRUST (Paulson) against
 28 Defendant JEFFREY S. RAND (Rand) in the sum of \$870,000 (Original Judgment). On
 August 20, 2009, Rand filed a motion to vacate the Original Judgment claiming the amount was
 contrary to California law.

1 Paulson failed to oppose the motion. After review of the moving papers, and good
2 causes appearing therefore,

3 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that:

4 1. The Original Judgment against Rand is vacated. A copy of the Court's Order
5 Granting Motion to Vacate Judgment is attached as Exhibit 1; and,

6 2. A New Judgment is entered, *nunc pro tunc* to December 12, 2007, in favor of
7 Plaintiff JOHN MICHAEL PAULSON, TRUSTEE OF THE ALLEN E. PAULSON LIVING
8 TRUST and against Defendant JEFFREY S. RAND in the corrected amount of \$170,689.26
9 plus post-judgment interest and costs.
