
I, Melanie Poblete, declare as follows:

1. I am employed by Perfect 10, Inc. and the Law Offices of Jeffrey N. Mausner. This declaration is meant to supplement the declaration which I submitted earlier today, to include evidence that was not available to me at the time I wrote the prior declaration (Docket No. 550). Unless otherwise stated, I have direct and personal knowledge of the facts set forth herein and, if called as a witness, could and would competently testify thereto.

2. Attached as Exhibit B is a true and correct copy of a PDF file that was contained on Exhibit 1 to the Second Supplemental Kassabian Declaration.
