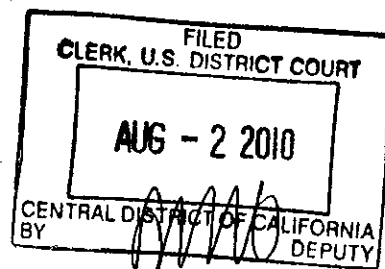


1 Pursuant to Local Rule 79-5.1, the Order of the Hon. A. Howard Matz re
