The judgment was entered against Defendants and Judgment Debtors TODAY’S GEAR, INC., a Minnesota corporation, and THOMAS SCHULTZ, an individual (collectively referred to as “JUDGMENT DEBTORS”), in the United States District Court, Central District of California, Western Division, Case No.

1 2:07-cv-00855-JFW-JTL, on August 6, 2007, in the amount of \$136,351.28, plus  
2 post-judgment interest at the rate of 4.99% per annum. [Docket No. 24].

3 Since the entry of the judgment on August 6, 2007, and as of September  
4 10, 2009, JUDGMENT DEBTORS have paid a partial payment of \$55,621.05.  
5 Thus, as of the date of the application, there is still an unsatisfied principal sum  
6 of judgment in the amount of \$80,730.23. WEBTRANS LOGISTICS,  
7 a California corporation (“WEBTRANS”), is also entitled to a post-judgment  
8 interest from September 10, 2009 to May 10, 2017 in the sum of \$30,912.00.

9 NOW, upon WEBTRANS’ Application for Renewal and Renewal of  
10 Judgment, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that  
11 the judgment against JUDGMENT DEBTORS is renewed in the amount of  
12 \$111,642.23, and that WEBTRANS recover as follows:

13	a. Principal.....	\$136,351.28
14	b. Credit Received.....	\$55,621.05
15	c. Outstanding Balance .....	\$80,730.23
16	d. Judgment Interest.....	\$30,912.00
17	(at the rate of 4.99% per annum from 9/10/2009 to 5/10/2017)	
18	e. Costs.....	\$0.00
19	f. Attorney’s Fees.....	\$0.00
20	GRAND TOTAL.....	\$111,642.23
