## TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:

The above-entitled action came on regularly for trial on August 28, 2012, at 8:30 a.m., in Courtroom " 740 " of the United States District Court, Central District of California, Western Division, with The Honorable Gary Allen Feess, presiding. Plaintiff CHARLES DIRKS was represented by and through his attorneys of record Saul Reiss, Esq., of the Law Offices of Saul Reiss, and Joe H. Freeman, Esq., of Joe
H. Freeman and Associates. Defendants Sergeant JOE GRASSO, Deputy RICKY BAKER, and Deputy DARREN INANA were represented by and through their counsel of record Thomas C. Hurrell, Esq. and Mariam Kaloustian, Esq., of Hurrell Cantrall LLC.

A jury of eight (8) persons was regularly impaneled and sworn on August 28, 2012. Witnesses were sworn and testified. After hearing evidence and arguments of counsel, the jury was duly instructed by the Court, and the cause was submitted to the jury with directions to return a verdict as to the claims against defendants Sergeant JOE GRASSO, Deputy RICKY BAKER, and Deputy DARREN INANA. The jury deliberated and thereafter returned to the Court on August 29, 2012, with an eight (8) to zero (0) verdict in favor of defendants Sergeant JOE GRASSO, Deputy RICKY BAKER, and Deputy DARREN INANA.

Specifically, the jury found in favor of defendants Sergeant JOE GRASSO, Deputy RICKY BAKER, and Deputy DARREN INANA on the special verdict with respect to the following questions submitted:

## FIRST AMENDMENT CLAIM

Did Plaintiff Charles Dirks prove by a preponderance of the evidence that, at the time of his arrest on April 27, 2006, he was engaged in the exercise of his rights under the First Amendment of the United States Constitution?

Did Plaintiff Charles Dirks prove by a preponderance of the evidence that, at the time that he was placed under arrest, the defendants violated his rights by arresting him without probable cause to believe that he had committed a violation of one or more sections of the California Penal Code.
