11 On September 2, 2008, this Court granted the Motion of defendants Chase
12 Home Finance LLC (“Chase”), JPMorgan Chase Bank, N.A., erroneously sued as JP
13 Morgan Chase Bank (“JPMorgan”), and U.S. Bank National Association, Trustee for
14 Lehman Brothers Structured Asset Securities Corporation SASCO 2006-BC2,
15 erroneously sued as U.S. Bank National Association, as Trustee for Lehman Brothers
16 Securities Corporation (“USBank,” collectively Defendants”) to Dismiss the First
17 Amended Complaint of plaintiffs Bruce Hadley and Stephanie Y. Hadley (collectively
18 “Plaintiffs” or “Hadleys”). The Court found that Plaintiffs cannot state any claim
19 against Defendants.

20 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Plaintiffs’
21 First Amended Complaint is dismissed with prejudice as to Chase, JPMorgan, and
22 USBank. The Court orders that Judgment is entered in favor of Chase, JPMorgan, and
23 USBank and against Plaintiffs, and each of them.
