of \$502,500.00, inclusive of all costs and attorney fees otherwise recoverable against them in this action. Attached hereto as Exhibits "1" and "2" are copies of the "Offer of Judgment [Rule 68]" and "Notice of Plaintiff's Acceptance of Offer of Judgment of Defendants Sonya Powell and Jason Powell [F.R.C.P. Rule 68]," respectfully, which are incorporated herein by this reference.

This partial judgment has no impact on Plaintiff's rights and claims, if any, against Defendants CITY OF LOS ANGELES and MONICA MCPARTLAND, nor does it affect the rights and defenses, if any, of Defendants CITY OF LOS ANGELES and MONICA MCPARTLAND, including the alleged right of the CITY OF LOS ANGELES and MONICA MCPARTLAND to claim that they are entitled to a "credit" for the amount of this judgment. - 2. As against each other, Plaintiff CLAUDIO RADOCCHIA and Defendants JASON POWELL and SONYA POWELL, shall bear their own costs and attorney's fees.
